### PROCLAMATION

By His Excellency the Right Honorable John Adrian Louis, Earl of Hopetoun, Viscount Aithrie, and Baron Hope, in the Peerage of Scotland; Baron Hopetoun of Hopetoun, and Baron Niddry of Niddry Castle, in the Peerage of the United Kingdom; Knight Grand Cross of the Most Distinguished Order of Saint Michael and Saint George; Governor and Commander-in-Chief in and over the Colony of Victoria and its Dependencies, &c., &c. |

N pursuance of the provisions contained in the Public Service Act 1890 (54 Vict. No. 1133, Part VI., section 135), I, the Governor of Victoria, with the advice of the Executive Council, do by this my Proclamation appoint the days and dates named hereunder to be observed as Public Holidays at the respective places specified, that is to say:—

FRIDAY, THE: 3RD DAY OF AUGUST NEXT,

as a Public Holiday throughout the Shire of Goulburn;

WEDNESDAY, THE 15TH DAY OF AUGUST NEXT,

as a Public Holiday throughout the Shire of Rutherglen;

THURSDAY, THE 6TH DAY OF SEPTEMBER NEXT,

as a Public Holiday throughout the Shire of Gordon;

THURSDAY, THE 13TH DAY OF SEPTEMBER NEXT,

as a Public Holiday throughout the Central Riding of the Shire of Benalla.
