#### PUBLIC AND BANK HOLIDAYS.

#### PROCLAMATION

By His Excellency the Right Honorable John Adrian Louis, Earl of Hopetoun, Viscount Aithrie, and Baron Hope, in the Peerage of Scotland; Baron Hopetoun of Hopetoun, and Baron Niddry of Niddry Cartle, in the Peerage of the United Kingdom; Knight Grand Cross of the Most Distinguished Order of Saint Michael and Saint George; Governor and Commander-in-Chief in and over the Colony of Victoria and its Dependencies, &c., &c., &c.

IN pursuance of the provisions contained in the Public Service Act 1899 (54 Vict. No. 1133, Part VI., section 135) and in the Banks and Currency Act 1899 (54 Vict. No. 1164, Part III., section 20), I, the Governor of Victoria, with the advice of the Executive Council, do by this my Proclamation appoint the days and dates hereunder mentioned to be observed as Public Holidays or Bank Holidays (as the case may be) at the places respectively specified, viz.:—

Tuesday, the 4th, and Wednesday, the 5th, days of September instant,

as Public Holidays throughout the Shire of Glenelg;

WEDNESDAY, THE 5TH DAY OF SEPTEMBER INSTANT,

as a Public Holiday throughout the Borough of Echuca;

FRIDAY, THE 7TH DAY OF SEPTEMBER INSTANT,

as a Bank Holiday at Coleraine;

TUESDAY, THE 11TH DAY OF SEPTEMBER INSTANT,

as a Public Half Holiday, from the hour of Twelve o'clock noon, throughout the Borough of Ararat, and as a Bank Holiday at Katamatite;

Wednesday, the 12th day of September Instant,

as a Bank Holiday at Swan Hill;

THURSDAY, THE 13TH, AND FRIDAY, THE 14TH, DAYS OF SEPTEMBER INSTANT.

as Public Holidays throughout the Borough of Hamilton;

THURSDAY, THE 13TH DAY OF SEPTEMBER INSTANT, as a Public Holiday throughout the Borough of Portland and the Shires of Broadmeadows, Minhamite, and Portland, and as a Bank Holiday at Penshurst;

FRIDAY, THE 14TH DAY OF SEPTEMBER INSTANT,

as a Public Holiday throughout the East and South Ridings of the Shire of Borung;
Wednesday, the 19th day of September instant,

WEDNESDAY, THE 19TH DAY OF SEPTEMBER INSTANT, as a Public Holiday throughout the Borough of Stawell and the Shire of Arapiles, and as a Bank Holiday at Birchip and Stawell;

FRIDAY, THE 21ST DAY OF SEPTEMBER INSTANT,

as a Bank Holiday at Echuca and Rupanyup;

WEDNESDAY, THE 26TH DAY OF SEPTEMBER INSTANT,

as a Public Holiday throughout the Township of Yarrawonga;

THURSDAY, THE 27TH DAY OF SEPTEMBER INSTANT,

as a Public Holiday throughout the Shire of Yarrawonga;

WEDNESDAY, THE 3RD DAY OF OCTOBER NEXT,

as a Public Holiday throughout the Borough of Inglewood and the Shire of Maldon, and as a Bank Holiday throughout the Borough of St. Arnaud and at Rochester;

THURSDAY, THE 4TH DAY OF OCTOBER NEXT,

as a Bank Holiday at Murchison;

FRIDAY, THE 5TH DAY OF OCTOBER NEXT,

as a Bank Holiday at Boort;

THURSDAY, THE 18TH DAY OF OCTOBER NEXT,

as a Bank Holiday at Tatura.
