PUBLIC AND BANK HOLIDAYS.

PROCLAMATION

By His Excellency the Right Honorable John Adrian Louis, Earl of Hopetoun, Viscount Aithrie, and Baron Hope, in the Peerage of Scotland; Baron Hopetoun of Hopetoun, and Baron Niddry of Niddry Castle, in the Peerage of the United Kingdom; Knight Grand Cross of the Most Distinguished Order of Saint Michael and Saint George; Governor and Commander-in-Chief in and over the Colony of Victoria and its Dependencies, &c., &c., &c.

IN pursuance of the provisions contained in the Public Service Act 1890 (54 Vict. No. 1133, Part VI., section 135) and in the Banks and Currency Act 1890 (54 Vict. No. 1164, Part III., section 20), I, the Governor of Victoria, with the advice of the Executive Council, do by this my Proclamation appoint the days and dates hereunder mentioned to be observed as Public Holidays or Bank Holidays (as the case may be) at the places respectively specified, viz.:—

WEDNESDAY, THE 21ST DAY OF MARCH INSTANT,

as a Public Holiday throughout the Shires of Alberton and Bellarine,* and as a Bank Holiday at Alberton, Port Albert, Portarlington, and Yarram Yarram; THURSDAY, THE 22ND DAY OF MARCH INSTANT,

as a Public Holiday throughout the Shires of Eltham, Heidelberg, and Templestowe; Wednesday, the 28th, and Thursday, the 29th, days of March instant,

as Public Holidays throughout the Shire of Talbot*;

THURSDAY, THE 29TH DAY OF MARCH INSTANT,

as a Public Holiday throughout the Shire of Tungamah*;

FRIDAY, THE 30TH DAY OF MARCH INSTANT,

as a Public Holiday throughout the Shire of Alberton, and as a Bank Holiday at Port Albert;

WEDNESDAY, THE 4TH DAY OF APRIL NEXT,

as a Public Holiday throughout the Shire of Maldon,* and throughout the Tatura Riding of the Shire of Rodney, and as a Bank Holiday at Mooroopna;

FRIDAY, THE 6TH DAY OF APRIL NEXT,

as a Public Holiday throughout the Shire of Pyalong, and as a Bank Holiday at Alexandra;

SATURDAY, THE 21ST DAY OF APRIL NEXT,

as a Public Holiday throughout Victoria.
