## PUBLIC AND BANK HOLIDAYS.

### PROCLAMATION

By His Excellency the Honorable Sir John Madden, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George, Lieutenant-Governor of the State of Vic-toria and its Dependencies, in the Commonwealth of Aus-

IN pursuance of the provisions contained in Part VI. of the Public Service Act 1890 (54 Vict. No. 1133), in Part III. of the Banks and Currency Act 1890 (54 Vict. No. 1164), and in the Public and Bank Holidays Act 1897 (61 Vict. No. 1534), I, the Lieutenant-Governor of the State of Victoria, in the Commonwealth of Australia, with the advice of the Executive Council of the said State, do by this my Proclamation appoint the days and dates hereunder mentioned to be observed as Public Holidays or Bank Holidays (as the case may be) at the places respectively mentioned, viz.:—

WEDNESDAY, THE 6TH DAY OF MARCH NEXT, as a Public Holiday throughout the Shires of Flinders and Kangerong, Frankston and Hastings and Mornington; as a Public Half-Holiday, from the hour of Twelve o'clock noon, throughout the Shire of Yarrawonga'; and as a Bank Half-Holiday, from the hour of Twelve o'clock noon, at Beulah, Boort, and Yarrawonga;

THURSDAY, THE 7TH DAY OF MARCH NEXT, as a Bank Holiday at Penahurst, and as a Bank Half-Holiday, from the hour of Twelve o'clock noon, at Nhill and Tallangatta;

Tuesday, the 12th day of March next, as a Public Holiday throughout the Shire of Lillydale;

Wednesday, the 13th Day of March Next, as a Public Holiday throughout the Town of Port Melbourne, the Shires of Castle Donnington\* and Rodney, and the Tatong and Warrenbayne Ridings of the Shire of Benalla; and as a Bank Half-Holiday, from the hour of Twelve o'clock noon, at Mooroopna, Nagambie, and Shepparton;

WEDNESDAY, THE 13TH, AND WEDNESDAY, THE 20TH DAYS OF MAROR MEXT, as Public Holidays throughout the Shire of Strathfieldsaye;

THURSDAY, THE 14TH DAY OF MARCH NEXT, as a Public Holiday throughout the Greensberough Riding of the Shire of Heidelberg

#### THE SPRINGVALE GENERAL CEMETERY.

The SPRINGVALE GENERAL CEMETERY,
of that piece or portion of land containing three hundred acres
two roods thirty-eight perches, being allotment 7, parish of Dandenong, county of Bourke: Commencing at the north-east angle
of allotment 8; bounded thence by Gladstone-road bearing east
twenty chains; thence by allotment 9 bearing south eighty
chains; thence by allotment 14 bearing west eighteen chains
sixty links to the Dandenong-road; thence by Dandenong-road
bearing north-westerly twenty-seven chains eighty-four links to
the south-east angle of allotment 8; thence by allotment 8 bearing north sixty-two chains to the point of commencement.
