UNUSED ROADS IN THE PARISHES OF DOOEN, VECTIS EAST, MYRRHEE, AND WHITFIELD.— CLOSED.

#### PROCLAMATION .

By His Excellency the Honorable Sir John Madden, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George, Lieutenant Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia.

HEREAS by the Land Act 1900 [64 Vict. No. 1720, sec. 27) it is enacted that where unused or unformed and unused roads intersect any land acquired by the Crown, pursuant to the provisions of Part III. of the Land Act 1898, and are not suitable to the subdivision of such land, such roads may, with the consent of the municipal council governing the municipality in which such roads are situate be closed by proclamation in the Government Gazette, and thereafter may be dealt with as part of the land so acquired which they intersect; and whereas the consent of the municipal councils governing the municipalities in which such roads are situate has been obtained: Now therefore I, the Lieutenant-Governor of the State of Victoria in the Commonwealth of Australia, with the advice of the Executive Council of the said State, do by this notice proclaim that the unused roads in the parishes of Doven, Vectis East, Myrrhee, and Whitfield, as defined in the following descriptions, be closed, that is to say:

# Parishes of Dooen and Vectis East.

County of Borung, parish of Dooen: Commencing at the south-west angle of allotment 17; bounded thence by that allotment bearing S. 58° 17′ E. thirty-nine chains; thence by allotment lebearing S. 17° 41′ W. one chain three links; thence by allotment 16 bearing N. 58° 17′ W. thirty-nine chains twenty-five links; and thence by the road from Horsham bearing N. 31° 43′ E. one chain to the point of commencement.
