**VICTORIAN RAILWAYS COMMISSIONERS.—ORDER
RE QUORUM REVOKED.**

*At the Executive Council Chamber, Melbourne, the second day of
June, 1903.*

WHEREAS it is provided by sub-section (1) of section 6 of the *Victorian Railways Commissioners Act 1903* (3 Edw. VII. No. 1825) that any one Commissioner shall form a quorum if so ordered by the Governor in Council, who may at any time revoke any such Order: Now therefore His Excellency the Governor of the State of Victoria in Council doth hereby order that the last clause of the Order in Council of the 6th day of April, 1903, providing that "until the 30th day of June, 1903, any one Commissioner shall form a quorum" be revoked, as and from the 2nd day of June, 1903.

And the Honorable Thomas Bent, His Majesty's Minister of Railways for the State of Victoria, shall give the necessary directions herein accordingly.
