WHEREAS The Parliament of Victoria stands prorogued until Tuesday, the fourth day of February, 1908: Now I, the Governor of the State of Victoria in the Commonwealth of Australia, do by this my Proclamation further prorogue the said Parliament of Victoria until Wednesday, the eighteenth day of March, 1908.

Given under my Hand and the Seal of the State of Victoria aforesaid, at Melbourne, this twenty-ninth day of January, in the year of our Lord One thousand nine hundred and eight, and in the eighth year of His Majesty's reign.
