## NYORA TO WOOLAMAI RAILWAY.

PETITION AGAINST THE CONSTITUTION OF RAILWAY CONSTRUCTION DISTRICT, ETC.

THE Honorable Alfred Arthur Billson, the responsible Minister of the Crown for the time being administering the Railway Lands Acquisition Acts, purporting to act under the authority of sub-section (1) of section 10 of the *Railway Lands Acquisition Act 1893*, has directed that there be published in the *Government Gazette* the following, being (omitting signatures) the whole text of a certain petition or petitions to the Governor in Council claimed to be within the meaning of the said sub-section, a petition duly presented praying that the Nyora to Woolamai Railway Construction District be not constituted, and that the authorized line Nyora to Woolamai be not constructed, and with respect to which it is further claimed that the same purports to be signed by at least one-third of the number of the owners of rateable property within the proposed Railway Construction District.

The text of the petition or petitions (with the omissions aforesaid) read as follows:—

*Petition to the Governor in Council.*

"We, the undersigned owners of rateable property in the Nyora to Woolamai Railway Construction District, hereby petition the Governor in Council, praying that such Railway Construction District be not constituted, and that such authorized line be not constructed under any conditions involving the loading of our land."
