Factories and Shops Acts.

## DETERMINATION OF THE BREAD CARTERS BOARD.

N accordance with the provisions of the Factories and Shops Acts, the special Board appointed to determine the lowest prices or rates which may be paid to any person or persons or classes of persons wheresoever employed in carting or driving or assisting in carting or driving in the business of a baker or seller of bread, has made the following determination, namely:—

#### ADULTS.

1. That the lowest rate of wages to be paid to any adult person or persons or classes of persons wheresoever employed in carting or driving in carting or driving in the business of a baker or seller of bread shall be:—

40s. per week of 60 hours.

#### IMPROVERS.

2. That the lowest rate of wages to be paid to any person or persons or classes of persons under the age of 21 years wheresoever employed in carting or driving or assisting in carting or driving in the business of a baker or seller of bread shall be:—

Under 18 years of age, 22s. 6d. per week of 60 hours, without board and lodging, and 15s. per week of 60 hours, with board and lodging.

Over 18 years, and under 21 years of age, 30s. per week of 60 hours, without board and lodging, and 22s. 6d. per week of 60 hours, with board and lodging.

#### PROPORTION OF IMPROVERS.

- 3. That the number of Improvers wheresoever employed in carting or driving or assisting in carting or driving in the business of a baker or seller of bread shall be :—
  - 1 improver to 3 adults or fraction thereof.
  - 2 improvers to 4 to 6 adults, and 1 additional improver to every additional 5 adults.

#### HOLIDAYS.

\*4. That the lowest rate of wages to be paid to any person or persons or classes of persons wheresoever employed in carting or driving or assisting in carting or driving in the business of a baker or seller of bread on Christmas Day, Boxing Day, New Year's Day, Good Friday, Easter Monday, and Eight Hours Day, shall be double the minimum rate fixed by this Determination.

### OVERTIME.

5. That the lowest rate of overtime wages to be paid to any person or persons or classes of persons wheresoever employed in carting or driving or assisting in carting or driving in the business of a baker or seller of bread, over and above the maximum number of hours per week fixed by this Determination, shall be:—

1s. per hour.

6. That the above Determination shall come into force on and from the 14th day of June, One thousand nine hundred and nine.

\* The rate of wages to be paid for work performed on the Holidays above specified shall be for the actual number of hours worked on those days.
