Factories and Shops Acts.

DETERMINATION OF THE MINING ENGINE-DRIVERS BOARD.

IN accordance with the provisions of the Factories and Shops Acts, the Special Board appointed to determine the lowest prices or rates which may be paid to any person or persons or classes of persons wheresoever employed in the occupation of a fireman, boiler attendant, or engine-driver in connexion with a steam engine or steam boiler in or about mines of every kind, has made the following Determination, namely:—

1. That this Determination shall come into operation on the 4th September, 1911.

WAGES.

2. That the lowest rates of wages to be paid to the following shall be—

Engine-drivers in charge of winding engines ... 1s. 3d. per hour or 60s. per week of 48 hours

All other engine-drivers 1s. 0½d. ,, 50s. ,, ,,

Firemen or boiler attendants ... 11½d. ,, 45s. ,, ,,

APPRENTICES.

Number.

3. That the number of apprentices who may be employed within any place shall be—
One apprentice to every worker engaged and receiving not less than 45s. per week.

IMPROVERS.

Number.

4. That the number of improvers who may be employed within any place shall be— One improver to every worker engaged and receiving not less than 45s. per week.

APPRENTICES OR IMPROVERS.

WAGES.

5. That the lowest prices or rates of payment payable to apprentices or improvers shall be—

For the 1st year's experience 20s. per week of 48 hours.

" 2nd " 30s. " "

" 3rd " 40s. " "

And thereafter the minimum wage.

OVERTIME.

6. That any employé who works for any time in excess of 48 hours in any one week shall be paid for such extra time at the rate of time and a quarter.

SPECIAL RATES FOR SUNDAYS AND PUBLIC HOLIDAYS.

- 7. That the special price or rate of payment payable to any employé for all work done on-
 - (a) Sundays, shall be at the rate of time and a quarter;
 - (b) On the undermentioned public holidays (that is to say):— New Year's Day, Easter Monday, *Christmas Day, *Boxing Day, shall be at the rate of time and a half.

 * Or such other day as may be observed as a Public Holiday in lieu thereof.

Factories and Shops Acts.

DETERMINATION OF THE BREAD CARTERS BOARD.

N accordance with the provisions of the Factories and Shops Acts, the Special Board appointed to determine the lowest prices or rates which may be paid to any person or persons or classes of persons employed in the process, trade, business, or occupation of carting or driving or assisting in carting or driving in the business of a baker or seller of bread, has made the following Determination, namely:—

1. That previous Determinations of this Board are hereby amended, and such amendments shall come into force and be operative on and after the 4th of September, 1911.

The Determination and amendments are printed hereunder:

2. That the lowest rates of wages paid to the following persons shall be :-

ADULT WORKERS.

£2 5s. per week of 60 hours.

APPRENTICES.

MALES.

Number.

3. That the number of male apprentices who may be employed in carting or driving or assisting in carting or driving shall be one apprentice to every three male persons or fraction of three male persons employed and receiving not less than £2 5s. per week of 60 hours.

Wages.

That the lowest prices or rates of payment payable to apprentices shall be :-

For the 1st year's experience, 30s. per week of 60 hours.

and thereafter the minimum wage.

IMPROVERS.

MALES.

Number.

4: That the number of male improvers who may be employed in carting or driving or; assisting in carting or driving shall be:—

One improver to three persons or fraction thereof.

Two improvers to four to six persons, and

One additional improver to every additional five-persons employed and receiving not less than £2 5s. per week of 60 hours.

That the lowest prices or rates of payment payable to improvers shall be :-

Under the age of 18 years, 22s. 6d. per week of 60 hours without board and lodging, and 15s. per week of 60 hours with board and lodging.

Over the age of 18 years and under the age of 21 years, 30s. per week of 60 hours without board and lodging, and 22s. 6d. per week of 60 hours with board and lodging, and thereafter the minimum wage.

SPECIAL RATES FOR PUBLIC HOLIDAYS!

5. That the special price or rate of payment payable to any persons for all work done on the undermentioned public holidays (that is to say) :---

Christmas Day,
Boxing Day,
New Year's Day,
Good Friday,
Easter Monday, and
Eight Hours Day,

shall be at the rate of 1s. 4d. per hour.
