Factories and Shops Acts.

DETERMINATION OF THE PRINTERS BOARD.

IN accordance with the provisions of the Factories and Shops Acts, the Special Board appointed to determine the lowest prices or rates which may be paid to any person or persons or classes of persons employed in the process, trade, or business of printing, including bookbinding, stereotyping, preparing printed matter for sale or distribution (including preparing wrappers or labels, folding, insetting, stapling, counting, wrapping, tying, labelling, carrying, or despatching), has made the following Determination, namely:—

(1) That previous Determinations of this Board are hereby amended, and such amendments shall come into force and be operative on and after the 1st day of November, 1913. The Determination and amendments are printed hereunder.

PRINTING.

Males.

One apprentice to every three or fraction of three $\$ male workers receiving not less than 42s, per week.

Females.

One apprentice to every two or fraction of two female workers receiving not less than 22s, per week.

One apprentice to every three or fraction of three workers receiving not less than 66s, per week.

BOOKBINDING.

Males

One apprentice to every three or fraction of three male workers receiving not less than 64s. per week.

IMPROVERS.

Proportions

(13) That the number or proportionate number of improvers who may be employed within any factory or work-room, or shop, or place, shall be in the following proportions to the workers continuously engaged for at least three months in the particular process, trade, or business hereinafter montioned:—

Males.

One improver to every fifteen journeymen receiving not less than 62s. per week.

Females.

One improver to every twenty female workers so employed receiving not less than 22s, per week.

STEREOTYPING.

One improver to every ten journeymen receiving not less than 66s, per week.

BOOKBINDING.

Males.

One improver to every twenty journeymen receiving not less than 64s. per week.

Females.

Two improvers to every female worker receiving not less than 21s. per week.

TIME OF BEGINNING AND ENDING WORK.

(15) That an ordinary day's work in jobbing or other offices (except Daily Newspaper Offices) for any person (other than those composing on linetype or monoline machines, or monotype keyboards, or attending to monotype casting machines) shall be done within the undermentioned hours of beginning and ending work:—

Time of Beginning, not earlier than

8 a.m. ... 12.30 p.m. on Saturdays, or the day on which the half-holiday is locally observed, and

8 a.m. ... 6 p.m. on the other working days of the week.



OVERTIME.

- (16) That the following rates shall be paid for work done during the times specified here-under, viz.:-
 - (a) Composing on Linotype, Monoline, or Typograph Machines, or Monolype Keyboards, or attending to Monolype Casting Machines in Jobbing Offices.

(b) For all other Work in Jobbing or other Offices except Daily Newspaper Offices.

For work done between 6 p.m. and 10 p.m. on any of the ordinary working days of the week

For work done within the times of beginning and ending work as specified in Clause (15) in excess of the maximum number of hours fixed for a week's work

Time and one-third.

For work done later than 12.30 p.m., or earlier than 8 a.m. on Saturday, or the day on which the half-holiday is observed locally

For work done later than 10 p.m., or earlier than 8 a.m. on any other working day

Time and a half.

(c) In Daily Newspaper Offices.

For work done by any person, except those engaged in the Composing Department and provided for in Clause (6), in excess of the maximum number of hours fixed for a week's work

Time and one-third.

SPECIAL RATES.

- (17) That double time shall be the special rate of payment payable to any person (except those employed in Daily Newspaper Offices) for all work done on-
 - (a) Sundays ;
 - (b) on the undermentioned public holidays (that is to say):-

Good Friday, 21st day of April, Christmas Day,

but if any other day be by Act of Parliament or Proclamation substituted for any of the above named holidays, the special rate shall only be payable for work done on the day so substituted.

HAND COMPOSITION SCALE.

- 1. All casual hands when called on shall be paid 11s. for eight hours or any fraction of eight hours, or 9s. 4d. for 8,000 or any fraction of 8,000 ens.
- 2. All kinds of composition entirely in a foreign language shall be done on time, unless compositors are employed of the same nationality as the language in which the work is composed.
- 3. All kinds of music composition, Greek, Hebrew, or dead languages, shall be done only on
- 4. Alterations from copy to be done by the "house," or charged for every line passing through the stick, and all marks in revises not appearing in the first proof to be corrected by the "house."
- 5.
