## PROCLAMATION

By His Excellency the Honorable Sir Arthur Lyulph Stanley, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George; Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.; Vice-Admiral of the State of Victoria.

**W**HEREAS in pursuance of the *Prize Courts Act* 1894 and of certain Commissions and Warrants issued thereunder I did on the nineteenth day of August One thousand nine hundred and fourteen proclaim that war had broken out between His Majesty and the German Emperor :

**AND WHEREAS** a state of war now exists between His Majesty the King and the Emperor of Austria, King of Hungary :

**NOW THEREFORE I, SIR ARTHUR LYULPH STANLEY**, the Vice-Admiral aforesaid, being satisfied thereof by information received by me do hereby proclaim that war has broken out between His Majesty the King and the Emperor of Austria, King of Hungary.

Given under my Hand and Seal of the State of Victoria, at Government House, Melbourne, this twenty-first day of August, in the year of our Lord One thousand nine hundred and fourteen, and in the fifth year of the reign of His Majesty King George V.

## PROCLAMATION

By His Excellency the Honorable Sir Arthur Lyulph Stanley, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George; Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

**W**HEREAS by the *Prize Courts Act* 1894 it is enacted that His Majesty the King in Council may make rules of court for regulating, subject to the provisions of the *Naval Prize Act* 1864, and that Act, the procedure and practice of prize courts within the meaning of the *Naval Prize Act* 1864, and the duties and conduct of the officers thereof, and of the practitioners therein, and for regulating the fees to be taken by the officers of the courts, and the costs, charges, and expenses to be allowed to the practitioners therein :

**AND WHEREAS** in pursuance of the said first-mentioned Act His Majesty the King in Council, by an order dated the fifth day of August, One thousand nine hundred and fourteen, made certain rules of court, a copy of which rules hereinafter referred to as the said Rules is published in the *Commonwealth of Australia Gazette*, No. 60, dated Monday, 17th August, 1914, pages one thousand five hundred and thirty-nine to one thousand five hundred and seventy-five:

AND WHEREAS it is by Order XLVI. of the said Rules provided that the said Rules, so far as they apply in a British Possession outside the United Kingdom, shall not come into operation until they are proclaimed in the Possession by the Governor thereof:

NOW THEREFORE I, SIR ARTHUR LYULPH STANLEY, the Governor aforesaid, acting with the advice of the Executive Council, do hereby proclaim that the said Rules, so far as they apply to the Supreme Court of Victoria in its Admiralty Jurisdiction, shall come into operation forthwith.

Given under my Hand and the Seal of the State of Victoria, at Melbourne, this twenty-first day of August, in the year of our Lord One thousand nine hundred and fourteen, and in the fifth year of the reign of His Majesty King George V.
