PRICE OF SUGAR AND AUSTRALIAN JAMS UNDER THE PRICE OF GOODS ACT 1914 (No. 2516).

WHEREAS by an Order in Council made under the Price of Goods Act on the 25th day of September last past Ten pounds ten shillings per ton of Two thousand pounds was declared to be the highest selling price for Flour for the purposes of the said Act And whereas the Prices Board appointed under the said Act has under date of the 27th of September reported that the price so named should be taken as fixed on basis delivery Melbourne the customary scale of differences in the trade for different country centres applying as usual retailers being entitled to charge retail prices based on the wholesale price so fixed And whereas the said Prices Board has now inquired into and in its report of the 27th of September aforesaid reported to the Governor in Council that the highest wholesale and retail selling prices for sugar and Australian jams should until further report by the Board be the prices ruling for those commodities in the wholesale and retail trades respectively as on the 1st of August 1914 And whereas the said report of the Prices Board of the 27th day of September having been taken into consideration and approved Now therefore I Sir Arthur Lyulph Stanley K.C.M.G. Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia by and with the advice of the Executive Council of the said State do now by this present Order ordain as follows:—

Firstly.—I declare that the price of Ten pounds ten shillings per ton of Two thousand pounds de-clared to be the highest selling price for Flour for the purposes of the Price of Goods Act 1914 by the Order in Council made on the 25th day of September last past and appearing in the Government Gazette of the State of Victoria of

the same date shall be taken as fixed on basis the same date shall be taken as fixed on basis delivery Melbourne, the customary scale of differences in the trade for different country centres applying as usual, retailers being entitled to charge retail prices based on the wholesale price fixed.

Secondly.—I declare and order that the wholesale and retail price or prices specified in the report of the Prices Board of the 29th day of September last past for Sugar and Australian Jams shall for the purpose of the Price of Goods Act 1914 be the wholesale and retail highest selling price or prices of those goods (that is to say):—

Australian Jams—Highest Selling Price—The prices ruling in the wholesale and retail trades respectively on 1st August 1914.

Sugar—Highest Selling Price—The prices ruling in the wholesale and retail trades respectively on 1st August 1914.
