## PROCLAMATION

By His Excellency the Honorable Sir Arthur Lyulph Stanley, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George; Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

**W**HEREAS The Parliament of Victoria stands prorogued until Tuesday, the eighth day of February, 1916: Now, I, the Governor of the State of Victoria in the Commonwealth of Australia, do by this my Proclamation further prorogue the said Parliament of Victoria until Tuesday, the seventh day of March, 1916.

Given under my Hand and the Seal of the State of Victoria aforesaid, at Melbourne, this fourth day of February, in the year of our Lord One thousand nine hundred and sixteen, and in the sixth year of the reign of His Majesty King George V.
