Factories and Shops Act 1915.

## DETERMINATION OF THE COAL AND COKE BOARD.

IN accordance with the provisions of the Factories and Shops Act 1915, the Special Board appointed to determine the lowest prices or rates which may be paid to any person or persons or classes of persons employed in any business or occupation connected with the sale or distribution of coal or coke by any—

- . (a) coal importer,
- (b) coal mine owner,
- (c) gas company,

has made the following Determination, namely :-

- 1. That previous Determinations of this Board are hereby amended and such amendments shall come into force and be operative on and after the 24th day of April, 1916.
  - 2. That the lowest rates of wages to be paid to the following persons shall be-

## APPRENTICES AND IMPROVERS. .

- "Apprentice" means any person under 21 years of age bound by indentures of apprenticeship or any person over 21 years of age who, with the sanction of the Minister, is bound by indentures of apprenticeship (Act 2650, Section 3).
- "Improver" means any person (other than an apprentice) who does not receive a piece-work price or a wages rate fixed by any Special Board for persons other than apprentices or improvers, and who is not over 21 years of age, or who, being over 21 years of age, holds a licence from the Minister to be paid as an improver (Act 2650, Section 3).

#### 3. That-

(a) the lowest rates which may be paid to apprentices or improvers; and
(b) the proportionate number of apprentices or improvers who may be employed by any employer
