By. His Excellency the Honorable Sir Arthur Lyulph Stanley, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George; Governor of the State of Victoria and its Dependencies in the Commonwealth of Aus-tralia, &c., &c., &c.

THE Governor of the State of Victoria in the Common-y, wealth of Australia, by and with the advice of the Executive Council of the said State, do by this my Proclama-tion revoke the Proclamation made on the twelfth day of November, 1918, and published in the Gazette of the 13th November, 1918, in so far as it relates to the appointment of Thursday, 2nd January, 1919, as a Public Holiday throughout the State of Victoria.
