Factories and Shops Acts.

DETERMINATION OF THE AERATED WATER TRADE BOARD.

Note.—This Determination on the 10th September, 1920, applied to the following parts of Victoria, namely:—The Metropolitan District as defined in the Factories and Shops Acts; the cities of Ballarat, Bendigo, Geolong, and Warrnambool; the towns of Ballarat East and Sandringham; and the boroughs of Eaglehawk, Geolong West, Newtown and Chilwell, and Sebastopol.

IN accordance with the provisions of the Factories and Shops Acts, the Wages Board appointed to determine the lowest prices or rates which may be paid to any person or persons or classes of persons employed in the process, trade, or business of an aerated water or cordial or non-intoxicating beer manufacturer, has made the following determination, viz.:—

(1) That on the 10th September, 1920, the last and all previous determinations of this Board shall be revoked and replaced by this Determination.

(3) TIME OF BEGINNING AND ENDING WORK. Time of Beginning.

Time of Ending.

7.30 a.m. 7.30 a.m. ... 12 noon on Saturday.
... 6 p.m. on the other working days of the week. ...

(4) OVERTIME. - The following rate shall be paid for all work done : -

(a) Outside the hours fixed in Clause (3)
(b) Within the hours fixed in Clause (3) in excess of 48 hours in any week

Time and a half.

(5) CASUAL LABOUR. - Casual employees, (i.e., persons employed during any week for not more than one-half the maximum number of hours fixed for a week's work) shall be paid-Adults, 2s. per day extra; all others, 1s. per day extra.

(6) Special Rates.—Double time shall be the special rate for all work done on Sunday, 26th January (Foundation Day), Good Friday, Easter Monday, 21st April (Eight Hours Day), King's Birthday, Christmas Day, Boxing Day, and New Year's Day; but, if any other day be by Act of Parliament or Proclamation substituted for any of the above-named holidays, the special rate shall only be payable for work done on the day so substituted.
