Factories and Shops Acts.

DETERMINATION OF THE MANUFACTURING CHEMISTS BOARD.

Note.—This Determination on the 29th July, 1921, applied to the following parts of Victoria, viz.:—The Metropolitan District as defined in the Factories and Shops Acts; the cities of Ballarat, Bendigo, Geelong, and Warmambool; the towns of Ballarat East and Sandringham; and the boroughs of Eaglehawk, Geelong West, Newtown and Chilwell, and Sebastopol.

N accordance with the provisions of the Factories and Shops Acts, the Wages Board appointed to determine the lowest prices or rates which may be paid to any persons employed in the trade of—

(a) a wholesale or a manufacturing chemist;

(b) manufacturing tellet preparations, perfumery, essences, essential oils, food preservatives, branding fluids, decidorants, disinfectants, fungicides, insecticides, vermin destroyers, weed destroyers,

has made the following Determination, namely :--

(1) That on the 29th July, 1921, the last previous Determination of this Board shall be revoked and replaced by this Determination. (2)
