In accordance with the provisions of the *Masseurs Registration Act 1923*, No. 3254, the following Supplementary Lists showing all additions and alterations made in the Register during 1924, are hereby published:—

Section 7 (a) indicates that the person at the commencement of this Act held the Diploma of or a Certificate of Competency issued by either of the Associations known respectively as the Victorian Massage Association and the Victorian Branch of the Australian Massage Association.

Section 7 (b) indicates that the person had been at the commencement of this Act for at least three years engaged in the bona fide practice of massage in Victoria or any other part of the Commonwealth of Australia or in the Dominion of New Zealand or in any two or more of such places.

Section 17 (d) indicates that the person at the commencement of this Act was being trained therein.
