Factories and Shops Acts.

DETERMINATION OF THE BISCUIT BOARD.

Norm.—This Determination on the 27th February, 1925, applied to the following parts of Victoria, namely:—The Metropolitan District, as defined in the Factories and Shops Acts; the cities of Ballarat. Bendigo, Geelong, Sandringham, and Warrnambool: the towns of Geelong West and Newtown and Chilwell; and the boroughs of Eaglehawk and Sebastopol.

IN accordance with the provisions of the Factories and Shops Acts, the Special Board appointed to determine the lowest prices or rates which may be paid to any person employed in making biscuits has made the following Determination, namely:—

Norz.—On the 21st June, 1913, the powers of the Biscuit Board were extended to enable it to "determine the lowest prices or rates which may be paid to any person employed as storeman, packer, or sorter in connexion with the trade or business of making biscuits."

(1) That on the 27th February, 1925, the last previous Determination of this Board shall be revoked and replaced by this Determination.

(3) Definition of Juvenile Workers.

Persons under 21 years of age (other than apprentices or improvers) employed at—

Baking, cutting, spreading, and filling of all wafers and biscuits;
Blanching nuts;
Bringing fuel to ovens;
Carrying goods, materials, or utensils;
Gleaning bake-house or premises;
Gleaning, greasing, scraping or burning off baking trays
Counting, cracking, and proserving og
Dusting and wheeling trays;
Feeding and emptying elevators;
Feeding and emptying ovens, feeding cutting and other machines with trays;
Grinding dates and other fruit;
Grinding acids and other ingredients (other than ammonia);
Labelling;

Labelling, weighing, and marking of all wasers;
Packing, sorting, or papering tins;
Packing boxes, cartons, or casks;
Picking and sorting nuts or biscuits;
Proparing butters for wasers or icing;
Putting fruit or peel on biscuits;
Setting fiscuits on trays;
Scraping, weighing, and marking tins;
Sifting dour, sugar, or other ingredients;
Stamping, icing, or dotting biscuits;
Stamping, icing, or dotting biscuits;
Stirring icing sugar and filling for wasers and biscuits in small basins;
Stirring gum or paste;
Wrapping for export; or
Washing, cleaning, papering tins, boxes, or casks.

(4) OVERTIME.—Any time worked in excess of 48 hours in any week shall be paid for at the rate of time and a half.

(5) SPECIAL RATES.—Double time shall be the rate for all work done on Sunday, New Year's Day, Foundation Day (26th January), Good Friday, Easter Monday, Eight Hours Day (21st April), King's Birthday, Christmas Day, and Boxing Day; but if any other day be Act of Parliament or Proclamation substituted for any of the above-named holidays, the special rate shall only be payable for work done on the day so substituted.

(6) PIECE-WORK.—The Board determines, under the provisions of Section 144 of the Factories and Shops Acts, that any employer may fix and pay piece-work prices to any person or persons or classes of persons employed at any work for which the Board has fixed the minimum wage, provided that any such employer shall base such piece-work prices on the earnings of an average worker working under like conditions, and such piece-work prices shall be fixed so that an average worker can carn not less than the wages that are fixed by the Board for such work.
