Factories and Shops Acts.

DETERMINATION OF THE BREAD CARTERS BOARD.

Note.—(a) On the 14th December, 1928, the powers of the Bread Carters Board were extended to enable it to fix rates for persons employed in or in connexion with any stable in which are stabled the horses used in his trade or business by any person subject to the Determination of the aforesaid Board.

(5) Special Rates.—That double time shall be the rate payable for all work done on Sunday, New Year's Day, 26th January (Foundation Day), Good Friday, Easter Monday, 21st April (Eight Hours Day), King's Birthday, Show Day (in localitie-mentioned in the Royal Agricultural Show Act), Christmas Day, or Boxing Day; but if any other day be by Act of Parliament or Proclamation substituted for any of the above-named holidays, the special rate shall be payable only for work done on the day so substituted.
