ACTS OF PARLIAMENT.

PROCLAMATION

By His Excellency the Lieutenant-Governor, as Deputy for His Excellency the Governor, of the State of Victoria and, its Dependencies in the Commonwealth of Australia, &c.,

THE Lieutenant-Governor, as Deputy for the Governor, of the State of Victoria, in the Commonwealth of Australia, do hereby declare that I have this day assented, in His Majesty's name, to the Bills passed by the Parliament of the said State, the titles whereof are hereinafter set forth, that is

"An Act to authorize the use of certain land in the Township of Dandenong for Market and Recreation purposes."

"An Act relating to Standing Places for Certain Classes of Motor Cars

PROCLAMATION

By His Excellency Lieutenant-Colonel the Right Honorable Lord Somers, K.C.M.G., D.S.O., M.C., Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

W HEREAS by Letters Patent passed under the Great Seal of the United Kingdom constituting the Offlice of Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia bearing date at Westminster the twenty-ninth day of October, One thousand nine hundred as amended by Letters Patent passed under the Great Seal of the United Kingdom making further provision for the administration of the Government of the said State in certain events bearing date at Westminster the thirtieth day of April, One thousand nine hundred and thirteen, provision is amongst other things made for the appointment of a Deputy in the event of the temporary absence of the Governor from the Seat

of Government or from the State (except for the purpose of administering the Government of the Commonwealth of Australia): And whereas by Royal Instructions dated the twenty-ninth day of October, One thousand nine hundred, as amended by Additional Instructions dated the thirtieth day of April, One thousand nine hundred and thirteen, provision is also, amongst other things, made for the Governor to appoint a Deputy in certain events: And whereas I the Governor aforesaid having proposed to be temporarily absent from the Seat of Government, did pursuant to the said authorities, by an Instrument given under my hand and Seal of the said State, at Melbourne, the eleventh day of October, One thousand nine hundred and twenty-eight, constitute depute and appoint His Excellency the Honorable Sir William Hill Irvine, K.C.M.G., Lieutenant-Governor of the said State, to be during my said temporary absence from the Seat of Government Deputy for and on my behalf to exercise the several powers in the said Instrument specified and limited: And whereas, owing to illness, I the said Governor was prevented from carrying out my intention of leaving the Seat of Government: And whereas the said Lieutenant-Governor, acting under my said Instrument dated the eleventh day of October, One thousand nine hundred and twenty-eight, presided as my Deputy at a meeting of the Executive Council held on Friday, the twelfth day of October, One thousand nine hundred and twenty-eight, presided as my Deputy at a meeting of the Executive Council held on Friday, the twelfth day of October, One thousand nine hundred and twenty-eight, presided as my Deputy at a meeting of the Executive Council held on Friday, the twelfth day of October, One thousand nine hundred and twenty-eight, and approved of certain draft orders submitted to him by responsible Ministers and also assented in His Majesty's name to the undermentioned Bills passed by the Parliament of the said State, viz.:—

"An Act relating to Standing Places for Certain Classes of Motor Cars":

And whereas a doubt has arisen as to the validity of the said orders and the said Acts being approved and assented to respectively by a Deputy whilst the Governor was at the Seat of Government: Now therefore I the Governor aforesaid do hereby ratify and confirm the said orders and the said Acts so that the said approval and assent shall as from the giving thereof, be valid and effectual.
