PROCLAMATION

By His Excellency the Lieutenant-Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

WHEREAS by an Act of Parliament of the State of Victoria passed in the twenty-fourth year of the reign of His Majesty King George V., intituled the *Mental Hygiene Act 1933* (No. 4157), it is amongst other things enacted that the said Act shall come into operation on a day to be fixed by Proclamation of the Governor in Council published in the *Government Gazette*: Now therefore, I, the Lieutenant-Governor of the State of Victoria, acting by and with the advice of the Executive Council thereof, do by this my Proclamation fix Wednesday, the fourteenth day of February, One thousand nine hundred and thirty-four, as the day upon which the said Mental Hygiene Act shall come into operation in the State of Victoria.

HENLEY ON THE MARIBYRNONG.

NOTICE TO BOATMEN AND OTHERS.

BOATMEN and others are hereby notified that Henley on the Maribyrnong will be held on Saturday, 3rd February, 1934, and that persons in charge of motor and other boats permitted to be on the river during the day and night shall observe the following Regulations, viz.:—

All boats must give way to racing boats going upstream to the start of the course.

PORT PHILLIP HEADS.

Extension Westward of Deep-water Fairway and Directions for Navigation of Deep-draft Vessels.

CONSEQUENT on the resumption of the blasting operations from October, 1932, mariners and others are now notified that the fairway over the Rip bank has been deepened to 43 feet for a width of 450 feet westward from the line of leading lights.

Demarcation, by Day.—The western limit of the 43 feet channel is from now until further notice defined by the High Lighthouse, bearing 044 deg. showing halfway between the Low Lighthouse and the Hume Tower Light which stands 65 feet north-west from the Low Lighthouse.

This western limit is also well defined by the line of Swan Island Beacon and the outer end of the Queenscliff new pier bearing 047 deg.

By Night.—The fixed and occulting white light of the High Light bearing 044 deg. showing halfway between the occulting white light from the Low Lighthouse and the occulting red light from the Hume Tower. The eastern limit of the 43 feet channel is marked as heretofore by the line of the High Light (fixed and occulting white by night) and the obelisk (occulting green by night) bearing 038 deg.

Directions—Deep-draft Steamers.—Mariners in charge of deep-draft steamers are from now until further notice informed that they are navigating in the centre of the deep-water fairway over the Rip bank by day when the High Lighthouse appears just on the east edge of the Low Lighthouse, and by night when the High Light shows just open east of the Low Light.

General Directions—Entrance to Port Phillip.—Since the fairway across the Rip bank at the entrance to Port Phillip has been deepened to 43 feet for a width of 1,000 feet to the eastward and for 450 feet to the westward of the line of leading lights, and as there is a least depth of 37 feet for an additional width of 450 feet, or 900 feet in all, to the westward from the line of leading lights, and a least depth of 37 feet also for an additional 1,000 feet, or for 2,000 feet in all, to the eastward from the line of leading lights, mariners in charge of vessels drawing less than 29 feet may now navigate the fairway with greater safety than heretofore by keeping eastward or westward of the mid-channel course according as they are entering or clearing the Heads while still conforming to the rule of the road.

The other directions for Port Phillip Heads will remain unchanged until further notice.

REGULATIONS.

*At the Executive Council Chamber, Melbourne,
the sixteenth day of January, 1934.*

UNDER the powers conferred by the Farmers Relief Acts and by the *Justices Act 1923* in that behalf His Excellency the Lieutenant-Governor of the State of Victoria, with the advice of the Executive Council of the said State, doth hereby make the following Regulations respecting the Unemployed Occupiers and Farmers Relief Acts, to come into operation on and from the 29th December, 1933, in lieu of all previous Regulations, which are hereby repealed.

1. These Regulations may be cited as the Farmers Relief Acts Regulations 1933 and shall come into operation on the 29th day of December, 1933.

2. In these Regulations the expression "the Act" shall mean the Farmers Relief Acts; the expression "the Board" shall mean the Farmers Relief Board.

3. The forms set out in the Schedule hereto shall be used for the purposes of the Farmers Relief Acts so far as they are respectively applicable.

4. The common seal of the Board shall be affixed to any document when duly authorized by the Board, and only in the presence of any member of the Board and of the Secretary thereof.

5. The Secretary of the Board or his deputy appointed in writing under his hand shall be the chairman of the first meeting of creditors under Section 27 of Act No. 3962.

6. In any case where no committee of creditors has been appointed the Board may require the monthly statement referred to in Sub-section (1) of Section 28 of Act No. 3962 to be forwarded to the Board.

7. The provisions of Sub-sections (1) and (2) of Section 31 of Act No. 3962 as to notification shall extend and apply to any order of the Board deleting from a Protection Certificate or from any order extending the same the specification of any land.

8. On receipt of an application for a Protection Certificate, or of any application for extension or cancellation of a certificate, or for the deletion of land from the specification in a Protection Certificate, the notification to be sent by registered letter by the Secretary to the Board to a creditor shall specify a date on which the Board will proceed to hear such application, being not less than twelve days in the case of an application for a Protection Certificate and not less than five days in the case of any other application herein referred to after the day on which, in the ordinary course of post, such letter would be delivered to such creditor. The Secretary to the Board shall also give similar notice to the farmer, and to any mortgagee, vendor, owner, and lessor referred to in Sub-section (2) of Section 12 of the *Farmers Relief Act 1933*.

9. In every case where an applicant is a lessee of Crown land, the State Rivers and Water Supply Commission, the Closer Settlement Commission, or the Lands Department, as the case may be, shall forward to the Secretary to the Farmers Relief Board any information as to the

use being made of the farm, the purposes to which it is best suited, and generally as to the farmers' methods, the securities executed by the farmer, also financial and other relevant particulars with respect to land and advances.

PURSUANT to the powers in that behalf conferred by section 7 of the *Fruit Growers' Relief (Commonwealth Payment) Act 1933* (No. 4199), His Excellency the Lieutenant-Governor of the State of Victoria, by and with the advice of the Executive Council thereof, doth hereby make the following Regulations, that is to say:—

1. These Regulations may be cited as the *Fruit Growers' Relief (Commonwealth Payment) Regulations 1933*.
2. In these Regulations, unless the contrary intention appears, schedule means the schedule to these Regulations.
3. Claims for payments or progress payments under the Act shall be in accordance with Form A in the schedule, and shall contain the following particulars relating to apples and pears grown by the claimants during the 1932-33 season:—
 - (a) The location and area of the orchard or orchards on which such apples and pears were grown.
 - (b) The area devoted to apples and pears on each orchard.
 - (c) The quantity, in cases, of apples and of pears harvested from each orchard.
 - (d) The quantity, in cases, of such apples and pears sold by the claimant within Australia.
 - (e) The quantity, in cases, of such apples and pears exported from Australia by the claimant, together with the date of shipment of each consignment, the name of the vessel, destination, the number of cases in each consignment, the name of the exporting agent (if any), the gross amount (in Australian currency) received for each consignment, and the expenses incurred in the export of each consignment.

4. Claims for payments or progress payments shall be accompanied by the accounts sales relating to all apples and pears grown by the claimant during the 1932-33 season and exported by him from Australia.

5. Claimants for payments or progress payments shall state whether a certificate under the *Farmers Relief Acts* has been issued to them.

6. Where the claimant is a share-farmer he shall state in the claim the nature and extent of his interest in the apples and pears under the share-farming agreement and the name and address of the other party or parties to the share-farming agreement.

7. Claimants for payments or progress payments shall state that they are necessitous, and shall supply the following particulars:—

- (a) A statement of their total assets.
- (b) A statement of their total liabilities.
- (c) A statement of their total income from all sources during the year ended 31st December, 1933.
- (d) A statement of their total expenditure during the year ended 31st December, 1933.
- (e) Particulars of family at home, with ages of dependent children.

8. Claims for payments or progress payments shall be supported by a statutory declaration made by the claimants before a justice of the peace or a commissioner for taking declarations and affidavits.

9. For the purpose of verifying any claim for payment or progress payment under the Act, any officer duly authorized, in writing, by the authority may, by notice in writing, call upon any person who makes a claim for payment or progress payment under the Act to furnish to him, within such time as may be specified in the notice, such books, documents, diaries, or other documents or writings relating to apples and pears as the authority thinks necessary; and any such person who without reasonable excuse fails after receipt of such notice to comply with the requirements of such notice shall be liable to a penalty of not more than Fifty pounds or imprisonment for not more than Three months.

2. In these Regulations, unless the contrary intention appears, "officer" means an officer of the Department of Agriculture or of the Department of Lands, and includes any person declared, in writing, by the Minister to be an officer for the purpose of these Regulations.

"Schedule" means the schedule to these Regulations.

3. Claims for payments or progress payments under the Act shall be in accordance with Form A in the schedule, and shall contain the following particulars:—

(a) The area sown to wheat by claimant in Victoria in 1933,
(a) on fallow land, (b) on stubble land, (c) on other land.

(b) The area of self-sown wheat crop on the claimant's farm or farms in 1933.

(c) The location of the farm or farms on which the wheat was sown, and the area of such farm or farms, together with the area sown to wheat on each such farm.

(d) The area of wheat harvested for grain by claimant after 1st October, 1933, and the yield of grain obtained in bushels.

(e) The area of wheat cut for hay by claimant after 1st September, 1933, and the produce obtained in tons.

(f) The area of self-sown wheat harvested for grain by claimant after 1st October, 1933, together with the yield obtained in bushels.

(g) The area of self-sown wheat cut for hay by claimant after 1st September, 1933, together with the produce obtained in tons.

(h) Area sown to wheat by claimant in 1932, together with yield of grain in bushels obtained from that area.

4. Where the claimant is a share-farmer, he shall state in the claim the nature and extent of his interest in the wheat under the share-farming agreement, and the name and address of the other party or parties to the share-farming agreement.

5. The claimant shall state whether a protection certificate under the *Farmers Relief Acts* has been issued to him.

6. Claims for payments or progress payments shall be supported by a statutory declaration made by the claimants before a justice of the peace, or a commissioner for taking declarations and affidavits.

7. Claims for payments or progress payments shall be accompanied by a statutory declaration (together with a copy thereof) from the claimant stating—

(a) that he derived no taxable income during the year ended on the thirtieth day of June, One thousand nine hundred and thirty-three; or

(b) that he derived taxable income during that year, and that there are circumstances by reason of which it is just that he should receive such assistance.

8. Claims shall be forwarded in the first instance to the Inspector of Land Settlement stationed in the district in which the farm of the claimant is situated.

9. For the purpose of verifying any claim for payment or progress payment under the Act, any officer duly authorized, in writing, by the authority may, by notice, in writing, call upon any person who makes a claim for payment or progress payment under the Act to furnish to him, within such time as may be specified in the notice, such books, documents, diaries, or other documents or writings relating to wheat as the officer thinks necessary, and any such person who without reasonable excuse fails, after receipt of such notice, to comply with the requirements of such notice shall be liable to a penalty of not more than Fifty pounds or imprisonment for not more than three months.
