ELECTORAL PROVINCES.

PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

UNDER the powers in that behalf conferred by section 10 of *The Constitution Act Amendment Act 1936, I*, the Governor of the State of Victoria, in the Commonwealth of Australia, by and with the advice of the Executive Council of the said State, do by this my Proclamation declare the names and boundaries of the Electoral Provinces for the Legislative Council as set out in the schedule hereto.

Given under my Hand and the Seal of the State of Victoria aforesaid, at Melbourne, this twelfth day of January, in the year of our Lord One thousand nine hundred and thirty-seven, and in the first year of the reign of His Majesty King George VI.

NAMES AND BOUNDARIES OF ELECTORAL PROVINCES
FOR THE LEGISLATIVE COUNCIL.

TECHNICAL DESCRIPTIONS.

In the following descriptions, wherever the boundary described runs along a river, creek, road, or street, the centre of such river, creek, road, or street shall be taken to be the boundary line.

In cases where the boundaries described are those of a municipal district, or portion of a municipal district, they shall be taken to be the boundaries in force on the 31st October, 1936.

METROPOLITAN.

DOUTTA GALLA PROVINCE.

Commencing on the Moonee Ponds Creek where Moreland-road abuts thereon; thence east by that road to the Merri Creek; thence south-easterly by that creek to Queen's-parade; thence south-westerly by that parade to Napier-street; thence north by that street to Freeman-street; thence west by that street to Nicholson-street; thence south by that street to Faraday-street; thence west by that street to Swanston-street; thence north by that street and north-westerly and south-westerly by College-crescent to Sydney-road; thence southerly by that road to its junction with Flemington-road; thence north-westerly by Flemington-road and Mount Alexander-road to the Moonee Ponds Creek; thence southerly by that creek to the Williamstown railway; thence westerly by that railway to the Maribyrnong River; thence north-westerly by that river to the west boundary of the City of Essendon; thence north by that boundary and easterly by the north boundary of the said city to Bulla-road; thence north-westerly by that road to Sharp's-road; thence east by the north boundary of the Parish of Doutta Galla to the Moonee Ponds Creek; thence south-easterly by that creek to the north boundary of the Parish of Jika Jika; thence east by that boundary to Northumberland-road; thence south by that road to Gaffney-street; thence west by that street to the Moonee Ponds Creek; thence southerly by that creek to Moreland-road, being the point of commencement.

EAST YARRA PROVINCE.

Commencing at the junction of the Kooyongkoot or Gardiner's Creek with the Yarra River; thence generally north-westerly and north-easterly by the Yarra River to its junction with the Koonung Koonung Creek; thence generally easterly by the Koonung Koonung Creek to Middleborough-road; thence southerly by that road to the north boundary of allotment 21c, Parish of Nunawading; thence west by that boundary and the north boundary of allotment 20A and westerly by Riversdale-road to Boundary-road; thence southerly by that road to the Kooyongkoot or Gardiner's Creek; thence westerly and north-westerly by that creek (following the constructed channel where it deviates from the old creek bed) to the Yarra River, being the point of commencement.

HIGINBOTHAM PROVINCE.

Commencing on the shore of Port Phillip Bay at North-road; thence east by North-road to Bambra-road; thence north by that road to Balaclava-road; thence east by that road to Park-crescent; thence north-westerly by that crescent to Inkerman-road; thence west by that road to Mayfield-grove; thence northerly by that grove to Normanby-road; thence north-westerly by that road to Dandenong-road; thence north-easterly by that road to Glendearg-grove; thence north by that grove to Wattle-tree-road; thence west by that road to Isabella-street; thence north by that street to Winter-street; thence east by that street to Oxford-street; thence north by that street to Stanhope-street; thence east by that street to Harvey-street; thence north by that street to High-street; thence west by that street to Spring-road; thence north by that road to Malvern-road; thence east by that road to Elizabeth-street; thence north by that street to Toorak-road; thence east by that road to the Kooyongkoot or Gardiner's Creek; thence south-easterly and easterly by that creek (following the constructed channel where it deviates from the old creek bed) to Warrigal road; thence south by that road to Waverley-road; thence east by that road to Box Hill-road; thence south by that road and southerly by Irvine-street and Victoria-avenue to Centre-road; thence west by that road to Warrigal-road; thence south by that road to South-road; thence west by that road to Bluff-road; thence south by that road to Edward-street; thence west by that street and a line to the shore of Port Phillip Bay; thence north-westerly by that shore to North-road, being the point of commencement.

MELBOURNE PROVINCE.

Commencing at the junction of Flemington-road with Sydney-road; thence northerly by Sydney-road to College-crescent; thence north-easterly and south-easterly by that crescent and south by Swanston-street to Faraday-street; thence east by that street to Nicholson-street; thence north by that street to Freeman-street; thence east by that street to Napier-street; thence south by that street to Queen's-parade; thence north-easterly by that parade to

Smith-street; thence south by that street to Alexandra-parade; thence east by that parade to the Merri Creek; thence southerly by that creek and generally south-easterly and westerly by the Yarra River and the Coode Canal and northerly by the Yarra River and the Maribyrnong River to the Williamstown railway; thence easterly by that railway to the Moonee Ponds Creek; thence northerly by that creek to Mount Alexander-road; thence south-easterly by that road and Flemington-road to the point of commencement.

MELBOURNE NORTH PROVINCE.

Commencing on the Moonee Ponds Creek where Moreland-road abuts thereon; thence northerly by that creek to Gaffney-street; thence east by that street to Northumberland-road; thence north by that road to the north boundary of the City of Coburg; thence easterly by that boundary to the Merri Creek; thence northerly by that creek to the north boundary of the City of Preston; thence easterly by that boundary to the Upper Plenty-road; thence south-westerly by that road to the south boundary of section 15, Parish of Keelbundora; thence easterly by the Preston City boundary, a line, and the boundaries of sections 9 and 8 to the Plenty River; thence southerly by that river to the Yarra River; thence generally south-westerly by that river to the Merri Creek; thence northerly by that creek to Alexandra-parade; thence west by that parade to Smith-street; thence north by that street to Queen's-parade; thence north-easterly by that parade to the Merri Creek; thence north-westerly by that creek to Moreland-road at the south boundary of the City of Coburg; thence west by that road to the Moonee Ponds Creek, being the point of commencement.

MELBOURNE WEST PROVINCE.

Commencing on the shore of Port Phillip Bay at a point in line with Shakespeare-grove (St. Kilda); thence north-westerly by that shore, westerly and southerly by the shore of Hobson's Bay and westerly by the shore of Port Phillip Bay to the west boundary of the City of Williamstown; thence north by that boundary to the Stony Creek; thence northerly by that creek to Francis-street; thence west by that street to the Geelong-road; thence south-westerly by that road to the Kororoit Creek; thence northerly by that creek to Anderson-road at the west boundary of section 18, Parish of Cut Paw Paw; thence north by Anderson-road, northerly by McIntyre-road, and further north by the west boundary of section 22 to the Maribyrnong River; thence south-easterly, north-easterly, and again south-easterly by that river and the Yarra River to the Coode Canal; thence easterly by that canal and the Yarra River to a point in line with Aikman-street; thence south-easterly by a line, that street, and Sloss-street to Nolan-street; thence north-easterly by that street to St. Kilda-road; thence south-easterly by that road to High-street (Prahran); thence east by that street to Punt-road; thence south by that road and south-easterly by High-street (St. Kilda) to Inkerman-street; thence west by that street to Barkly-street; thence south by that street to Carlisle-street; thence west by that street to Albert-street; thence south-westerly by that street, Shakespeare-grove, and a line to the shore of Port Phillip Bay, being the point of commencement.

MONASH PROVINCE.

Commencing on the shore of Port Phillip Bay at a point in line with Shakespeare-grove (St. Kilda); thence north-easterly by a line, Shakespeare-grove and Albert-street to Carlisle-street; thence east by that street to Barkly-street; thence north by that street to Inkerman-street; thence east by that street to High-street (St. Kilda); thence north-westerly by that street and north by Punt-road to High-street (Prahran); thence west by that street to St. Kilda-road; thence north-westerly by that road to Nolan-street; thence south-westerly by that street to Sloss-street; thence north-westerly by that street, Aikman-street and a line to the Yarra River; thence easterly by that river and south-easterly by the Kooyongkoot or Gardiner's Creek to Toorak-road; thence west by that road to Elizabeth-street; thence south by that street to Malvern-road; thence west by that road to Spring-road; thence south by that road to High-street; thence east by that street to Harvey-street; thence south by that street to Stanhope-street; thence west by that street to Oxford-street; thence south by that street to Winter-street; thence west by that street to Isabella-street; thence south by that street to Wattle-tree-road; thence east by that road to Glendearg-grove; thence south by that grove to Dandenong-road; thence

south-westerly by that road to its junction with Normanby-road; thence south-easterly by that road to Mayfield-grove; thence southerly by that grove to Inkerman-road; thence east by that road to Park-crescent; thence south-easterly by that crescent to Balaclava-road; thence west by that road to Bamba-road; thence south by that road to North-road; thence west by that road to the shore of Port Phillip Bay; thence north-westerly by that shore to the point of commencement.

COUNTRY.

BALLAARAT PROVINCE.

Commencing on the Wimmera River at a point where the road forming the south boundary of the Parish of Marma abuts thereon; thence east by that road and the road forming the south boundary of the Parish of Wirchilleba to the south-east angle of allotment 192; thence north by the east boundary of that allotment and a line in continuation thereof to the Richardson River; thence north-westerly and north-easterly by that river to the road forming the south boundary of the Parish of Banyena; thence east by that road to the north-east angle of allotment 7, Parish of Marnoo; thence south by a road to the north-west angle of allotment 41; thence east by the north boundary of that allotment, the road forming the north boundary of allotment 36 and a line to the western boundary of allotment 35B; thence north-easterly by that boundary to the western boundary of allotment 35A; thence southerly by that boundary and east by the south boundaries of that allotment and allotment 37A to the north-east angle of allotment 37; thence south by a road to the south-west angle of allotment 3A, section 4, Parish of Warngar; thence south-easterly by a three-chain road to the main road from Stawell to Navarre; thence easterly by that road and north-easterly by a three-chain road through the Town of Navarre to the road forming the eastern boundary of that town; thence southerly by that road to the three-chain road forming the south-western boundary of allotment 191A, section B, Parish of Navarre; thence south-easterly by that road to the north-western angle of allotment 168A; thence easterly by a road to the road forming the eastern boundary of the parish; thence northerly by that road to the north-eastern angle of allotment 180; thence easterly by a road to the north-eastern angle of allotment 22B, section E, Parish of Barkly; thence southerly by the eastern boundary of that allotment to the south-western angle of allotment 52B; thence easterly by the southern boundaries of that allotment and allotment 53 to the road forming the eastern boundary of the last-mentioned allotment; thence northerly by that road to the road forming the southern boundary of allotment 54; thence easterly by that road and northerly by the eastern boundary of the said allotment to a point due west (magnetic) of the south-western angle of allotment 71, Parish of Redbank; thence east (magnetic) by a line to that angle; thence easterly by a road to the main road from St. Arnaud to Ballarat; thence southerly by that road to the road forming the northern boundary of allotment 35; thence easterly by that road and southerly by the road forming the eastern boundary of the said allotment to the south-western angle of allotment 34B; thence easterly, southerly, and easterly by a road to the south-eastern angle of allotment 34E; thence northerly by the eastern boundary of that allotment and easterly by the southern boundary of allotment 33A to its south-eastern angle; thence southerly by a road to the southern angle of allotment 31; thence easterly by a road to the road forming the eastern boundary of the Parish of Redbank; thence southerly by that road to the south-western angle of allotment 44G, section 1, Parish of Moyreisk; thence easterly and north-easterly by a road to the eastern angle of allotment 39B; thence easterly by a road to the three-chain road from St. Arnaud to Avoca; thence south-easterly by that road to the south-western angle of allotment 34B; thence easterly by the southern boundaries of that allotment and the Rathscar pre-emptive section to the Avoca River; thence southerly by that river to a point in line with the northern boundary of allotment 18, Village of Natteyallock; thence easterly by a line and a road to the road forming the western boundary of allotment 3A, section 1, Parish of Natteyallock; thence southerly by that road to the south-western angle of that allotment; thence easterly by the southern boundary of the last-mentioned allotment to the road forming the western boundary of allotment 2, section 3; thence northerly by that road to the north-western angle of the said allotment; thence easterly by a road to the south-eastern angle of allotment 12, section 4; thence northerly by a road to the

south-western angle of allotment 14, section 4; thence easterly and north-easterly by a road to the northern angle of allotment 8, section A, Parish of Rathscar; thence south-easterly by the north-eastern boundary of that allotment to its eastern angle; thence south-westerly by a road to the road forming the south-western boundary of allotment 1; thence south-easterly by that road to the road forming the eastern boundary of allotment 6A¹; thence southerly by that road to the main road from Natteyallock to Maryborough; thence easterly by that road to the north-eastern angle of allotment 2, section 3, Parish of Wareek; thence southerly by the eastern boundaries of that allotment and allotment 7 and westerly by a road to the south-western angle of the last-mentioned allotment; thence southerly by a road to the north-eastern angle of allotment 26, Parish of Rathscar; thence westerly by a road to the north-eastern angle of allotment 25B; thence southerly by the eastern boundaries of that allotment and allotments 32 and 30 to the south angle of allotment 29; thence south-westerly by the road from Dunolly to Avoca to the north-western angle of allotment 43; thence southerly by a road to the north-western angle of the Township of Bung Bong; thence easterly and southerly by the northern and eastern boundaries of that township to the southern angle of allotment 15, section 2, Parish of Bung Bong; thence north-easterly by a road to the southern boundary of allotment 16; thence easterly by that boundary, northerly by a road and easterly by the southern boundary of allotment 26 and a line in continuation thereof to the western boundary of allotment 17; thence southerly by that boundary and easterly by the southern boundary of the said allotment and a line in continuation thereof to the road from Avoca to Maryborough; thence north-easterly by that road to the northern angle of allotment 10, section 4; thence south-easterly, southerly and south-westerly by a road to the northern angle of allotment 1v; thence easterly by a direct line to the southern angle of allotment 5, section 5; thence easterly by a direct line to the north-eastern angle of allotment 2A, section 19, Parish of Amherst; thence easterly and south-easterly by a road to the road from Amherst to Carisbrook at the south-eastern angle of allotment 12N, section 9A; thence easterly by that road to the western boundary of the Parish of Craigie; thence southerly by a road to the southern boundary of allotment 5, section B; thence easterly by that boundary and a line in continuation thereof to the western boundary of allotment 29A, section 2; thence northerly by that boundary to the road forming the northern boundary of the said allotment; thence easterly by that road, the northern boundaries of allotments 29, 14, and 13 and a road to the south-eastern angle of allotment 114, section 7; thence southerly by a road to the northern boundary of allotment 11, section 5; thence easterly by that boundary to the Tullaroop or Deep Creek; thence northerly by that creek to the northern boundary of allotment 2B, section 5, Parish of Rodborough; thence easterly by that boundary, the northern boundaries of allotments 2A and 2 and a road to the south-eastern angle of allotment 1c, section 11; thence further easterly by a line in continuation of the southern boundary of the last-mentioned allotment to Joyce's or Deep Creek; thence southerly and south-easterly by that creek to its source (in the Parish of Wombat); thence south (magnetic) by a direct line to the Great Dividing Range; thence north-easterly by the boundary between the Shires of Glenlyon and Bungaree, generally north-easterly by the boundary between the Shires of Glenlyon and Ballan, easterly, north-easterly and south easterly by the boundary between the Shires of Kyneton and Ballan, easterly by the boundary between the Shires of Kyneton and Bacchus Marsh, north-easterly by the boundary between the Shires of Bacchus Marsh and Newham & Woodend, and southerly by the boundary between the Shires of Bacchus Marsh and Gisborne to the road from Trentham to Gisborne; thence south-easterly by that road to the western boundary of allotment 53, Parish of Bullengarook; thence southerly by that boundary and southerly and easterly by the western and southern boundaries of allotment 44 to a point in line with the eastern boundary of allotment 43; thence south-westerly by a direct line to the northern angle of allotment 36; thence south-westerly by the north-western boundary of that allotment to its western angle; thence south-easterly by a road to the

northern boundary of allotment 26A; thence westerly by that boundary and south-westerly and southerly by Goodman's Creek to the road forming the southern boundary of allotment 20A; thence easterly by that road and southerly and easterly by roads forming the western and southern boundaries of the Bullengarook Pre-emptive section to the south-eastern angle thereof; thence southerly and easterly by a road to the south-eastern angle of allotment 22E and further easterly by the southern boundary of the parish to the Djerriwarrh Creek; thence southerly by that creek to its junction with the Werribee River; thence westerly by that river to the eastern boundary of the Parish of Parwan; thence southerly by that boundary and westerly by the southern boundary of the last-named parish to the Balliang Creek; thence southerly by that creek to the road from Bacchus Marsh to Geelong; thence southerly by that road to the south-eastern angle of allotment 20, section A (Staughton Vale Estate), Parish of Balliang; thence westerly by a road to the road forming the eastern boundary of allotment 21; thence southerly by that road and the road forming the eastern boundaries of allotments 23, 24 and 25 to the Little River; thence westerly by that river to the western boundary of the last-named parish; thence northerly by that boundary to the north-eastern angle of allotment 2A, section B, Parish of Beremboke; thence westerly and southerly by a road to the northern boundary of allotment 5; thence westerly by that boundary and the northern boundary of allotment 8 to its north-western angle; thence westerly by a direct line to the south-eastern angle of allotment 24E; thence westerly by the southern boundaries of the last-named parish and the Parish of Ballark to the Moorarbool River; thence southerly by that river to the southern boundary of allotment 47, Parish of Meredith; thence westerly by that boundary, the southern boundaries of allotment 46, the Borhoneyghurk Pre-emptive Section, and a road to the north-western angle of allotment 133, Parish of Meredith; thence southerly by the western boundaries of that allotment and allotments 132, 129, 128 a road and a line in continuation thereof to the Geelong and Ballarat Railway; thence north-westerly by that railway to a point in line with the northern boundary of allotment 166; thence westerly by a line and a road to the north-west angle of allotment 182A at the western boundary of the parish; thence south-westerly by a road to the southern boundary of allotment 63B, Parish of Cargerie; thence westerly by that boundary and the southern boundary of the Cargerie pre-emptive section to its south-western angle; thence south-westerly by a road to the northern boundary of allotment 32; thence west by that boundary and the northern boundary of allotment 31 to the north-west angle of that allotment; thence north by a road to the north-east angle of allotment 36AB¹; thence west and north-westerly by a road to the bridge (known as the Leigh Grand Junction Bridge) over the Yarrowee River; thence north-westerly and westerly by a road forming the northern boundary of allotment 50G, Parish of Enfield to the north-east angle of allotment 50L; thence south-westerly by a road to the south-western angle of allotment 50B; thence westerly by a road forming the southern boundary of the last-named parish and the southern boundary of the Parish of Lynchfield to the Mount Misery Creek; thence south-westerly by that creek and the Little Woody Yaloak Creek to its junction with the Woody Yaloak River; thence southerly by that river to the road forming the north boundary of the Parish of Wilgul North; thence west by that road and the road forming the north boundary of the Parish of Poliah North to the Gnarkeet Ponds; thence northerly by those ponds to their source, being a point on the road forming part of the eastern boundary of the Parish of Borriyallock; thence northerly by that road and the road forming the eastern boundary of the Parish of Skipton to the Mount Emu Creek; thence south-westerly by that creek and westerly by the boundary of the County of Ripon to the Fiery Creek; thence westerly by that creek and the southern boundary of the last-named county to the Hopkin's River; thence south-westerly by that river to its junction with the Back Creek; thence northerly and north-westerly by that creek and westerly by the boundary between the Counties of Ripon and Villiers to the Serra Range; thence northerly by that range and the Grampians Range to Briggs' Bluff; thence north-east by a line to the south-west boundary of the Parish of Ledcourt; thence north-westerly by that boundary to the western angle of allotment 212; thence easterly by a two-chain road to the eastern angle of allotment 201; thence north by a road to the north-west angle of allotment 23 at the north boundary of the parish; thence east by a road to the Wimmera River; thence north-westerly by that river to the road forming the south boundary of the Parish of Marma; being the point of commencement.

BENDIGO PROVINCE.

Commencing on the main road from Nattetallock to Maryborough at the north-eastern angle of allotment 2, section 3, Parish of Wareek; thence easterly by that road to the north-eastern angle of allotment 3B; thence northerly by a road to the south-western angle of allotment 12, section 1A; thence easterly by the southern boundaries of that allotment and allotments 11, 10, 9, 8, and 7 to the south-eastern angle of the last-mentioned allotment; thence southerly by a road to the south-western angle of allotment 9, section 2A; thence north-easterly by a road to the southern boundary of allotment 9, section 3A; thence easterly by that boundary to the Bet Bet Creek; thence generally north-easterly by that creek and northerly by the Loddon River to the northern boundary of allotment 1, section 15, Parish of Yarrayne; thence east by a road to the Bullock Creek; thence further east by a road to the road forming the east boundary of the Parish of Salisbury; thence north by that road to the north boundary of allotment 1A, section 8A, Parish of Yallock; thence east by a road to the south-east angle of allotment 40, section A, Parish of Kamarooka; thence north by a road to the north-west angle of allotment 12F; thence east by a road to the north-eastern angle of allotment 12B; thence south, south-easterly, easterly, and south by the eastern boundary of that allotment to its south-east angle; thence east by the north boundary of allotment 12E and south by the west boundary of allotment 12A to the south-west angle of that allotment; thence east and north-easterly by a road to the Piccaninny Creek; thence south-easterly by that creek and further south-easterly and southerly by the Bendigo Creek and the western boundary of allotment 2, section 5 (Elmore Estate), Parish of Egerton, to the south-western angle of that allotment; thence easterly by a road and the northern boundary of the Parish of Nolan to the Campaspe River; thence southerly by that river to the road forming the northern boundary of the Parish of Axedale; thence east by that road and the road forming the north boundaries of the Parishes of Weston and Crosbie to a point in line with the west boundary of allotment 2, section D, in the last-named parish; thence south by a road to the north-western angle of allotment 24, section C; thence easterly by a road to the north-eastern angle of allotment 6, section 23 (Mount Camel Estate), Parish of Redcastle; thence north-easterly by a road to the most western angle of allotment 7B; thence southerly by the western boundary of that allotment to the Cornella Creek; thence north-easterly by that creek to its junction with the Redcastle Creek; thence southerly by that creek to the northern boundary of the Shire of McIvor; thence east, south, and east by that boundary to the southern boundary of the County of Rodney; thence easterly and south-easterly by that boundary to the Sandy Creek; thence southerly and easterly by that creek to the Goulburn River; thence southerly by that river to Hughes Creek; thence northerly and easterly by that creek to the road forming the western boundary of allotment 1, section A, Parish of Avenel; thence northerly by that road and easterly by a road forming the northern boundary of the said allotment to the road forming the east boundary of allotment B²; thence north by that road to the north-east angle of the last-mentioned allotment; thence east by a road to the north-east angle of allotment 31, section G; thence north by a two-chain road to the north-west angle of allotment 33; thence east and south by a road to the south-east angle of allotment 34A; thence north-easterly by a two-chain road to a point in line with the east boundary of allotment 38; thence south by a line and a road to the northern boundary of allotment 18, section 18A; thence easterly and southerly by the northern and eastern boundaries of that allotment, easterly and southerly by the northern and eastern boundaries of allotment 17, and again easterly and southerly by the northern and eastern boundaries of allotment 15 to the south-eastern angle of the last-mentioned allotment; thence easterly by the northern boundaries of allotments 63B, 63A, 54A, and 54, Parish of Monca South, and southerly by the eastern boundary of the last-mentioned allotment to its south-eastern angle; ALTERATION OF THE REGULATIONS RESPECTING NETTING IN WATSON'S, WOOROOKOKE, AND DEW'S LAKES, NEAR CHARLTON.

PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

I, THE Governor of the State of Victoria, in the Commonwealth of Australia, by and with the advice of the Executive Council of the said State, and in pursuance of the provisions of the Fisheries Acts and all other powers me enabling in that behalf, do by this Proclamation repeal the Proclamation made the twenty-second day of January, 1924, and published in the *Government Gazette* of the thirtieth day of January, 1924, respecting netting in Watson's, Woorookoke, and Dew's Lakes, near Charlton, and permit the use of gill or set nets for the purpose of taking fish in Watson's, Woorookoke, and Dew's Lakes (commonly known as the Woorookoke Lakes) during the whole of each year provided:—

1. That no nets shall be used other than those with meshes measuring not less than three and a half inches;
2. That no person shall use at the one time more than two hundred and twenty yards of net.

FURTHER AMENDMENT OF ELECTRICAL TRADES REGULATIONS (No. 3).

IN pursuance of the powers conferred by the Apprenticeship Acts and the Acts Interpretation Act 1928, His Excellency the Governor of the State of Victoria, by and with the advice of the Executive Council thereof, doth hereby make the following Regulations (that is to say):—

1. Regulations 4 and 4 (a) of the Electrical Trades Regulations (No. 3) shall be and the same are hereby rescinded as on and from the eighth day of December, 1936.
2. Such rescission shall not affect any right accrued or accruing to any person, or any liability of any person under the said rescinded Regulations before the commencement of these Regulations.
3. For the said rescinded Regulations substitute the following:—

“4. The minimum rates of wages to be paid to apprentices shall be as follows, and shall commence on the eighth day of December, 1936, on, from, and after which date all indentures heretofore executed under the provisions of the Act, and the Regulations made in respect of the aforesaid trades shall be deemed to be amended accordingly:—

- (a) Apprentices whose indentures were executed before the 17th day of June, 1936—
 - 1st year—at the rate of 17s. 3d. per week.
 - 2nd year—at the rate of 23s. per week.
 - 3rd year—at the rate of 36s. 6d. per week.
 - 4th year—at the rate of 52s. 9d. per week.
 - 5th year—at the rate of 67s. 3d. per week.
- (b) Apprentices whose indentures were executed on and after the 17th day of June, 1936—
 - 1st year—at the rate of 15s. per week.
 - 2nd year—at the rate of 20s. 6d. per week.
 - 3rd year—at the rate of 32s. per week.
 - 4th year—at the rate of 52s. 3d. per week.
 - 5th year—at the rate of 65s. 9d. per week.

And the Honorable Edwin Joseph Mackrell, His Majesty's Minister of Labour for the State of Victoria, shall give the necessary directions herein accordingly.

- For each offensive trade premises—Fifty shillings.
- For each boardinghouse—Ten shillings.

- For each eating house—Ten shillings.
- For each premises (whether a licensed victualler's premises or not) on which are manufactured or prepared for sale, ice cream, ices, ginger beer, hop beer, or any similar beer, lemonade, cordials, soda water, lithia water, or other mineral water, or any artificially aerated water—Five shillings.
- For each premises at or in any part of which eggs for sale are received or stored for the purpose of being chilled—One pound.
- For each transfer of registration—Two shillings and sixpence.

2. This By-law shall apply to and have operation throughout the whole of the City of Geelong West.

CITY OF MORDIALLOC.

By-LAW No. 72.

A By-law of the City of Mordialloc, made under section 197 of the *Local Government Act* 1928 with the approval of the Governor in Council, and numbered 72, for the purpose of prescribing areas within the municipality as residential areas and prohibiting or regulating within the whole or any part of such residential areas the use of any land or the erection (including adaptation for use) or the use of any building for the purpose of all classes of trades, industries, manufactures, businesses or public amusements.

IN pursuance of the powers conferred by the *Local Government Act* the Mayor, Councillors and Citizens of the City of Mordialloc order as follows:—

1. That By-law No. 64 be amended by deleting from clause 18, schedule 1, the words "and from Isabella-street to White-street."

2. This By-law shall come into operation on its confirmation by the Governor in Council, and immediately after its publication in the *Government Gazette*.

A Resolution adopting the foregoing By-law was passed by the Council of the City of Mordialloc on the 12th day of October, 1936, and confirmed on the 9th day of November, 1936.

SHIRE OF MILDURA.

By-LAW No. 74.

A By-law of the Shire of Mildura, and numbered 74, prescribing the conditions on which animals may be received into or supplied or removed from the Abattoirs of the Shire of Mildura; requiring persons engaged in tending and slaughtering animals, and in dressing carcasses at the Abattoirs to be licensed, and prescribing the conditions of licence; fixing the rates of fees or dues payable to it under the *Health Act* 1928; prescribing the time for slaughtering animals; the feeding, watering, and tending, and the prevention of cruelty to and overcrowding of animals in the Abattoirs, and for the regulation and management of the Abattoirs of the Shire of Mildura, and for other purposes therein appearing.

IN pursuance of the powers conferred by the *Local Government Act* 1928, and the *Health Act* 1928, and every other Act or power enabling them in that behalf, the Council of the Shire of Mildura orders as follows, and makes the following By-law:—

1. Superintendent.

The land of the Council held for abattoir purposes, and all buildings and structures thereon and appurtenances thereto, hereinafter called the establishment, shall be under the care, management, and direction of the superintendent appointed by the Council, with one or more assistants as the Council have appointed or may appoint for that purpose.

2. Assistant Superintendent, &c.

During the absence of the superintendent his duties shall devolve upon and be performed by the assistant or other person in the service of the Council then in charge of the establishment, and such assistant or person shall for the time being have all the powers, authority, and duty of the superintendent.

3. Hours for Use.

The establishment shall be open for slaughtering during the following hours and days in each week, and at no other time except upon special occasions, and then only upon special conditions as may be prescribed, in writing, under the hand of the Shire Secretary—

Mondays, Tuesdays, Wednesdays, Thursdays, and Fridays, from 5 a.m. until 5 o'clock p.m., and on Saturday mornings from 5 o'clock a.m. until 11 a.m.

The establishment shall not be open on Sundays, Good Friday, Christmas Day, New Year's Day, Foundation Day, Easter Monday, or such other public holidays as may be determined by the Council.

The establishment shall be open for the removal of branded carcasses during the hours in which it is open for slaughtering.

4. Use on Payment of Dues.

Every person who shall pay the dues and fees as hereinafter fixed shall be entitled to the use for a reasonable time of such portion of the establishment as shall be available and be assigned to him. No person shall use any portion of the establishment except for such purpose or at or for such time as the superintendent shall approve.

5. Stock to be Reported.

Every person who shall bring any animals to the establishment shall forthwith inform the superintendent of the number and description thereof, together with the name and address of the owner thereof, and the locality or district from which the same were brought, and the superintendent shall thereupon cause such particulars to be entered in a record book to be kept at the Abattoirs, and every such person shall place such animals in such portion of the establishment as directed by the superintendent, and in no case shall any animals, once brought into the establishment, be removed without the consent of the superintendent.

6. Fees and Dues Payable.

The following fees and dues shall be payable to the Council for the use of the public Abattoirs in respect of the matters following, that is to say:—

7. Food for Stock.

The owner of all animals placed in the establishment shall provide the same with good and sufficient food at least once in every twenty-four hours, and shall provide that all milch animals shall be duly milked. In case he shall fail to do so the Council may do so, and such owner shall pay to the Council all expenses incurred in connexion therewith.

8. No animal shall be allowed to remain in the establishment for a longer period than forty-eight hours, nor any carcasses or portion of any carcasses for a longer period than eighteen hours, unless with the consent of the superintendent.

9. Diseased Animals.

No animals visibly or known to be affected with any contagious or infectious disease shall be received into the establishment except with the express permission of the superintendent.

10. Lien.

The Council shall have a lien on all animals, carcasses, skins, hides, fat, and/or offal for the time being in the establishment of any person indebted to the Council, and if any person shall default for seven (7) days in payment of any fees or sums due by him, the Council may (without any demand or giving any notice) sell by public auction or private contract all or any part of such animal carcasses, skins, hides, fat, and/or offal, and after deducting all fees and sums due to the Council, shall pay the surplus thereof to the owner of such animals, carcasses, skins, hides, fat, and/or offal.

11. Liability for Death, Injury, or Escape.

The Council will take all reasonable care of stock brought into the establishment for slaughter, but will not be responsible for any injury to or for the death or escape of any stock.

12. Liability for the Loss of Carcasses.

The Council will take all reasonable care of carcasses and offal while in its possession, but the Council will not be responsible for any loss thereof or damage thereto.

13. Liability for Bone-taint, Hides and Skins.

The Council will take no risk or responsibility with respect to carcasses, skins, hides, fat, and/or offal of animals slaughtered at the establishment, and the Council will under no circumstances whatever be responsible for bone-taint or any other condition which may occur in carcass meat whilst on the Abattoir premises or in the chilling chamber.

14. Hours for Opening and Closing Chilling Chamber.

The chilling chambers at the establishment shall be opened and closed daily at such times as the superintendent shall direct, and at no other time, and all persons doing business at the establishment in connexion with the chilling chambers shall conform to the directions of the superintendent or the inspector or other person on duty at the time.

15. Directions of Superintendent or Inspector to be Obeyed.

All persons doing business at the establishment shall conform to the directions of the superintendent or the inspector or other person on duty at the time.

16. Carcass to be Examined and Passed Before Removal.

No person shall remove from the establishment any carcass of any animal slaughtered thereat until the same has been examined by the inspector and passed by him as fit for human food, and branded by him with the regulation brand.

17. Slaughtermen.

No person shall be permitted to commence or continue to work at the establishment as a slaughterman unless his name shall be entered in the Register of Slaughtermen hereby required to be kept by the superintendent, and he shall have signed an undertaking to observe, comply with, and obey each and every one of the rules of the establishment under pain (apart from any other penalty) of having his name expunged from the Register of Slaughtermen.

18. All slaughtering shall be carried out in good and sufficient light, and no slaughtering shall be done during the last hour before the closing time hereinbefore prescribed. The superintendent shall cause that carcasses of large animals before the cutting of the throats thereof be lifted by the hind leg or legs, and thoroughly drained of blood which shall, as far as practicable, be thereupon caught in suitable receptacles. The skins of all carcasses shall as far as practicable be kept from contact with blood or flushing water. All carcasses shall be so hung as not to touch any other carcass, or any wall, door, or window of any such room. No sheepskin shall be removed from the establishment with the head attached.

19. Diseased Animals to be Reported.

Immediately any animal slaughtered is discovered to be diseased, the slaughterman in charge shall immediately stop the work of dressing such animal for food and report the fact to the superintendent or inspector on duty at the time, and shall not proceed further with such dressing until authorized to do so.

20. Organs of Diseased Carcasses.

It shall be the duty of slaughtermen to see that the organs of diseased carcasses are not mixed with the organs of healthy carcasses.

21. Disfiguring Walls, &c.

No slaughterman or other person shall—

- (a) Write on, soil, or disfigure any of the walls, floors, ceilings, fittings, or fixtures of the establishment, or remove, deface, or disfigure any signboard or written or printed matter or notice on or in the establishment.
- (b) Except with the permission of the superintendent, interfere in any way with the electric light, switches, motors, fans, ventilation arrangements, or the steam or water pipes, or other appliances whatsoever in the establishment.
- (c) No slaughterman shall leave the establishment attired in his slaughtering clothes. Every slaughterman shall keep such clothes when at the establishment, but not in use, in such part of the establishment as shall be made available and assigned to him for such purpose by the superintendent.

22. Mess Room.

Every slaughterman and every other person having meals at the establishment shall use the mess room provided for the purpose, and shall not use any other portion of the establishment for the purpose.

23. No slaughterman or other person suffering from contagious or infectious disease shall go or be upon the establishment or any part thereof. Any person suspected by the superintendent or shire secretary of so suffering may be ordered to leave, and on refusal to do so may be forcibly removed from the establishment.

24. Cruelty to Animals.

No person shall ill-treat or unnecessarily frighten or irritate any animal, or resort to unnecessary cruelty in slaughtering any animal at the establishment.

25. Dogs.

No dog other than cattle or sheep dogs shall be brought upon or allowed to remain in the establishment, and every such cattle or sheep dog when not in use shall be securely tied up by the person in charge of such dog in such place as is assigned for that purpose by the superintendent. All dogs found in the establishment, whether in charge of any person or not, will be destroyed.

26. Liability for Breakages, &c.

Every person using the establishment who shall do any breakage, injury, damage, or destruction thereto, or to any of the appliances used in connexion therewith, whether accident-

tally or otherwise, shall make good the same to the satisfaction of the superintendent, and if he shall have acted wantonly or maliciously he shall upon conviction be liable to a penalty not exceeding Twenty pounds.

27. Persons Illegally on the Premises.

No person unless having lawful business to transact at the establishment shall enter thereon or remain therein, and if any such person do not leave immediately upon being requested to do so by the superintendent, the assistant, or other person in charge thereof for the time being, he shall be guilty of an offence against this By-law, and may be forcibly removed.

28. Drunkenness, Offensive and Indecent Behaviour, &c.

Any person who shall be drunk, or who shall be guilty of profane swearing or of foul or abusive or offensive language or conduct, or of obscenity or indecency, or who shall conduct himself riotously or create disturbance, or who shall obstruct in the execution of his duty any superintendent, inspector, or officer or other person, shall be guilty of an offence against this By-law, and may be forcibly removed from the establishment.

29. Deposit of Offal, &c.

Any person who shall deposit or cause to be deposited any blood, offal, filth, or refuse matter upon any portion of the establishment, or on any road or land abutting thereon save in the pits, bins, or receptacles provided for same, shall be guilty of an offence against this By-law. The superintendent shall cause all heads, horns, shanks, skins, hair, bristles, blood, and other offal to be removed from the establishment daily.

30. Urinals, Use of.

No person shall, without the consent of the superintendent, place any insoluble or germicidal or other foreign matter in any urinal or water closet at the establishment. Every person using any water closet at the establishment shall use only the sanitary roll paper provided therein by the Council, and shall before leaving such convenience use the flushing water provided for the discharge of the excrement deposited in such convenience.

31. Clean Clothing.

The superintendent, assistant, or other person in charge for the time being may refuse to allow any person not wearing clean clothing or clean overalls to load or handle any meat in the establishment.

32. Penalty.

Any contravention of this By-law or any part thereof by wilful act or default contrary thereto shall be an offence against this By-law, and every person guilty of an offence against this By-law shall be liable, on conviction, to a penalty not exceeding Twenty pounds.

33. Operation of By-law.

This By-law shall apply to and have effect throughout the Mildura Meat Area.
