Forests Act 1928 (No. 3685).

“PROCLAIMED PERIOD” AND “PROCLAIMED AREAS” WHERE SERIOUS DANGER FROM FIRES EXISTS.

PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia. &c. &c., &c.

WHEREAS by section 69 of the *Forests Act 1928* (No. 3685) it is enacted that—

Whenever the Commission with respect to any period of twelve months reports to the Minister that, whether owing to climatic conditions or otherwise, there is serious danger of fire or of the spread of fire in any part or parts of Victoria, the Governor in Council may from time to time, for the purpose of this section, declare by Proclamation—

- (a) any specified portion of such period to be a “proclaimed period,” and
(b) any specified area of Victoria to be a “proclaimed area.”

And whereas under the said section it is provided that every person who during any proclaimed period within any proclaimed area light or kindles, or knowingly causes or permits to be lighted or kindled, any fire in the open air except—

- (a) in such positions as are prescribed by Regulations under the said section, or are indicated by notices in the prescribed form issued under the authority of prescribed persons (including the holders for the time being of any prescribed offices as such), or bodies of persons, and

- (b) with such precautions as are prescribed—

shall be liable to imprisonment for a term of not more than two years, or to a penalty of not more than Two hundred pounds, or to both such imprisonment and penalty;

And whereas the Commission with respect to the period of twelve months commencing on the first day of January, 1937, has reported to the Minister that, owing to climatic conditions, serious danger of fire exists in the parts of Victoria specified in the schedules hereto: Now, therefore, I, the Governor of the State of Victoria, by and with the advice of the Executive Council of the said State, do hereby declare—

- (a) the period from the twenty-seventh day of January, 1937, to the thirty-first day of March, 1937, both dates inclusive, to be a “proclaimed period.”

- (b) the areas of Victoria specified in the schedules hereto to be “proclaimed areas.”

THE CONSTITUTION ACT AMENDMENT ACTS.

PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

WHEREAS, pursuant to the provisions of *The Constitution Act Amendment Act 1936*, the State of Victoria has been re-divided into electoral provinces, the names and boundaries of which have been proclaimed and published in the *Government Gazette*: And whereas it is provided by the said Act that, as soon as practicable after the publication of such Proclamation in the *Government Gazette*, new rolls shall be prepared in accordance with The Constitution Act Amendment Acts for the several electoral provinces mentioned in the Proclamation and the proclaimed divisions thereof: And whereas it is further provided in the said Act that for the purposes of the preparation of the said new rolls the Governor in Council may by Proclamation published in the *Government Gazette* divide any electoral province into divisions and specify the names and boundaries of divisions: And whereas it is by the *Legislative Council Elections Act 1935* enacted that new general rolls generally and new general rolls for any province or division shall be prepared whenever directed by Proclamation of the Governor in Council published in the *Government Gazette* and in the manner specified in the Proclamation: Now therefore I, the Governor of the State of Victoria, in the Commonwealth of Australia, by and with the advice of the Executive Council of the said State, do hereby proclaim:—

- (1) that the electoral provinces aforesaid are hereby divided into the divisions set out in the schedule hereto, with the names and boundaries specified;
- (2) that new general rolls generally shall be prepared;
- (3) that, in preparing the new general rolls, Electoral Registrars shall place on the general roll for the appropriate division the name of each person whose name appears on an existing general roll; and
- (4) that every person entitled to enrolment on such new general rolls, who is not already enrolled on an existing general roll, shall, if he desires enrolment thereon, sign and send to the proper Electoral Registrar, in accordance with The Constitution Act Amendment Acts a form of claim for enrolment.

ENLARGEMENT OF FIRE DISTRICTS.

PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

WHEREAS by the *Fire Brigades Act 1928* it is amongst other things enacted that, on the request of the council of any municipal district outside the metropolitan fire district or any country fire district, and on receiving a certificate from the Metropolitan Fire Brigades Board or the Country Fire Brigades Board (as the case may be) that it is necessary or desirable so to do, the Governor in Council may at any time by Proclamation in the *Government Gazette* declare that any such municipal district or any portion thereof shall be added to and form part of such fire district, and that thereupon such municipal district or portion shall for the purposes of the said Act be included in and become part of such fire district. And whereas the councils of the municipal districts hereinafter mentioned have requested that the portions of such districts set forth be added to and form part of the Fire Districts respectively specified. And whereas certificates have been received from the Country Fire Brigades Board that it is necessary and desirable so to do. Now therefore I, the Governor of the State of Victoria, in the Commonwealth of Australia, by and with the advice of the Executive Council of the said State, and in pursuance of the provisions of section 5 (1) of the *Fire Brigades Act 1928*, do hereby declare that the portions of the Shires of Grenville, Avon, Bet Bet and Donald set forth hereunder shall be added to and form part of the Fire Districts respectively specified accordingly.

CENTRAL FIRE DISTRICT.

DIMINUTION OF FIRE DISTRICTS.

PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

WHEREAS by the *Fire Brigades Act 1928* it is amongst other things enacted that, whenever the Metropolitan Fire Brigades Board or the Country Fire Brigades Board certifies that it is necessary or desirable that any specified portion of the metropolitan fire district or of any country fire district (as the case may be) be excised therefrom, the Governor in Council may by Proclamation in the *Government Gazette* declare that such portion shall be excised accordingly, and that thereupon such specified portion shall for the purposes of the said Act no longer be included in or be part of such metropolitan or country fire district. And whereas the Country Fire Brigades Board has certified that it is necessary and desirable that the portions of the Central, Eastern and North Central Fire Districts set forth hereunder be excised from such Fire Districts. Now therefore I, the Governor of the State of Victoria, in the Commonwealth of Australia, by and with the advice of the Executive Council of the said State, and in pursuance of the provisions of section 5 (2) of the *Fire Brigades Act 1928*, do hereby declare that the portions of the said Central, Eastern and North Central Fire Districts set forth hereunder shall be excised from such Fire Districts, viz.:

Central Fire District.—The Township of Linton.

Eastern Fire District.—That portion of the Shire of Avon which was added to the Eastern Fire District by a Proclamation of the Governor in Council issued on the twentieth day of April, 1932, and published in the *Government Gazette* on the twenty-seventh day of April, 1932.

North Central Fire District.—The townships of Tarnagulla and Watchem.

Given under my Hand and the Seal of the State of Victoria aforesaid, at Melbourne, this twenty-first day of January, in the year of our Lord One thousand nine hundred and thirty-seven, and in the first year of the reign of His Majesty King George VI.
