PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c.

WHEREAS by the Local Government Act 1928 (No. 3720) WHEREAS by the Local Government Act 1928 (No. 3720), section 518, it is amongst other things enacted that it shall be lawful for the Governor in Council at any time, and from time to time, upon the request of the council of any municipality, by notice in the Government Gazette, to declare any land reserved, used, or by purchase or exchange acquired for a street, road, highway, thoroughfare, bridge, square, court, alley, or right-of-way to be a public highway, and that such land shall thereupon and thenceforth from the date of such Proclamation become and be absolutely dedicated to the public as a public highway within the meaning of any law then or thereafter in force: And whereas the Council of the City of Preston has requested that the land hereinafter mentioned, which has been used as a right-of-way by the said Council within the said city, be so declared to be a public highway: Now therefore I, the Governor of the State of Victoria, in the Commonwealth of Australia, by and with the advice of the Executive Council of the said State, do by this Proclamation declare the land used as a right-of-way hereinafter described, and situated within the City of Preston aforesaid, to be a public highway within the meaning of the said Act, viz.:—

PUBLIC HIGHWAY.—CITY OF PRESTON.

All that land shown coloured blue, green, and red on plan marked "A" attached to Correspondence No. L.G.40/947, lodged in the office of the Department of Public Works, being the land comprising a right-of-way between Stott-street and Austral-avenue, Preston.

II. Market, When Open.

- 4. The cattle market, hereinafter referred to as the "market," shall be open for the reception and delivery of cattle for the conducting of special stock sales on every day except Sunday, Christmas Day, Anzac Day, and Good Friday, from sunrise to convert
- 5. The said market shall be open for the sale of cattle on 5. The said market shall be open for the sale of cattle on every Friday from sunrise to sunset, and no cattle shall be received at the said market after the hour of Twelve o'clock noon, except horses and swine, which must be in the market not later than Two o'clock in the afternoon.
