State Coal Mine Industrial Tribunal Act 1932.

AWARD No. 62 OF 1218 NOVEMBER, 1942, RELATING TO RATES OF PAY OF CERTAIN WORKERS AT THE STATE COAL MINE, WONTHAGGI.

THE State Coal Mine Industrial Tribunal, in pursuance of the powers in that behalf conferred by the provisions of the State Coal Mine Industrial Tribunal Act 1932 (No. 4030), and constituted as provided by the said Act and the Order in Council made thereunder, hereby determines and awards as follows: (that is to say): follows (that is to say) :-

- 1. The adult male workers included in Part III. of the Schedule to the Act (except those for whom weekly rates are prescribed) shall be paid a basic wage of 17s. 2d. per day when working on a basis of twelve shifts a fortnight, 18s. 9d. per day when working on a basis of eleven shifts a fortnight, and 20s. 7d. per day when working on a basis of ten shifts a fortnight, and in addition the margins prescribed in the averaging prescribed in the appropriate awards in operation.
- 2. That in lieu of the rates prescribed for workers in the under-mentioned grades in Award No. 61, the following rates shall be substituted viz :-----

#### RAILWAYS CLASSIFICATION BOARD.

AWARD No. 71 OF 9TH NOVEMBER, 1942. RELATING TO CERTAIN CONDITIONS OF EMPLOYMENT.

THE Railways Classification Board, in pursuance of the powers in that behalf conferred by the provisions of the Railways Act 1928 (No. 3759), hereby determines and awards as follows (that is to say):—

1. That Award No. 8 be varied as set out hereunder:-

#### Division 10 .- Holiday Duty.

By deleting the provisions in this division and substituting therefor the following:—

"(1) Subject to clause 2 of this division, any officer or employee, including a casual employee working at a daily rate of pay at the time the holiday occurs, who has had the equivalent of one month's service during the preceding six months, and who is required to work on any of the following public holidays on any week day, viz.:—

New Year's Day Australia Day Labour Day Good Friday Easter Monday Anzac Day King's Birthday Christmas Day, and Boxing Day

or any day substituted for any of these days by agreement between the Commissioners and the officer or employee con-cerned, shall be granted one day's leave of absence with pay in respect thereof.

- (2) This provision shall not apply, in the case of employees who are five (5) shift workers, to a holiday falling on the day on which it is the custom under normal conditions for the employee not to commence duty.
- (3) Any officer or employee who works on a holiday falling on a Sunday, or any employee who is a five (5) shift worker who works on a holiday falling on a week day excluded under clause 2 hereof, shall be paid at the rate of double time for the time worked on such holiday; subject to any such officer or employee being paid for at least one-twelfth of the ordinary hours of duty per fortnight at single rate except in the case of a turn of duty extending into the holiday, either at the commencement or finish thereof, the pay for which amounts to at least such minimum.
- (4) 'Pay for one day's leave of absence' has the following meaning.
  - (i) When it is the custom, at the time the holiday is granted, for the employee to work only on week days and to commence shifts of the same length on the same day in every week—payment for the number of hours normally worked, excluding overtime, on the shift commencing on the day on which the holiday is granted.
  - (ii) When there is no such custom—in the case of five (5) shift workers, payment for one-tenth of the ordinary hours of duty per fortnight, and in other cases payment for one-twelfth of such ordinary hours.
  - (iii) When employees are paid on the basis of seven (7) days per week—payment for one-fourteenth of the ordinary pay for the fortnight, excluding Sunday penalty time.
- (5) 'Week day' means any day other than Sunday."

### Division 14.—Travelling and Incidental Expenses.

(i) By inserting in clause 3. immediately after the figure "4," the figure "9."
(ii) By inserting in sub-clause (a) of clause 9, immediately after the words "commencement of the meal interval," the following:-

"where the period of duty immediately prior amounts to more than four (4) hours."

- (iii) By deleting from sub-clause (a) of clause (9) the definition of "Meal interval" and inserting immediately prior to the definition of "Prior Notice" the following:

  "'Meal interval' shall mean an interval at a time either
  - rostered or recognized by practice allowed with or without pay for the purpose of partaking of a meal or crib, and rostered time shall include a change of such time where prior notice of the change has been given."

#### Division 22.—Shift and/or Night Work.

- (i) By inserting in clause (1), immediately prior to the words "Any officer or employee," the following:—
  - "Subject to clauses (5) and (6) of this division,".
- (ii) By deleting from clause (1) the words "in a grade" and substituting therefor the words—"employed in the work and being paid the rate of a grade."

- (iii) By deleting clause (4) and substituting therefor the following:-
- "(4) The additional allowances prescribed herein shall not be taken into account in the computation of payment for overtime, and shall not apply in respect of a shift on which emergency. Sunday, or holiday rates are payable for more than one (1) hour."
- (iv) By adding the following additional clauses, viz.:-
- "(5) The allowances prescribed in clause (1) hereof shall apply in cases where any officer or employee performs in any shift mixed functions the rate of pay for one of which includes compensation for shift and/or night work and the rate of pay for the other does not.
- (6) Where any officer or employee in any shift performs mixed functions covered by this and some other award and different shift work provisions are applicable. he shall be paid either the appropriate allowance as prescribed in clause (1) hereof or the amount of the shift work allowance payable under the other award or awards concerned—whichever is the higher or highest—but not more than one shift work allowance for the shift.
- (7) For the purposes of clause (1) hereof a broken shift shall be deemed to commence when the first part thereof commences and to have finished when the last part thereof
- 2. The variations referred to herein shall come into operation as on and from the 6th day of July, 1942.
