COMMISSION PASSED UNDER THE ROYAL SIGN MANUAL AND SIGNET, APPOINTING LIEUTENANT-GENERAL THE HONORAULE SIR EDMUND FRANCIS HERRING, K.B.E., D.S.O., M.C., E.D., CHIEF JUSTICE OF THE SUPERME COURT OF THE STATE OF VICTORIA, TO BE LIEUTENANT-GOVERNOE OF THE STATE OF VICTORIA AND ITS DEPENDENCIES, IN THE COMMONWEALTH OF AUSTRALIA. George the Sixth by the Grace of God of Great Britain, Ireland and the British Dominions beyond the Seas, King, Defender of the Faith, Emperor of India: To Our Trusty and Well-beloved the Honorable Sir Edmund Francis Herring, Knight Commander of Our Most Excellent Order of the British Empire, Companion of Our Distinguished Service Order, upon whom has been conferred the Decoration of the Military Cross and the Australian Efficiency Decoration, Lieutenant-General in the Reserve of Officers of Our Australian Military Forces, Chief Justice of the Supreme Court of Our State of Victoria, Greeting:
