## GAS REGULATION ACT 1933.

*At Government House, Melbourne, the  
sixth day of December, 1946.*

## REGULATIONS.

WHEREAS by a Proclamation dated the twenty-ninth day of November, 1946, His Excellency the Governor of the State of Victoria, by and with the advice of the Executive Council thereof, declared that on and after the date of the publication in the *Government Gazette* of such Proclamation the provisions of section 33 of the *Gas Regulation Act 1933* should have effect: And whereas the said Proclamation was published in the *Government Gazette* of the twenty-ninth day of November, 1946: Now therefore His Excellency the Governor of the said State, by and with the advice of the Executive Council thereof and in pursuance of the powers conferred by section 33 of the said Act, doth hereby make the following Regulations (that is to say):—

1. These Regulations may be cited as the "Gas Regulation (Emergency Powers) Regulations (No. 31)," and shall apply to and have operation throughout the area supplied with gas by The Heidelberg City Council Gas Works.

## 2. In these Regulations—

"Gas" means gas supplied by a Gas Undertaker pursuant to the provisions of the *Gas Regulation Act 1933*.

"Gas Undertaker" shall have the same meaning as "Undertaker," as defined by the *Gas Regulation Act 1933*.

3. On and after the publication of these Regulations no person shall use gas during the period commencing at Eight o'clock in the afternoon of Friday, the 6th December, 1946, and ending at Twelve o'clock midnight on Tuesday, the 10th December, 1946, except between the hours hereinafter specified:—

- (a) In the case of Monday, the 9th December, 1946—
- (i) 7 a.m. and 8 a.m.
  - (ii) 5.30 p.m. and 7 p.m.
- (b) In the case of Tuesday, the 10th December, 1946—
- (i) 6.30 a.m. and 8 a.m.
  - (ii) 12 o'clock noon and 1 p.m.
  - (iii) 5.30 p.m. and 7 p.m.

4. It shall be lawful for any inspector or other person upon producing an authority issued to him by the Gas Undertaker referred to in Regulation 1 hereof to enter any premises to which gas is supplied by such Gas Undertaker for the purpose of determining whether the provisions of these Regulations are being observed.

5. No person shall obstruct any such inspector or other authorized person in the course of his duties.

6. The Gas Undertaker shall not, except during the hours specified in Regulation 3 hereof, be required to supply gas in any main or in any pipe, of the pressure prescribed by the *Gas Regulation Act 1933*.

7. Any person who offends against these Regulations shall be liable to a penalty of not more than Fifty pounds (£50) and in the case of a continuing offence a further penalty of not more than Five pounds (£5) for each day on which any offence is continued after conviction or order of any court.

And the Honorable Francis Field, for and on behalf of His Majesty's Chief Secretary for the State of Victoria, shall give the necessary directions herein accordingly.

WHEREAS by a Proclamation dated the twenty-ninth day of November, 1946, His Excellency the Governor of the State of Victoria, by and with the advice of the Executive Council thereof, declared that on and after the date of the publication in the *Government Gazette* of such Proclamation the provisions of section 33 of the *Gas Regulation Act 1933* should have effect: And whereas the said Proclamation was published in the *Government Gazette* of the twenty-ninth day of November, 1946: Now therefore His Excellency the Governor of the said State, by and with the advice of the Executive Council thereof and in pursuance of the powers conferred by section 33 of the said Act, doth hereby make the following Regulations (that is to say):—

1. (1) These Regulations may be cited as the "Gas Regulation (Emergency Powers) Regulations (No. 32)," and shall apply to and have operation throughout the areas supplied with gas

by The Metropolitan Gas Company, The Colonial Gas Association Limited (as to its Box Hill, Footscray, Frankston and Oakleigh Works) and The Brighton Gas Company Limited.

(2) These Regulations shall take effect on the seventh day of December, 1946.

2. In these Regulations—

“Gas” means gas supplied by a Gas Undertaker pursuant to the provisions of the *Gas Regulation Act 1933*.

“Gas Undertaker” shall have the same meaning as “Undertaker,” as defined by the *Gas Regulation Act 1933*.

3. No person shall use gas except between the hours hereinafter specified:—

(a) In the case of Saturday, the 7th December, 1946—

- (i) 6.30 a.m. and 8 a.m.
- (ii) 11 a.m. and 1.30 p.m.
- (iii) 5.30 p.m. and 7 p.m.

(b) In the case of Sunday, the 8th December, 1946—

- (i) 8 a.m. and 1.30 p.m.
- (ii) 6 p.m. and 7 p.m.

4. The restrictions contained in Regulation 3 shall not apply to persons using gas in connexion with the conduct of hospitals, medical services, or institutions rendering relief to the aged or infirm, or to persons using gas for pilot lights or by-pass flames on automatic appliances.

It shall be lawful for any inspector or other person upon producing an authority issued to him by a Gas Undertaker referred to in Regulation 1 hereof to enter any premises to which gas is supplied by such Gas Undertaker for the purpose of determining whether the provisions of these Regulations are being observed.

6. No person shall obstruct any such inspector or other authorized person in the course of his duties.

## Water Acts.

MORNINGTON PENINSULA WATERWORKS DISTRICT.—  
PORTION OF DISTRICT PROCLAIMED AN "URBAN DISTRICT."

## PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

UNDER the powers conferred by the Water Acts and all other powers enabling me in that behalf, I, the Governor of the State of Victoria, with the advice of the Executive Council thereof, do hereby claim that as on and from the date hereof that portion of the Mornington Peninsula Waterworks District included within the boundaries set out and described in the Schedule hereto, shall be and become an "Urban District" for the purpose of the said Acts, and shall be known as Officer Urban District.

## SCHEDULE.

*Boundaries of Officer Urban District.*

Commencing at the north-eastern angle of allotment 15, Parish of Pakenham, County of Mornington; thence southerly by the western boundary of a road to the northern boundary of the Main Gippsland Railway Reserve; thence generally westerly by the last-mentioned boundary to a point in line with the north-western boundary of Wallace-street, on lodged plan of subdivision No. 2963; thence north-easterly by a line and the last-mentioned boundary to the southern boundary of Princes Highway; thence generally easterly by the last-mentioned boundary to a point in line with the eastern boundary of allotment 34; thence northerly by a line and the last-mentioned boundary to a point in line with the northern boundary of lot 1 on lodged plan of subdivision No. 5795; thence easterly by a line and the northern boundaries of lots 1, 2, and 3 to the north-eastern angle of the last-mentioned lot; thence northerly by the western boundaries of lots 7, 8, 9, and 10, and easterly by the northern boundary of said lot 10, all on lodged plan of subdivision No. 5795, to the south-western angle of lot 6 on lodged plan of subdivision No. 10784; thence northerly by the western boundaries of lots 6, 5, 4, 3, 2, and 1, and a line connecting those boundaries to the north-western angle of the last-mentioned lot; thence northerly and easterly by the western and northern boundaries of the land described in certificate of title, volume 6900, folio 1179814, and by a line in continuation of the last-mentioned boundary to the western boundary of allotment 36; thence northerly by the eastern boundary of a road to a point distant 14 chains

7 5/10 links northerly from the south-western angle of said allotment 36; thence by a line bearing south 80 degrees 1 minute east to the eastern boundary of the last-mentioned allotment; thence northerly and easterly by the western and northern boundaries of allotment 37 to the north-eastern angle of that allotment; thence easterly by the northern boundary of a road to a point in line with the eastern boundary of allotment 43; thence southerly by a line and last-mentioned boundary and by a line in continuation thereof to the northern boundary of allotment 15; thence north-easterly by that boundary to the point of commencement.

The boundaries set out and described in the foregoing Schedule are shown on a plan approved by the Governor in Council, and deposited in the office of the State Rivers and Water Supply Commission, Melbourne.

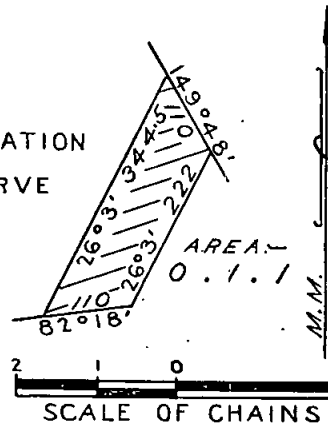
