NOTICE OF REVOCATION OF DECLARATION OF CERTAIN GOODS AS DECLARED GOODS, AND OF A CERTAIN SERVICE AS A DECLARED SERVICE FOR THE PURPOSES OF PART II. OF THE PRICES REGULATION ACT 1948.

- (5) the following items of Miscellaneous Goods, namely— Fuses, detonators, and explosives, Umbrellas; and
- (6) the following items of Household Equipment and Appliances, namely—

Domestic platedware other than cutlery; and

NOTICE OF DECLARATION OF CERTAIN GOODS AS DECLARED GOODS FOR THE PURPOSES OF PART II. OF THE PRICES REGULATION ACT 1948.

In pursuance of the powers conferred upon him by the *Prices Regulation Act* 1948, His Excellency the Governor of Victoria, by and with the advice of the Executive Council thereof, doth hereby declare the following goods to be declared goods for the purposes of Part II. of the said Act, that is to say:—

Egg albumen,
Eggs in shell and egg contents in powder or liquid form whether vested in or in the possession, custody, or control of The Egg and Egg Pulp Marketing Board of Victoria or otherwise.

And the Honorable Trevor Donald Oldham, His Majesty's Attorney-General for the State of Victoria, shall give the necessary directions herein accordingly.

Prices Regulation Acts.

PRICES REGULATION ORDER No. 116.

EGGS IN SHELL

In pursuance of the powers conferred upon me by the Prices Regulation Acts, I, John Francis Waldron, Prices Decontrol Commissioner, hereby make the following Order:—

Citation.

1. This Order may be cited as Prices Regulation Order No. 116.

Revocation.

2. Prices Regulation Order No. 3407, issued under Commonwealth National Security (Prices) Regulations, is hereby revoked.

Definitions.

- 3. In this Order, unless the contrary intention appears—
 - "First Quality" means in relation to eggs in shell-
 - (i) that the shells of such eggs are clean, uncracked and free from stain, and are not thin or misshapen; and
 - (ii) that such eggs when candled are free from blood spots and the yolks are translucent or but faintly visible and the whites are translucent and firm, and the air cells of such eggs are slightly tremulous and not more than 1 inch in depth;
 - "Second Quality" means, in relation to eggs in shell, that such eggs do not conform to the definition of first quality eggs;
 - "First Quality Hen" means,-in relation to eggs in shell comprised in any sale, that such eggs are fowl eggs and are of first quality and not less than 1½ oz. each in weight, with an average weight of not less than 24 oz. to the dozen;

- "First Quality Pullet" means, in relation to eggs in shell comprised in any sale, that such eggs are fowl eggs of first quality, and not less than 1½ oz. each in weight, but less than 1½ oz.;
- "Second Quality Hen" means, in relation to eggs in shell comprised in any sale, that such eggs are fowl eggs and are of second quality, and are not less than 13 oz. each in weight with an average weight of not less than 24 oz. to the dozen;
- "Duck Eggs" means duck eggs which are not cracked.

Sales by Wholesale.

4. I fix and declare the maximum price at which the class, quality or grade of eggs in shell set out in the First Schedule to this Order may be sold by wholesale to be the price specified in that Schedule.

Sales by Retail.

- 5. I fix and declare the maximum price at which eggs in shell may be sold by retail to be the sum of— $\,$
 - (a) the wholesale price as fixed by the First Schedule to this Order:
 - (b) the margin as specified in the Second Schedule to this Order; and
 - (c) cost of transport incurred in conveying the eggs in shell to the retail seller's store.

Provided that no cost of transport may be added under the provisions of this paragraph unless such amount is properly recorded in the retail seller's books of account.

Exhibition of Price List.

6. Every person who sells or offers for sale by retail eggs in shell, the maximum price for the sale of which is fixed by or under the provisions of this Order, shall exhibit in his place of business or if he has more than one place of business, in each of his places of business, particulars of the maximum prices fixed by or under the provisions of this Order for the sale by him of such eggs in shell, in the form of a price list and in such manner as to be easily legible to persons contemplating making any purchase or conducting any business at such place or places of business.

Fixation of Maximum Prices by Notice.

7. Notwithstanding the foregoing provisions of this Order, I declare the maximum price at which eggs in shell may be sold by any person to whom a notice is given in pursuance of this paragraph to be such price as is fixed by the Commissioner by notice in writing to that person.
