GAS REGULATION ACT 1933.

PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

IN pursuance of the powers conferred by the *Gas Regulation Act 1933*, I, the Governor of the State of Victoria, by and with the advice of the Executive Council thereof, do by this my Proclamation revoke the Proclamations which issued on the twenty-first day of June, 1949, and the twenty-eighth day of March, 1950, and were published in the *Government Gazette* of the twenty-first day of June, 1949, and the twenty-eighth day of March, 1950, respectively, and which declared that on and after such dates of publication in the *Government Gazette*, the provisions of section 33 of the *Gas Regulation Act 1933* should have effect.

Given under my Hand and the Seal of the State of Victoria aforesaid, at Melbourne, this eighteenth day of April, in the year of our Lord One thousand nine hundred and fifty, and in the fourteenth year of the reign of His Majesty King George VI.

IN pursuance of the powers conferred upon him by the *Prices Regulation Act 1948*, His Excellency the Governor of Victoria, by and with the advice of the Executive Council thereof, doth hereby make the following Regulations, that is to say:—

Citation and Interpretation.

1. (1) These Regulations may be cited as the Prices Regulations (Victoria) No. 4.

(2) In these Regulations, unless inconsistent with the context or subject matter, "Act" means the *Prices Regulation Act 1948*, as amended from time to time.

2. (1) Without prejudice to any other mode of proof, in any prosecution for an offence against the Act, the mere production of a document bearing on it a certificate purporting to be signed by a person who sent or caused to be delivered to the defendant an order requirement or notice in writing pursuant to the Act and certifying that the document is a copy of the order requirement or notice so sent or delivered and that it was sent or delivered on a date named in the certificate shall be prima facie evidence—

(a) that the document is a true copy of such order requirement or notice and that the original thereof was signed by the person giving the certificate;

(b) that it was sent or delivered to the defendant on the date named in the certificate; and

(c) in the case of an order requirement or notice certified to have been sent by post, that it was received by the defendant on or about the time at which it would be delivered in the ordinary course of post if it had been posted on the date so certified to.

(2) In the immediately preceding sub-clause, "order" or "notice in writing" does not include any order or notice in writing which, under the Act, is required to be published in the *Government Gazette*.

(3) Without prejudice to any other mode of proof, in any prosecution for an offence against the Act for neglecting or failing to furnish any information or return or details of particulars or to produce documents books or papers, the mere production of a certificate in writing purporting to be signed by the person to whom the information return or details or documents books or papers was or were required under the Act to have been furnished or produced and certifying that the information return or details or documents books or papers was not or were not furnished or produced as so required shall be prima facie evidence of the matters certified to.

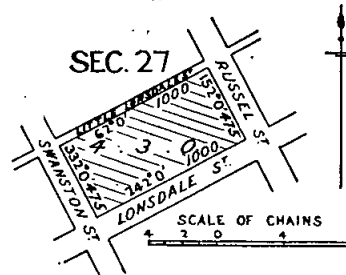

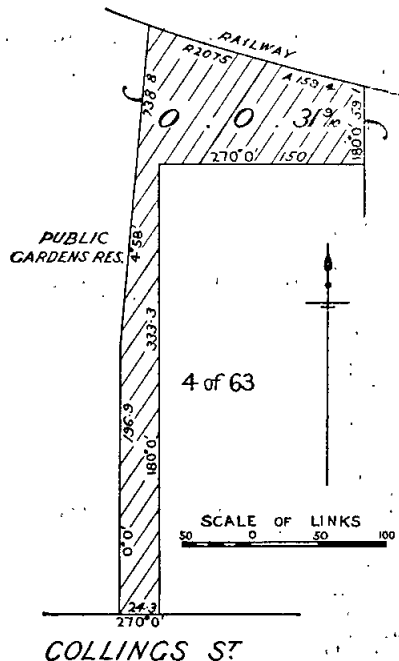

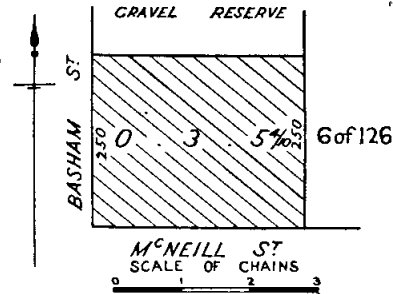

TEACHING SERVICE (CLASSIFICATION, SALARIES, AND ALLOWANCES) REGULATIONS.

THE Teachers Tribunal, in pursuance of the powers conferred by the *Teaching Service Act 1946*, hereby amends the Teaching Service (Classification, Salaries, and Allowances) Regulations made on the nineteenth day of January, 1950, and published in the *Government Gazette* of the third day of February, 1950, in the manner following, that is to say:—

PART IV.—GENERAL PROVISIONS.

Insert a new clause 20A as follows:—

"20A. 7. The supplies coming under the head of Rations and Medical Comforts are to be delivered direct to the establishment entitled thereto on the written order of the officer in charge. All other supplies will be ordered by the head of the Department concerned or any officer authorized by him, and shall be delivered as may be directed by the Officer ordering the supply.

8. At the time of delivering the supplies, the contractor shall produce the order for the same to the officer authorized to accept delivery, and such officer shall acknowledge thereon the receipt of the stores accepted, and shall return the order to the contractor, who shall render his account as soon as possible after the delivery of the supplies, accompanied by the receipted delivery order. The rates or quantities quoted in the orders cannot be exceeded.

9. Where practicable, the contractor shall use the Railways for the transport of the goods. When a contractor is required to make delivery of goods at a railway station for transmission by rail, except for Commonwealth Departments, he shall obtain a receipt for the goods in duplicate on the Stores and Transport consignment note, at the same time handing in the triplicate and quadruplicate of the form as an authority for the Railways to act as agent for, and charge the freight to, the Stores and Transport Office. He shall as soon as possible, and not later than twenty-four hours thereafter, deliver at the Tender Board Offices the original, the duplicate to be forwarded to the consignee and the quintuplicate retained by himself. Should the goods thus forwarded be rejected, the contractor must bear the cost of replacing such goods, for which services the departmental consignment note is not to be used. Any infringement of this condition may subject the contractor to such mulct as the Tender Board may recommend under clause 18 of these conditions.

10. Orders must receive prompt execution; in the event of the goods not being delivered at the time mentioned in the order or within such other time as the officer ordering the supply may specify for delivery, it will be competent for such officer, or the head of the Department to whom the goods are to be supplied, on giving the contractor twenty-four hours' notice, to purchase the supplies, or any like supplies that are suitable for the service, at the contractor's risk, and the extra expense incurred over and above the contract price (if any) will be deducted from the contractor's account or from the security money.

11. The acceptance of the supplies shall be subject to the approval of the officer authorized to take delivery of the stores, or such other officer as shall be named in the conditions.

12. If the officer in charge of stores be not satisfied as to the quantity or quality of the stores, or if, after taking delivery of any stores or material, he shall discover any deficiency or defect therein, he may return such deficient or defective stores or material to the contractor, and shall report the same to the head of his department and to the Tender Board.

13. In the event of a difference of opinion between the contractor and the officer receiving the supplies as to the quality, the same is to be decided, in cases where the article is not of a perishable nature, by a Board of Survey composed of persons named by the Treasurer of the State for the time being; and the decision of the Board is to be considered final. In the event of the decision being against the contractor, the survey fees and expenses (if any) will be deducted as in clause 10.

14. In cases where the article is of a perishable nature, or when from some other cause injury would be sustained either by the person to whom the rations or stores are due or by the contractor in waiting for a Board to survey, the head of the Department or officer authorized to take delivery will have power to reject such article or articles as are obviously of inferior quality, it being understood that he will be responsible to the Government for so doing, and that the contractor must take back the rejected article and supply good in its stead; failing which it, or any like supply suitable for the Service, will be obtained by the officer requiring it as in clause 10. In case of the rejection or return of any supplies, the contractor shall bear the whole cost of replacing the supplies so rejected or returned.

15. If the Board shall decide that the article is not of proper quality it must be immediately replaced by the contractor; failing which it, or any like supply suitable for the Service, will be procured by the officer requiring it, and the expense charged as in clause 10.

16. In the case of supplies for Mental Hospitals, it will be competent for a Board of Survey, consisting of the medical superintendent (or, in his absence, of the medical officer) and any two officers named by him, to examine and reject any supplies that may be objected to. It must be distinctly understood, however, that the contractor will have a right of appeal to the Treasurer of the State for the time being, such appeal to be made in writing within 24 hours of the rejection; but, pending such appeal, he must at once supply others of approved quality; failing which, the supplies required, or any like supplies suitable for the Service, may be obtained by the officer concerned, and the expense charged as in clause 10.

17. In the case of supplies for Mental Hospitals, it will also be competent for two or more of the official visitors, in conjunction with the medical superintendent, to reject any supplies that they may consider not in accordance with contract; and in such cases the reference to a Board of Survey will not be deemed to be necessary.

18. A refusal to execute orders, irregularity in the quantity or quality of the supplies, or delay in delivering or replacing them when required, will subject the contractor, upon report from the Tender Board, to such mulct, not exceeding Fifty pounds, as the said Treasurer may direct, and the amount may be deducted as in clause 10. It will also be in the power of the said Treasurer, upon such refusal, irregularity, or delay, to terminate the contract forthwith, and forfeit the whole or any part of the security money; and, in addition, the contractor will be disqualified from tendering or holding any future contract or contracts for a period of twelve months from the date of such disqualification.

19. Contractors are not at liberty to transfer their contracts under cover of power of attorney, coupled with an interest or otherwise, and no such transfer will be recognized by the Government. *If it is found during the currency of the contract that the contractor has not conformed to the condition of advertisement—which stipulates that if a tenderer be a member of a firm and such firm be interested in the contract, the tender shall be in the name of the firm and not in that of the individual—then the*

Treasurer may, on the recommendation of the Tender Board, determine the contract, and forfeit the security money.

20. It will be competent for the Tender Board to terminate the contract, without notice, should there be reason to know that the contractor takes advantage of his contract to communicate with a prisoner.

21. The contract entered into under these conditions is not to be considered as being broken, infringed, or vitiated by the importation of stores for the Government service, or by any contracts or purchases made by the Imperial Commissariat; or by the consumption of the produce or surplus stock of any Government establishment, or by any article being made at and supplied for the use of any Government establishment.

22. Notwithstanding anything contained to the contrary in section 152 of the *Customs Act 1901-36*, it is hereby expressly provided that upon any alteration of the duty collected affecting the goods included in this contract, the contract price shall not be altered, and the contract may be terminated at the option of either party by two months' notice in writing from the first day of the calendar month next ensuing, and within the period for which the contract is made. The contract for the unaffected items shall remain in full force and effect. Any notice to be served under this condition shall be deemed to have been duly served if sent to the contractor in a registered letter to his last known place of business or abode.

23. Under no circumstances other than those mentioned in clause 22 will a contractor be permitted to abandon his contract. In the event of the contractor failing to carry on the contract, the contract security money will in that case be absolutely forfeited and, in addition, the contractor will be held liable for any loss which the Government may sustain in consequence of such failure.

24. For the purposes of these contracts the word "Government" shall mean the Government of the State of Victoria; and the word "Treasurer" shall mean the Treasurer of the said State.

CITY OF KEW.

BY-LAW NO. 81.

A By-law of the City of Kew, made under the provisions of section 197 of the *Local Government Act 1946*, and numbered 81, for the purpose of prohibiting the leaving (whether unattended or not) of motor cars or other vehicles standing in any street or road or part thereof specified in the By-law, and for requiring the owner or person apparently in control of any motor car or other vehicle left standing (whether unattended or not) in any street or road to give information with respect to any person (other than the said owner or person apparently in control), who is or was the driver of any motor car or vehicle which may lead to the identification of any

person who is leaving or has left such motor car or other vehicle so standing in contravention of this By-law or any other By-laws of the City of Kew.

IN pursuance of the powers conferred by the *Local Government Act 1946* and of every other Act or power enabling them on that behalf, the Mayor, Councillors, and Citizens of the City of Kew order as follows:—

1. This By-law shall come into operation and have effect immediately upon its publication in the *Government Gazette*.

2. This By-law shall apply to and become operative throughout the whole of the municipal district of the City of Kew.

3. By-law No. 79 of the City of Kew, providing for the regulation of motor cars or other vehicles standing in any street in the City of Kew, is hereby repealed.

4. In this By-law, unless inconsistent with the context or subject matter—

“Council” means the Mayor, Councillors, and Citizens of the City of Kew.

“Driver” includes rider of a cycle and person in charge of a vehicle.

“Street” includes every highway, road, carriageway, lane, thoroughfare, or other public place within the City other than a footway.

“Vehicle” includes every conveyance capable of being propelled, pushed, or drawn by human, animal, mechanical, electrical, or other power, and includes a motor car but does not include a tram car.

Singular includes the plural.

5. Between the hours of 2 a.m. and 5 a.m. no driver of a vehicle shall leave such vehicle standing (whether unattended or not) for a period exceeding one hour in any of the streets within the City of Kew which are set out in the Schedule hereto, provided however that this clause shall not apply to the driver of a licensed motor car or hackney carriage while plying for hire on any stand duly fixed or appointed by the Council under any By-law.

6. For the purposes of this By-law the person next driving or taking charge of any vehicle shall until the contrary is proved be deemed to be the driver of such vehicle within the meaning of this By-law.

7. The owner of any vehicle which is left standing (whether unattended or not) in any street or road specified in the Schedule hereto or any person who is apparently in control of such vehicle shall supply, on demand, to any authorized officer of the Council or member of the Police Force any information such officer or member of the Police Force may demand or require with regard to any person (other than the said owner or person apparently in control of such vehicle), who is or was the driver of such vehicle which may lead to the identification of any person who has left such vehicle standing in contravention of this By-law or any other By-law of the City of Kew.

8. Any person who is guilty of any wilful act or default contrary to any of the provisions of this By-law shall be liable, on conviction, to a penalty of not less than 5s. and not more than £5 for each and every offence.
