SOLICITOR-GENERAL ACT 1951.

PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

WHEREAS by an Act of Parliament of the State of Victoria, passed in the sixteenth year of the reign of His Majesty King George VI., intituled the *Solicitor-General Act 1951*, it is amongst other things enacted that

the said Act shall come into operation on a date to be fixed by Proclamation of the Governor in Council published in the *Government Gazette*: Now therefore I, the Governor of the State of Victoria, acting by and with the advice of the Executive Council thereof, do by this my Proclamation fix Wednesday, the nineteenth day of December, One thousand nine hundred and fifty-one, as the day upon which the *Solicitor-General Act 1951* shall come into operation.

Given under my Hand and the Seal of the State of Victoria aforesaid, at Melbourne, this nineteenth day of December, in the year of our Lord One thousand nine hundred and fifty-one, and in the sixteenth year of the reign of His Majesty King George VI.
