SANCTUARY FOR NATIVE GAME IN RESPECT OF AN AREA IN THE PARISH OF PIAMBIE KNOWN AS "MAJOR MITCHELL'S LAGOONS."

PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia,

&c., &c., &c.

I THE Governor of the State of Victoria, in the Commonwealth of Australia, by and with the advice of the Executive Council of the said State, and in pursuance of the provisions of the Game Acts and all other powers me enabling in that behalf, do by this my Proclamation direct that the part of Victoria hereinafter described shall be a locality in which from the first day of January to the thirty-first day of December (both days inclusive) in each year it shall be unlawful for any person to kill or destroy any native game included in the Third Schedule to the Game Act 1928.

PART OF VICTORIA ABOVE REFERRED TO.

All that land having an area of 36 acres 0 roods 15 perches, more or less, in the Parish of Piambie, County of Tatchera, being that portion of the State Forest known as "Major Mitchell's Lagoons," and more particularly described as follows:

Commencing at a point on the left bank of the Murray River; thence by a line bearing 331 deg. 3 min. distant 1,410 links to the eastern side of a Government road abutting on allotment 35B; thence by lines bearing respectively 322 deg. 59 min. 436.4 links, 26 deg. 4 min. 602 links, 39 deg. 357.9 links, 66 deg. 45 min. 429.8 links, 103 deg. 10 min. 410.1 links, and 140 deg. 15 min. 1,354.8 links to a point on the left bank of the Murray River; thence in a general south-westerly direction along the left bank of the Murray River to the point of commencement.

In pursuance of the powers conferred by the Public Service Act 1946, His Excellency the Governor of the State of Victoria, by and with the advice of the Executive Council thereof, doth hereby amend the Public Service (Governor in Council) Regulations in the manner following, that is to say:—

PART IV.—LEAVE OF ABSENCE.—SPECIAL LEAVE FOR WAR PURPOSES.

Sub-regulation (1) of Regulation 50a shall be deleted and the following sub-regulation shall be inserted in lieu thereof:—

"(1) The Minister may grant special leave of absence to any officer or employee who is a member of the Defence Forces for the purpose of attending an annual training camp and not more than two schools, classes or courses of special instruction in each year" and;

After Regulation 50A the following Regulation shall be inserted:—

"Special Leave for War Service in Korea.

- 50B. (1) The Minister may grant special leave of absence to any officer or employee who enlists for war service in Korea.
- (2) Leave of absence granted under this Regulation shall be with full pay for the first fourteen days and without pay there-
- (3) Contributions due to the State Superannuation Fund by the officer during his absence on leave shall be paid by the





By-LAW No. 16.

BY-LAW NO. 16.

IN pursuance of the powers contained in the Health Act 1928 and of any other powers thereunto enabling them in that behalf, the Council of the Shire of Buninyong, in the name and on behalf of the President, Councillors, and Ratepayers of the said shire, for the purpose of carrying the said Act into execution within their jurisdiction, make the following By-law, that is to say:—

1. This By-law shall come into force and operation on its confirmation by the Commission of Public Health and immediately after its publication in the Government Gazette.

2. This By-law shall apply and have operation throughout the following parts of the municipal district, that is to

(1) All that area locally known as the Town of Wallace within the Parish of Warrenheip, County of Grant, bounded by a line commencing at the northwest corner of Crown allotment 3, section 11; thence southerly along the western boundary of this allotment to the south-west corner of the said allotment; thence easterly along the southern boundary of the said allotment to the south-east corner of the said allotment; thence northerly along the eastern boundary of the same allotment to a point opposite the north-west corner of Crown allotment 2a, section 13; thence

across the Government road and in an easterly direction along the northern boundaries of Crown allotments 2a, 2p, 21, 2J, and 2M, to the Western Moorabool River in section 13; thence northerly by this river and the Black Creek to the north-east corner of Crown allotment 1B in the same section; thence westerly by the Western Highway to the point of commencement.

3. The proprietor of every premises not connected with the sewers of a sewerage authority shall provide thereon suitable sanitary conveniences, and where any such proprietor has failed or neglected to provide such conveniences the Council shall by notice, in writing, require the proprietor within a time therein specified to provide conveniences to the number set out in the notice.

4. No person shall erect or construct any pan closet on any premises except in such a position as will admit of the pan being from time to time removed from such closet and from such premises without being carried through any dwelling-house or public building, or through any building or premises in which any person is employed in any manufacture, trade, or business:

Provided that if the Council is satisfied that in respect of any particular premises it is impracticable to conform with the provisions of this Ry-law, the Council may, con-

Provided that if the Council is satisfied that in respect of any particular premises it is impracticable to conform with the provisions of this By-law, the Council may, consistent with the preservation of health, modify such of the requirements as the Council deems fit.

5. The occupier of any premises on which there is a closet or privy shall cause the space under the seat of each closet or privy on such premises to be prepared, and shall permit the same to be used for the double-pan service hereinafter provided for, and shall cause the closet or privy to be kept in a fit state for such service.

6. The occupier or the person having control or management of any premises upon which there is any closet shall when required by the Council alter, reconstruct, or remove any closet and provide a closet which is in accordance with the General Sanitary Regulations 1950.

7. Every new or reconstructed pan closet shall comply with the provisions of the General Sanitary Regulations 1950.

8. Each and every householder shall have provision for 8. Each and every householder shall have provision for not less than one pan; all business and trading premises, hotels and public buildings, factories and shops shall have provision for the number of pans as may be required by the Factories Act 1928 and the Health Act 1928 and Regulations thereto.

9. No occupier or person shall use a closet pan for depositing any house or yard rubbish (except for deodorizing) other than night-soil or shall damage such pans or lids in any manner whatever.

other than night-soil or shall damage such pans or lids in any manner whatever.

10. The Council shall cause every closet or privy to be supplied and kept supplied with two pans for the reception of night-soil and a lid to closely fit the same, and shall cause one or other of such pans to be kept under the seat aforesaid.

aforesaid.

11. The Council at least once a week shall cause the pan in use to be closed with a tight-fitting lid and removed with its contents from the premises and a clean pan in good order to be left in its place.

12. The occupier aforesaid or other person shall not contract for the removal of night-soil from such premises except in accordance with this By-law.

13. The Council shall have power, in lieu of making a rate, to make a charge for the pans supplied and for the proper collection, removal, and disposal of night-soil. Such charges shall be levied on the occupiers or owners in respect proper collection, removal, and disposal of night-soil. Such charges shall be levied on the occupiers or owners in respect of which the services for which the charges are made are rendered and may be recovered by the Council in the same way as general rates are recoverable under the Local Government Act 1946.

14. If any person commit a breach of this By-law he or they shall for every such breach be liable to a penalty not exceeding Twenty pounds, and in the case of a continuing breach a further penalty of not more than Five pounds.

A By-law of the Shire of Buninyong, made under the provisions of section 197 (1) (xxxi) (d) of the Local Government Act 1946, and numbered 17, for authorizing the placing on roads in situations approved by the municipal engineer (subject in the case of State highways, main roads, and tourists' roads to the further approval of the Country Roads Board) of stands or platforms for milk and cream cans, and prescribing the nature and size and regulating the use of such stands and electroms. and platforms.

IN pursuance of the powers conferred by the *Local Government Act* 1946 and every other power it thereunto enabling, the President, Councillors, and Ratepayers of the Shire of Buninyong order as follows:—

- 1. In this By-law, unless the context otherwise requires-

- "Council" means the Council of the Shire of Buninyong.
 "Engineer" means the officer appointed by the Council to carry out the duties of the shire engineer.
 "Stands or platforms" include any existing stand or platform on any road.
 "Formation" means that portion of the road prepared for the use of traffic, and includes the pavement of the road. of the road.
- 2. The Council may authorize the owner or occupier of any property, who is engaged in dairy farming and the production of milk or cream, to erect a stand or platform on any road to facilitate the collection of such milk or cream. No person other than an owner or occupier so authorized shall erect or commence to erect any such stand or platform.
- 3. Every such owner or occupier, prior to the erection of any such stand or platform, shall make written application to the Council for permission to do so, and shall not erect or commence to erect any such stand or platform without the written consent of the engineer, and where the stand or platform is to be erected on any State highway, main road, or tourist road without the further written consent of the Country Roads Board.
- 4. Every such owner or occupier in his application to the Council for permission to erect a stand or platform shall state-
 - (a) his full name, address, and occupation;
 - (b) the materials proposed to be used;
 - (c) the dimensions and height of the proposed stand or platform from the ground;
 - (d) the distance of the proposed stand or platform from the centre of the trafficable portion of the road;
 - (e) the Crown allotment number of his property and the nature of his interest therein;

and his application shall be accompanied by a sketch plan showing the location of the proposed stand or platform with regard to the formation and road boundaries, and the direction and course of travel to be made in collecting milk or cream therefrom.

- 5. Every such owner or occupier who is granted permission to erect a stand or platform shall--
 - (a) erect the same of sound materials approved by the engineer and in a workmanlike manner;
 - (b) keep the same in good and substantial repair;
 - (c) erect the same in such position approved by the engineer as will ensure that when cream or milk is being collected therefrom the collecting vehicle will not obstruct other traffic using the road;
 - (d) construct and maintain at his own expense such gravel or other tracks from the edges of the trafficable portion of the road to the stand or platform as the engineer may order;
 - (e) forthwith remove any stand or platform when ordered so to do by the Council.
- 6. Every owner or occupier in respect of whose property any stand or platform has been erected prior to the coming into operation of this By-law, and without the permission of the Council, shall, within three months from the operation of this By-law, make written application to the Council as provided in clause 4 hereof.
- 7. The Council may, on giving notice in writing to the owner or occupier, order that any stand or platform, whether erected before or after the coming into operation of this By-law, shall be forthwith removed.
- 8. On the refusal, failure, or neglect of any owner or occupier to remove or repair, as the case may be, any stand or platform erected, whether before or after the coming into operation of this By-law, for use in respect of

property owned or occupied by him after fourteen days' properly owned or occupied by him after fourteen days notice in writing from the Council it shall be lawful for the Council by its workmen or agents to remove such stand or platform, and to dispose of the materials thereof as it deems fit, and to reimburse itself from the proceeds of such disposal for all expenses incurred by it in such removal, and disposal removal and disposal.

- 9. Any person who shall be guilty of any wilful act or default contrary to this By-law shall be liable, on conviction, to a penalty of not less than Two nor more than Twenty pounds, and in the case of a second or subsequent offence to a penalty of not less than Five nor more than Twenty pounds, and in the case of a continuing offence shall be liable to a penalty of One pound for each day on which an offence against this By-law is continued after a conviction or order of any court.
- 10. This By-law shall apply to and have operation throughout the whole of the municipal district of the Shire of Buninyong.

 (b) The minimum area, depth, and width of frontage specified in column 5 of Table 803 of the Regulations are hereby adopted as the minimum area, depth, and width of frontage of land on which a building shall be constructed throughout that portion of the municipal district of the said shire set out and described in the Third Schedule hereto. hereto.

Greater Distance from Street Alignment.

- 4. (a) Within that portion of the municipal district of the said shire set out and described in the Second Schedule hereto no person shall construct or cause to be constructed any building of Class I. or Class II. Occupancy closer to the frontage of any site than 20 feet or the average distance from the frontage of their respective sites of the buildings on either side of that building whichever is the greater
- (b) Within that portion of the municipal district of the said shire set out and described in the Third Schedule hereto no person shall construct or cause to be constructed any building of Class I. or Class II. Occupancy closer to the frontage of any site than 25 feet or the average distance from the frontage of their respective sites of the buildings on either side of that building whichever is the greater

Sites Below Minimum Requirements.
