### NOTICE OF VARIATION OF NOTICE OF DECLARATION OF CERTAIN GOODS AS DECLARED GOODS AND OF CERTAIN SERVICES AS DECLARED SERVICES FOR THE PURPOSES OF PART II. OF THE PRICES REGULATION ACT 1948, AND NOTICE OF DECLARATION OF CERTAIN GOODS AS DECLARED GOODS FOR THE PURPOSES OF THE SAID PART II.

IN pursuance of the powers conferred upon him by the *Prices Regulation Act 1948*, His Excellency the Governor of Victoria, by and with the advice of the Executive Council thereof—

1. Doth hereby vary the notice of declaration heretofore made of certain goods as declared goods for the purposes of Part II. of the Act by substituting for the goods set out in the First Column hereunder the goods set out opposite thereto in the Second Column hereunder, and the goods set out in the Second Column are hereby declared to be declared goods for the purposes of the said Part II.:—

#### FIRST COLUMN.

##### *Clothing.*

Diapers.  
Footwear other than bespoke footwear.  
Nursery squares.  
Pilchers.  
Sanitary napkins.  
Shawls.  
Articles made from plastic piecegoods or plastic-coated piecegoods.  
Clothing, garments, and apparel of all kinds and descriptions, but not including the following unless manufactured partly or wholly from wool or from

##### *Clothing.*

Clothing, garments, and apparel of all kinds and descriptions, including clothing, garments, and apparel made from plastic piecegoods and plastic-coated piecegoods, and also including—  
Bathing costumes and trunks.  
Diapers.  
Footwear, other than footwear made for the personal use and to the individual measurements of a customer.

material containing wool, or from plastic piecegoods or plastic-coated piecegoods:—

- (a) Millinery.
- (b) Furs and articles of apparel made from furred skins.
- (c) Bathing caps.
- (d) Garters, armbands, suspenders, belts, and braces.
- (e) Hair nets.
- (f) Men's and boys' headwear other than men's and boys' felt hats.
- (g) Women's, maids', and girls' hosiery other than of wool or containing wool.
- (h) Handkerchiefs, ties, and scarves.
- (i) Men's and boys' knitted sports and chukka shirts.
- (j) Gloves and mittens.
- (k) Laces for boots, shoes, and corsets.
- (l) Foundation garments.
- (m) Ladies' neckwear.
- (n) Female gowns, dresses, or frocks being of ankle length or longer when designed for use as evening, dance, wedding, or cocktail wear.
- (o) Clothing, garments, and apparel made or principally made from alpaca, chenille, mohair, sealette, astrakhan, fabric imitating fur, imitation camelhair cloth, velvet, velveteen, plush, lame, tinsel, or fabric wholly knitted or woven from pure silk.

*Fibres, Yarns, Threads, and Fabrics.*

All fibres, natural or synthetic.

Canvas and duck.

Elastic.

Fabrics of all kinds, whether knitted, lockstitched, or woven including water-proofed or rubberized fabrics, and including piecegoods of all types and descriptions.

Felts of wool or hair.

Mens' and boys' felt hats.

Nursery squares.

And also including the following if manufactured partly or wholly from wool, or from materials containing wool, viz.:—

- (iii) gloves and mittens; but not including—
  - (a) foundation garments,
  - (b) furs and articles of apparel made from furred skins,
  - (c) garters, armbands, suspenders, belts, and braces,
  - (d) hairnets,
  - (e) handkerchiefs,
  - (f) laces for boots, shoes, and corsets,
  - (g) millinery and headwear other than men's and boys' felt hats,
  - (h) clothing, garments, and apparel manufactured or substantially manufactured from broderie anglais and/or allover lace.

*Fibres, Yarns, Threads, and Fabrics.*

Canvas and duck.

Carpet fabric.

Cotton, artificial silk, and silk threads manufactured for domestic and manufacturing purposes, but not including cotton, artificial silk, and silk threads manufactured for the purpose of hand crocheting, knitting, and embroidery.

Elastic.

Fabrics and piecegoods of all kinds, whether knitted, lockstitched, or woven, including

Furniture of all kinds and descriptions other than furniture made solely from wicker or cane.

Counterpanes and quilts.

Feltex.

Floor coverings impregnated with bitumen, tar, or emulsion.

Linoleum and other similar floor coverings, except of rubber.

Mats and matting of coir or jute.

Mattresses.

Pillows, other than air-filled, pillow cases, bolsters, and bolster cases.

Sheets.

Table cloths.

Towels and tea towels.

Underfelts and felt base.

*Metals.*

Pig iron.

Ingots, blooms, slabs, and billets.

Iron and steel materials for tram and railway lines, including rails, fish plates, tie plates and rods, switches, points, crossings and intersections, and fishbolts.

2. Doth hereby vary the notice of declaration heretofore made of certain services as declared services for the purposes of Part II. of the Act by substituting for the services set out in the First Column hereunder the services set out opposite thereto in the Second Column hereunder, and the services set out in the Second Column are hereby declared to be declared services for the purposes of the said Part II.:—

## FIRST COLUMN.

The dry cleaning and laundering of piecegoods, furnishings, or garments.

The manufacture of clothing, manchester, furnishings, bedding, yarns, fabrics, textiles, and articles from timber.

Services carried on by other than public bodies for the operation of communications, transport, refrigeration, or the supply of steam and water.

## SECOND COLUMN.

The dry cleaning, pressing, and laundering of piecegoods, furnishings, or garments.

The manufacture or partial manufacture of clothing, footwear, manchester, furnishings, bedding, yarns, fabrics, textiles, and articles from timber.

The transportation of persons by road carried on by any person or body other than a governmental semi-governmental or local governing authority.

3. Doth hereby declare the following goods to be declared goods for the purposes of the said Part II.:—

*Hides, Leather, and Rubber.*

## Latex.

Rubber soling and heeling materials in any form, including "Kromhyd," "Tufhide," and similar materials and substitutes therefor, including "Neolite."

*Timber, Bricks, and other Building Materials.*

## Metal ceiling sheets.

The headings appearing in this Order as to facilitate reference to the goods which are the subject of this notice and shall not be read or construed as limiting or defining the scope of any of the items under the headings or of the goods included in such items.

And the Honorable Herbert John Thornhill Hyland, His Majesty's Minister in Charge of Prices for the State of Victoria, shall give the necessary directions herein accordingly.
