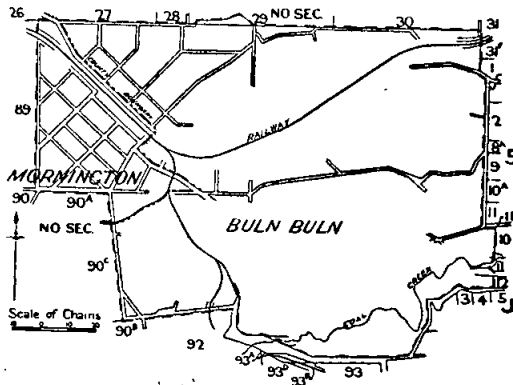

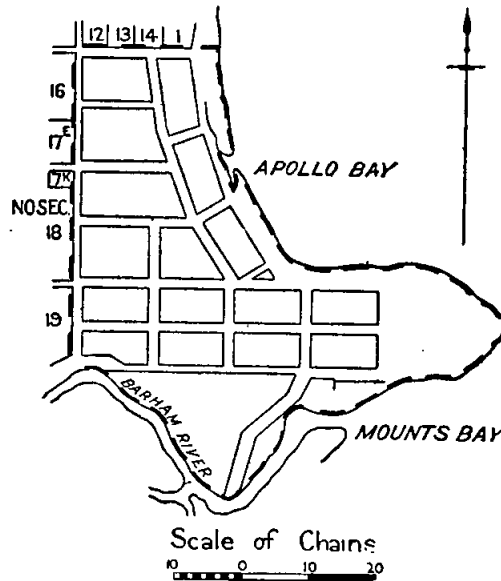

## NURSES AND MIDWIVES ACT 1928 (No. 3734).

**I**N pursuance of the powers conferred by the *Midwives Act 1928*, the Nurses Board of Victoria doth hereby amend the Midwives Regulations 1951, in the manner following, that is to say:—

1. These Regulations may be cited as the Midwives Regulations 1952, and shall be read and construed as one with the Midwives Regulations 1951, as amended by other Midwives Regulations.

2. After Regulation 21 of the Midwives Regulations 1951, there shall be inserted the Regulation following:—

“21A. (1) Notwithstanding anything in these regulations, upon the application of the Manager of a Training School the Board may in respect of any pupil midwife who has commenced her period of training before the coming into operation of these Regulations—

(a) reduce her period of training to that required under the Midwives Regulations 1941;

(b) authorize her to undergo the course of training prescribed under the Midwives Regulations 1941; and

(c) authorize her to sit for an examination the scope of which is set out in clause 13 of the Midwives Regulations 1941.

(2) If the Board approves of any such application, the period of training, course of training and examination referred to in sub-clause (1) hereof shall as regards the pupil midwife in respect of whom the application is made be deemed to be the period of training, course of training and examination respectively referred to elsewhere in these Regulations.”

## GENERAL NOTICE.

AGREEMENT BETWEEN THEIR EXCELLENCIES  
THE GOVERNORS OF VICTORIA AND TASMANIA  
FOR THE PURPOSE OF MAKING THE FACILITIES  
OF THE VICTORIAN CANCER INSTITUTE AVAIL-  
ABLE TO RESIDENTS OF TASMANIA.

**T**HIS Agreement made the thirtieth day of January One thousand nine hundred and fifty-two between His Excellency General Sir Reginald Alexander Dallas Brooks Knight Commander of the Most Honorable Order of the Bath Companion of the Most Distinguished Order of Saint Michael and Saint George and Companion of the Distinguished Service Order Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia of the one part and His Excellency The Right Honorable Sir Ronald Hibbert Cross Baronet Governor in and over the State of Tasmania and its Dependencies in the said Commonwealth of the other part witnesseth that in pursuance of section 26 of the *Cancer Institute Act* 1948 of the State of Victoria and of every other power them thereunto enabling the parties hereto hereby agree as follows:—

1. In this Agreement unless inconsistent with the context or subject matter—

“Act” means the *Cancer Institute Act* 1948 aforesaid.

“Board” means the Cancer Institute Board incorporated under the Act.

“Date of commencement” means the date specified in clause 2 hereof.

“Institute” means the Cancer Institute established under the Act.

“Treasurer” means the Treasurer of the State of Victoria.

2. This Agreement shall come into operation on the sixteenth day of January One thousand nine hundred and fifty-two.

3. The Board shall during the continuance of this Agreement make available to residents of Tasmania the facilities of the Institute.

4. (1) Upon the date of commencement the property in all deep therapy X-ray equipment and associated equipment in public hospitals in Tasmania shall vest in the Board and thereafter the Board shall maintain and if necessary replace that equipment which shall not be removed from Tasmania without the consent of the Governor of the State of Tasmania.

(2) No additional equipment (except that required to replace unserviceable equipment) shall be installed by the Board in Tasmania without the prior approval of the Governor of the State of Tasmania nor shall it be removed from Tasmania without his consent.

(3) Upon the termination of this Agreement the property in all equipment of the Board situate in Tasmania shall vest in the State of Tasmania.

5. (1) Upon the date of commencement all medical and technical members of staffs employed in Tasmanian public hospitals in the care and treatment by radiation of patients affected by cancer or allied conditions shall be transferred to the staff of the Board upon not less favourable terms of employment than those existing on the said date.

(2) The State of Tasmania shall provide all staff (other than medical and technical staff) required in Tasmania for the work of the institute and the keeping of its medical records and which shall in the performance of duties associated with that work be subject solely to the direction of the Senior Officer of the Board present in Tasmania.

(3) (a) The Board shall if possible provide for full-time service in Tasmania a medical officer trained in the treatment by radiation of cancer and allied conditions together with such technicians as are required for the operation of its equipment installed in Tasmania.

(b) If the Board is unable to provide a medical officer as aforesaid it shall arrange regular and adequate visits to Tasmania by the Assistant Medical Director of the institute or a medical officer of similar professional status and by such other medical officers as from time to time are deemed necessary by the Board.

(c) In the event mentioned in the last preceding paragraph the State of Tasmania shall provide a suitable medical officer to supervise the care and treatment of patients of the institute in Tasmania during such time as a medical officer of the institute is not available.

6. (1) Whenever medical officers of the Board deem it necessary patients in Tasmania may be sent to the institute at Melbourne for any treatment not available in Tasmania.

(2) The State of Tasmania shall pay the Treasurer as hereinafter provided at a daily bed cost rate for the maintenance of patients so sent to the institute at Melbourne.

(3) The expression “daily bed cost rate” in the last preceding sub-clause means the average daily cost of maintenance of a bed in the institute together with a just proportion of the annual amortisation allowance which the Treasurer deems necessary to recoup the State of Victoria over a period of fifty-three years for the capital cost (with interest thereon at the appropriate rate payable by the State of Victoria to the Commonwealth of Australia) of establishing and equipping the buildings of the institute situate at 483 Little Lonsdale-street, Melbourne.

7. The State of Tasmania shall be required to contribute to the cost of research undertaken by the institute only to the extent agreed upon by the parties hereto.

8. The State of Tasmania shall not save as provided herein be required to make any contribution towards the cost of establishing and equipping the said buildings but shall pay to the Treasurer as aforesaid the costs of—

(a) maintaining and replacing the equipment described in sub-clause (1) of clause 4 hereof;

(b) installing in Tasmania additional equipment the provision of which the Governor of the State of Tasmania has approved;

(c) salaries allowances and travelling expenses of members of the staff of the Board while employed in or in transit to or from Tasmania; and

(d) treating patients sent from Tasmania to the institute at Melbourne as provided in clause 6 hereof (including daily bed cost rate ambulance charges and travelling expenses in respect of patients and the cost of supplying to them special preparations or drugs not usually provided without charge).

9. (1) The Board shall keep separate records of expenditure in respect of Tasmanian patients and the Auditor-General of Victoria shall submit to the State of Tasmania in respect of each financial year a certificate specifying the amount of costs payable by that State pursuant to this Agreement.

(2) Prior to the commencement of a financial year the Treasurer shall estimate the amount of costs so payable during that financial year and the State of Tasmania shall pay to the Treasurer the amount so estimated by equal instalments at the end of each quarter of the said year.

(3) Upon submission of a certificate as aforesaid the amount so paid shall if necessary be adjusted.

10. This Agreement shall be subject to amendment variation or termination as provided in section 26 of the Act.

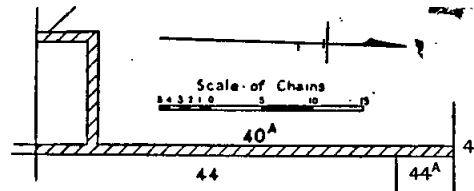

REGULATIONS.

**P**URSUANT to the powers conferred by section 22 of the *Building Operations and Building Materials Control Act 1946* (No. 5116), His Excellency the Governor of the State of Victoria, by and with the advice of the Executive Council thereof, hereby makes the following Regulations (that is to say):—

1. These Regulations may be cited as the "Building Operations and Building Materials Control Regulations 1952," and shall come into operation on the date of the publication thereof in the *Government Gazette*. These Regulations shall be divided into Parts I. and II.
2. "Authorized Officer" means a member of the staff of the Materials Procurement Directorate authorized in writing by the Minister for the purpose of these Regulations.

PART I.

3. The Minister may, from time to time by notice published in the *Government Gazette*, declare that the provisions of Part II. of these Regulations shall apply in respect of any building material specified in such notice, whereupon the provisions of the said Part shall apply in respect of such building material.

4. The Minister may, from time to time by notice published in the *Government Gazette*, declare that the provisions of Part II. of these Regulations shall cease to apply in respect of any building material specified in such notice, whereupon the provisions of Part II. shall cease to apply to such building material unless and until the Minister makes, pursuant to clause 3 hereof, a further declaration in respect of such building material.

PART II.

5. Any person desiring to obtain building materials shall make—
  - (1) application for such materials in the form of the Schedule hereto, and shall sign such application in the presence of a witness who shall sign as witness and insert his address.

- (2) Such application shall be transmitted to a manufacturer or wholesale seller of such building materials and shall bear the signature of all intermediate resellers of such building materials.
- (3) Upon receipt of such application, signed as aforesaid, the manufacturer or wholesale seller of such building materials shall transmit it to the Materials Procurement Directorate for the allocation of priority to the application.

6. An authorized officer shall endorse on the application its priority, sign and date such endorsement, and cause it to be returned to the manufacturer or wholesale seller by whom it was transmitted to the Materials Procurement Directorate.

7. A manufacturer or wholesale seller shall group all applications according to the priority endorsed thereon, and shall supply building materials in each group according to date thereof so that the application bearing the earlier endorsement is fulfilled before that bearing the later endorsement, provided that on the written direction of an authorized officer, such manufacturer or wholesale seller shall supply building materials in accordance with such direction. The percentage of building materials to be supplied to each group shall be determined by the Minister from time to time according to prevailing circumstances, and notification of such determination shall be given in writing to the manufacturer or wholesale seller by the Minister or the Director of Materials Procurement Directorate.

8. A reseller who receives any such building materials shall not, without the written authority of an authorized officer, supply such building materials to any person other than the applicant in respect of whose application such building materials have been received by the reseller.

9. No person shall supply any building materials otherwise than in accordance with the foregoing Regulations.

10. No person shall make an untrue statement in any application for building materials.

11. No person shall, without the written authority of an authorized officer, use any building materials otherwise than for the purpose and for the job specified in the application pursuant to which such building materials were supplied.

12. No person shall make a further application for the supply of any building materials in respect of any building operation unless his prior application (a) has been granted and the quantities have proved insufficient, (b) has been refused, or (c) has been cancelled.

13. Every manufacturer and every wholesale seller of building materials—

- (1) shall keep a register and record therein, as soon as possible, the following particulars:—
  - (a) The quantities of building materials received by him and the date of receipt;
  - (b) (in the case of a manufacturer) the quantities of the various building materials manufactured from any other building material and the date of manufacture;
  - (c) particulars of the distribution of such building materials including the quantity supplied to each customer.
- (2) Upon the demand of an authorized officer such manufacturer or wholesale seller shall produce such register for his inspection,
- (3) Every such manufacturer at the written request of the Minister or an authorized officer shall, within fifteen days after the last day of each month, cause to be received by the Director of Materials Procurement Directorate a copy of the entries in the register for such month.

14. Every reseller shall keep a register and shall, as soon as possible, record therein the following particulars:—

- (a) The name and address of every person making application to him in the form of the schedule hereto for the supply of any building material.
- (b) The quantities, sizes, gauges and classes of building materials for which each application is made, and the purpose for which same is required.
- (c) The date upon which he received such application.



- (d) The name of the manufacturer or wholesale seller to whom he transmits such application and the date of such transmission.
- (e) The date upon which he supplies the building materials to the applicant.

15. Every manufacturer and wholesale seller of building materials shall, on or before the date of delivery of any building materials to a reseller, give to such reseller a statement in writing of the name and address of the applicant to whom the building material has been allocated.

16. No person, other than the applicant or an authorized officer at the request of the applicant, shall make any alteration to any application, and if any alteration is made by the applicant, he shall initial such alteration.

17. Any person who fails to comply with, or does anything forbidden by these Regulations, shall be liable to a penalty of not more than One hundred pounds.

## AMENDMENT No. 1.

PURSUANT to the provisions of section 14 of the *Hospitals and Charities Act 1948* (No. 5300), His Excellency the Governor of the State of Victoria, by and with the advice of the Executive Council of the said State, hereby amends the *Hospitals and Charities Commission Staff Orders, 1951*, in the manner following, that is to say—

For Order No. 4 there shall be substituted the following Order:—

"4. *Long-Service Leave*—

(1) Every officer of the Commission who has served for twenty years shall be entitled to be granted by the Commission six months long-service leave with pay in respect of that period of twenty years service and one and a half months long-service leave with pay in respect of each additional period of five years completed service.

## (2) Where—

(a) an officer retires on account of age or ill health or dies; or

(b) the appointment of a female officer is terminated on account of or in anticipation of marriage—

that officer shall be entitled, or (in the case of death) shall be deemed to have been entitled, to be granted by the Commission—

where the completed years of service are not less than five but are less than twenty, then in respect of such completed years of service;

where the years of service are more than twenty, then (in addition to any entitlement under clause (1) of this Order) in respect of such completed years of service (not exceeding four) as exceed the next lower multiple of five—

long-service leave with pay on the basis of one-twentieth of six months leave for each such completed year.

(3) The Commission shall have discretion as to the time of granting any leave under this Order.

(4) Where on account of age or ill health an officer retires that officer may by notice in writing to the Commission elect to take pay in lieu of the whole or any part of any such leave to which he is then entitled and the Commission shall grant him pay in lieu thereof accordingly.

(5) Where the appointment of any female officer is terminated on account of or in anticipation of marriage, she may by notice in writing to the Commission elect to take pay in lieu of the whole or any part of such leave and the Commission on her marriage or in such other special circumstances as the Commission in its discretion determines shall grant her pay in lieu thereof accordingly.

(6) Where an officer entitled to any such leave or to pay in lieu thereof dies before or while taking such leave or (as the case may be) before such pay in lieu is paid the Commission shall to the extent that pay in lieu thereof has not already been paid to that officer grant pay in lieu of the whole or part of the leave not taken or (as the case may be) grant the pay in lieu to the legal representative of the deceased officer."

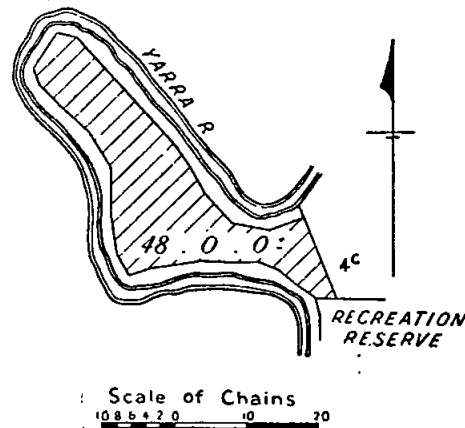

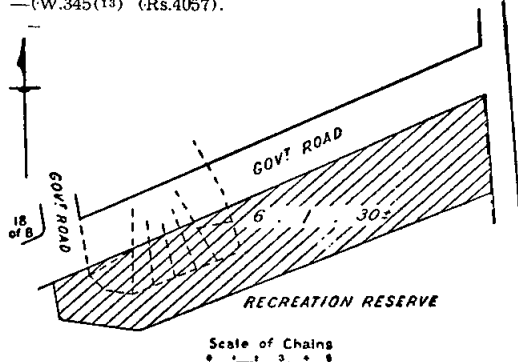

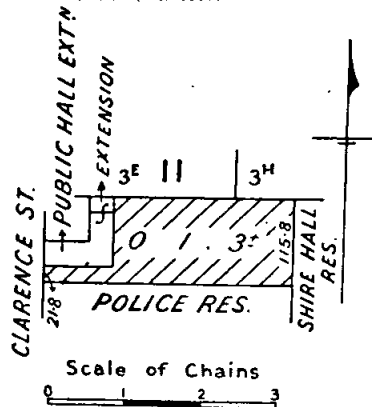

- (a) not being the holder of a current permit issued by the Council hereunder; or
- (b) otherwise than at the times and places, and in accordance with the conditions set out in such permit shall sell any goods from any stall, motor car, cart, truck, barrow, box, basket, crate, tray, or other vehicle or receptacle standing or placed on any street, road, or public place within the areas set forth in the First Schedule hereto.

3. Any person may lodge with the Town Clerk an application to sell goods as aforesaid in the form and containing the particulars provided for in the form set out in the Second Schedule hereto. Such application shall be signed by the applicant and the certificate at the foot thereof shall be signed by at least five ratepayers of the City of Essendon.

4. The Council may in its discretion issue to any such applicant a permit in the form or to the effect set out in the Third Schedule hereto, and may cause to be endorsed on any such permit such conditions as in each particular case it may think fit.

5. No such permit shall be for a period of more than twelve months from the date of its issue, and shall be personal to the applicant, and shall not be transferable.

6. Any such permit may be revoked by the Council at any time and shall thereafter cease to have any force or effect.

7. No street hawker or itinerant trader dealing in goods shall use any street, road, or public place within the municipal district between the hours of 5 p.m. on one day and 8.30 a.m. on the succeeding day.

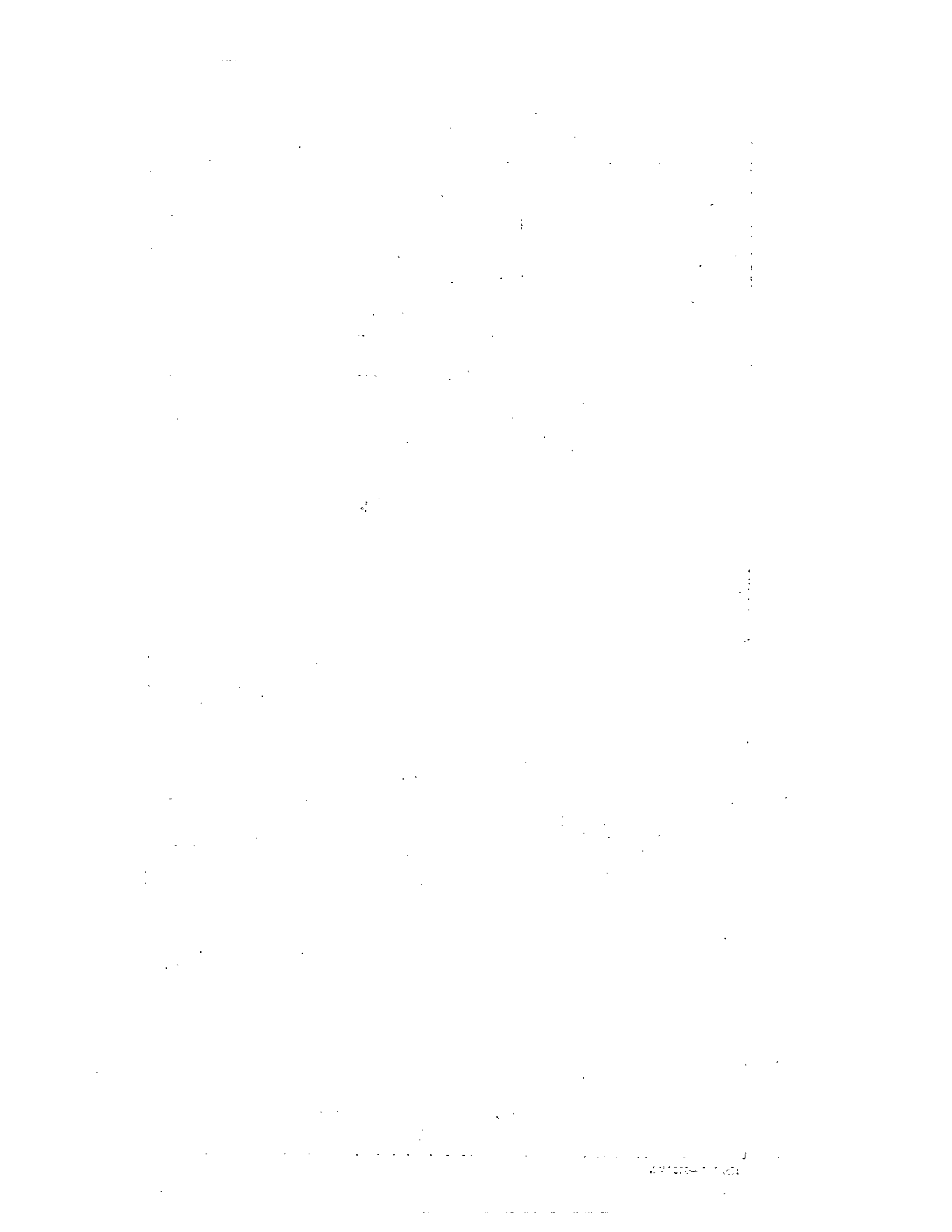
