Prices Regulation Acts.

PRICES REGULATION ORDER No. 377.

CHOCOLATES AND CONFECTIONERY—EASTER EGGS—RETAIL PRICES.

IN pursuance of the powers conferred upon me by the Prices Regulation Acts, I, John Francis Waldron, Prices Commissioner, hereby make the following Order:—

Citation.

1. This Order may be cited as Prices Regulation Order No. 377.

Maximum Prices-Sales by Retail.

2. I fix and declare the maximum price at which chocolates and confectionery of any of the types, weights, or descriptions specified in the Schedule to this Order may be sold by retail to be the price specified in that Schedule for that type, weight, or description.

Exhibition of Price Tickets.

3. Every person who sells or offers for sale by retail any chocolates and confectionery the maximum price of which is fixed by or under the provisions of this Order, shall attach to or display with those goods a ticket or label setting forth that maximum selling price; such ticket or label shall be in such form as to be easily legible to any person inspecting or viewing the goods, and as to be properly associated with such goods.

Fixation of Maximum Prices by Notice.

4. Notwithstanding the foregoing provisions of this Order, I declare the maximum price at which any chocolates or confectionery, a maximum price for the sale of which is fixed by the foregoing provisions of this Order and which is specified in a notice given in

pursuance of this clause, may be sold by any person to whom such notice is given to be such price as is fixed by the Commissioner by Notice in Writing to that person.
