AMENDMENT OF THE SIXTH SCHEDULE TO POISONS
ACT 1928 (No. 3748), AS AMENDED BY ACT No. 3918.

PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

BY virtue of the powers conferred by section 38 of the *Poisons Act 1928* (No. 3748) as amended by section 5 of Act No. 3918, I, the Governor of the State of Victoria, by and with the advice of the Executive Council of the said State and on the recommendation of the Pharmacy Board of Victoria do by this my Proclamation add the names of the following substances and preparations to paragraph (2) of the Sixth Schedule to the *Poisons Act 1928* as amended by Act No. 3918, namely:—

Curarising and Ganglionic paralyzing substances which are quaternary ammonium compounds, such as—

Curare, curara, tubocurarine, d-tubocurarine chloride, pentamethonium compounds, hexamethonium compounds, decamethonium compounds, gallamine triethiodide, C⁶, C⁸, C¹⁰, tetraethyl ammonium compounds; their salts, derivatives, preparations and admixtures by whatever name such substances are described, and for whatever therapeutic use they are intended,

and declare that Division 2 of Part III. of the *Poisons Act 1928*, as amended by Act No. 3918 shall apply to the substances and preparations named in the same manner as it applies to the substances and preparations included in the said paragraph (2) and the provisions of the said Division shall apply accordingly.

Selenium and all preparations and admixtures thereof—

to the first part of the Second Schedule of the *Poisons Act 1928*.

A MEAT AREA.

PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

BY virtue of the powers conferred by the Health Acts, I, the Governor of the State of Victoria, in the Commonwealth of Australia, on the recommendation of the Commission of Public Health, and by and with the advice of the Executive Council of the said State, do by this my Proclamation amend the Proclamation dated the seventh day of September, 1948, constituting the Kyneton Meat Area by deleting therefrom the expression:—

“This Proclamation shall take effect on the first day of January, 1964.”

and substituting therefor the expression:—

“This Proclamation shall take effect on the 1st day of July, 1954.”

BY-LAW No. 60.

Standing Orders.

THE Melbourne and Metropolitan Board of Works (hereinafter called “the Board”), pursuant to and in exercise of the powers and authorities conferred on it by the Melbourne and Metropolitan Board of Works Acts and in exercise of every other power in this behalf enabling, doth hereby make the By-law and Regulations following:—

1. On, from and after the first day of March, One thousand nine hundred and fifty-four, By-law No. 17 of the By-laws and Regulations of the Board, as amended by By-laws Nos. 18, 21, 36, 39, 40, 44, and 49 (such By-law as so amended being hereinafter referred to as “the said By-law”), shall be further amended as hereinafter provided.

2. Clause 64 of the said By-law shall be repealed.

3. In substitution for the said clause 64 so repealed there shall be inserted in the said By-law the following clause:—

“64. In addition to the Officers and Servants' Committee required to be appointed pursuant to section 46 of the Act, there shall be six permanent Committees to be respectively called “Finance,” “Water Supply,” “Sewerage,” “Legislative,” “Farm,” and “Stores” Committees. The Water Supply, Sewerage, Finance, and Officers and Servants' Committees shall each consist of ten members, the Farm Committee of nine members, the Legislative Committee of seven members, and the Stores Committee shall consist of the Vice-Chairmen from time to time of the Officers and Servants', Finance, Water Supply, Sewerage, Legislative, and Farm Committees, and the quorum for such Committees shall be as follows, namely, for the Finance, Water Supply, Sewerage, and Farm Committees, five members, for the Officers and Servants', Legislative, and Stores Committees, three members.”

The foregoing By-law and Regulation was made and passed by the Melbourne and Metropolitan Board of Works on the twenty-sixth day of January, One thousand nine hundred and fifty-four, and the common seal of the said Board was affixed hereto in the presence of—

(2) BASS STRAIT—CURRENT STUDIES.

Shipmasters, fishermen, and others concerned are warned that ocean current studies will be carried out from about 28th January, 1954, without further notice, for a period of approximately twelve months, off the coast between Cape Schanck and Point Nepean.

It is anticipated that the floats will be released on each of approximately 40 occasions from a line running seaward from position 38 deg. 26 min. 30 sec. South, 144 deg. 50 min. 40 sec. East from a ½ to 2 miles off shore.

The floats consist of a 15-ft. tubular mast surmounted by two radar reflectors and a yellow buoyancy chamber bearing the letters “M.M.B.W.” in black. A device has been incorporated in the design of the float which will cause the mast to collapse approximately 60 hours after its release, thus destroying its radar reflecting properties.

BENAMBRA AND OMEO PUBLIC CEMETERIES.

IN pursuance of the powers vested in them under the Cemeteries Acts, the Trustees of the Benambra and Omeo Public Cemeteries hereby rescind the Rules and Regulations previously published in the *Government Gazette*, and substitute the following:—

RULES AND REGULATIONS.

1. No interment shall be permitted until an application has been made, the particulars supplied in form Schedule A, an order obtained, and a certificate from the Registrar of Deaths, the Coroner, or Justice of the Peace, has been delivered to the Secretary.

2. The application for interment must be given to the Secretary before Twelve o'clock noon on the day previous to the interment where a morning interment is required, and before Two p.m. on the day previous to the interment where an afternoon interment is required.

3. On application for interment all such fees and charges as may be from time to time fixed by the Trustees shall be paid to the Secretary.

4. The time fixed for any burial shall be the time of arrival at the cemetery, and such time shall be punctually observed.

5. The usual hours of interment shall be between Ten a.m. and half-past Four p.m. from Monday to Friday, and half-past Nine a.m. and Twelve noon on Saturday, but

burials may be permitted outside of these hours on payment of the prescribed fees with the consent of the Chairman or Secretary.

6. The Trustees will cause all ordinary graves to be dug, but when a brick grave or vault is required or any alteration made thereto, it must be constructed under the direction of the Trustees or some person appointed by them. In case interment is to be made in any private grave or vault belonging to another person the burial right must accompany the application.

7. Every coffin placed in a vault or brick grave shall be bricked in, cemented, and made airtight.

8. No adult shall be buried within 4 feet nor child under the age of twelve years within 3 feet of the ordinary surface level, and a layer of earth at least 6-in. thick shall be left undisturbed above and around any coffin previously buried in the same grave.

9. A certificate of ground for a burial place within the cemetery may be granted by the Secretary in the form and to the effect set out in Schedule B, on payment of fees prescribed.

10. No re-interment or removal from another cemetery or another grave will be permitted until there be submitted a certified copy of the original certificate of the Registrar of Deaths, the Coroner, or Justice of the Peace, and of the licence for disinterment from the Minister of the Crown authorized in that behalf.

11. Before any person commences the erection of any tablet, headstone, monument, tomb, vault, fence, railing, or enclosure the permission of the Trustees must be obtained, also payment made of fees set out in the scale of charges. Persons desiring to make such erections are required to submit designs, drawings, or descriptions, proposed location, also a copy of the proposed inscription or epitaph, and such information as the Trustees may require. The Trustees may withhold permission and prevent the proposed erection of anything which may appear to them as unappropriate, unbefitting, or not sufficiently durable.

12. Every grave, vault, tomb, monument, tombstone, headstone, cenotaph, wall, fence, or other erection shall be maintained in thorough repair and proper condition by and at the expense of the owner or owners. Where any monument, tombstone, headstone, cenotaph, wall, fence, or other erection is allowed to fall into a state of disrepair and the owners fail to carry out repairs to the satisfaction of the Trustees within seven days after the serving of written notice so to do by the Trustees to the last-registered address of the owners, the Trustees may remove such monument, tombstone, headstone, cenotaph, wall, fence, or other erection at the expense of the owner or owners.

13. All materials required in the completion of any stone or other work shall be fully prepared before being taken into the cemetery, and the Trustees may refuse to allow any vehicle conveying such material to enter the cemetery during wet or unfavourable weather. Stones, refuse, and rubbish or other materials remaining after the work is completed shall be removed at once by the persons employed on the work, and in the event of any such refuse or other material not being removed within seven days after completion of the work the Trustees may have same removed at the expense of the owner or owners or the persons or firm carrying out such work.

14. No person being the owner of the exclusive right of burial of a grave shall transfer such right without the consent of the Trustees, and no transfer shall be consented to by the Trustees except a transfer to a near relative of the owner, or a transfer to the Trustees.

15. A plan of the cemetery and register will be kept and may be inspected at the Shire Office, Omeo.

16. Any person wantonly or wilfully destroying or causing to be done any damage to any monument, tombstone, or vault, building, erection, railing, fence, shrubbery, tree, or plant in the cemetery is guilty of a misdemeanour, and on being convicted thereof is liable to the penalties provided by the Cemeteries Act.

17. No dogs will be allowed in the cemetery.

18. The cemetery will be open to the public from sunrise to sunset.

19. These Rules and Regulations may be altered or amended and additions made thereto from time to time by the Trustees, with the consent of the Governor in Council, in accordance with the provisions of the Cemeteries Acts.

6. The charge for the water supplied by measure shall be payable, on demand, at the office of the Trust.

7. Public Institutions and others.—Water supplied to the Government Departments, charitable or other institutions,

and religious denominations, shall be by measure at One shilling and three pence per 1,000 gallons, or by special agreement.

Hairdressers Registration Acts.

HAIRDRESSERS REGISTRATION REGULATIONS 1953.

THE Hairdressers Registration Board of Victoria by virtue of the powers conferred upon it by the *Hairdressers Registration Acts 1936* doth, with the approval of the Governor in Council, hereby make the following Regulations:—

1. These Regulations may be cited as the Hairdressers Registration Regulations 1953 and shall come into operation upon publication thereof in the *Government Gazette*.

2. The Regulations made under the *Hairdressers Registration Act 1936* on the 23rd March, 1937, are hereby amended as follows:—

(1) By substituting for Part III. thereof the following as Part III.:—

“PART III.—TRAINING.

9. (1) For the purposes of section 8 (2) (a) of the *Hairdressers Registration Act 1936* the prescribed course of training shall consist of training in the subjects prescribed for examination in the prescribed class of hairdressing received—

(a) whilst employed during a period of at least five years as an improver in a hairdresser's shop or shops in Victoria in which hairdressers of such class are employed throughout such period, or

(b) whilst serving an apprenticeship in Victoria in such class of hairdressing for a term approved by the Board, or

(c) whilst a student for a period of not less than one year in a school or schools registered under the provisions of the *Hairdressers Registration Act 1936* at which he has been in regular attendance for the full daily period of tuition and training observed therein for at least Two thousand hours.

(2) Every applicant for registration under section 8 (2) (a) of the *Hairdressers Registration Act 1936* in respect of any prescribed class of hairdressing shall submit proof satisfactory to the Board that he has completed the prescribed training.

10. Every applicant for registration under sub-section 2 (b) of section 8 of the Act in respect of any prescribed class of hairdressing shall submit proof satisfactory to the Board that he has outside Victoria—

(a) completed an appropriate course of training as a hairdresser which in the opinion of the Board is substantially equivalent to that prescribed under paragraph 9 (1) of the Regulations and is registered or entitled to be registered as a hairdresser in any State in the Commonwealth of Australia; or

(b) practised hairdressing of the class in which he seeks registration.”; and

(2) By inserting after Regulation 62 the following heading and Regulation:—

“NOMINATION OF PRINCIPALS.

63. (1) Upon every premises in which a business of hairdressing of any prescribed class or classes is carried on there shall be present and in control of the hairdressing carried on

in such premises during business hours at least one person who is registered in respect of the prescribed class or classes of hairdressing carried on in such premises, and who for the purposes of the Act shall be the principal of the business.

(2) The owner or proprietor of every hairdressing business shall nominate a principal or principals (as the case may require) in respect of each premises in which such owner or proprietor carries on business, and shall notify the Hairdressers Registration Board of such nomination in the form in the Schedule hereto, setting forth the full name and address of each principal so nominated.

(3) If a principal so nominated ceases to act as principal, such owner or proprietor shall within seven days notify the Board of the fact and furnish it with the particulars required by these Regulations in respect of the principal appointed in his place.

(4) These Regulations shall not apply in the case of a business of which the owner or proprietor thereof or one of the owners or proprietors thereof is during business hours in direct personal control as a principal and as a principal is registered in respect of the prescribed class or classes of hairdressing practised in connexion with the said business."

3. Clause 3 of the Hairdressers Registration Regulations 1940 is hereby repealed.

4. The Hairdressers Registration Regulations 1937 (No. 2) are hereby repealed.

The foregoing Regulations were made and passed by the Hairdressers Registration Board at a meeting of the said Board held on the sixteenth day of December, 1953.

1. Travelling expenses at the rates and in accordance with the conditions prescribed in the Regulations under the *Public Service Act 1946* for personal expenses for officers other than Permanent Heads whose salaries are more than £900 a year:

Provided that where a board member leaves his home on board business and returns the same day he shall be entitled to receive—

(a) 3s. 6d. for breakfast, where he is required to leave before 7 a.m. and is unable to return until after 9.30 a.m.

(b) 6s. for tea, where he is required to leave before 5 p.m. and is unable to return until after 7 p.m.

- (o) (i) 4s. 6d. for lunch, where he is required to leave before 7 a.m. and is unable to return until after 7 p.m., or
- (ii) 3s. 6d. for lunch, where he is required to leave before 12 noon and is unable to return until after 3 p.m., and is absent for a period of at least seven hours.

2. Reimbursement of actual railway fares paid by him, or, where a member, with the approval of the Board, uses his own car on board business, mileage rates as prescribed in the Regulations under the Public Service Act.

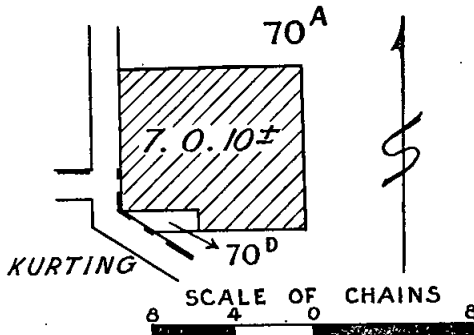

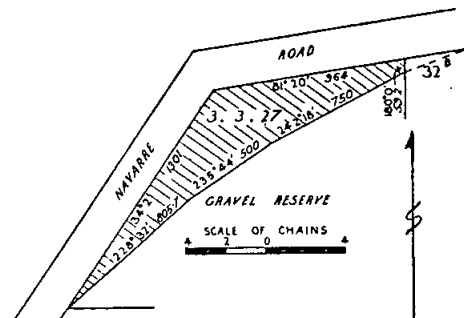

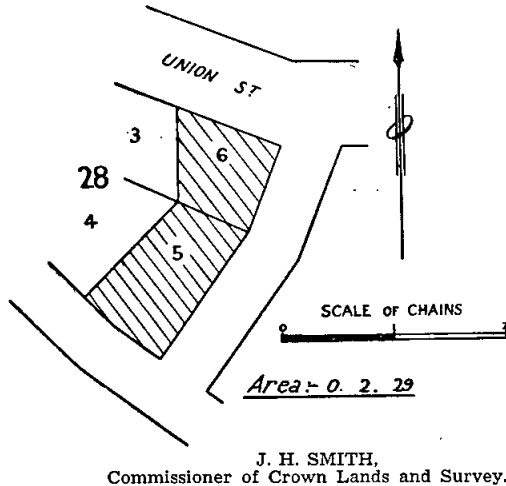

No person shall sell or permit or suffer the sale of goods of any description from stalls, motor cars, carts, trucks, barrows, or any other vehicles, boxes, crates, bags, or other receptacles standing or placed on vacant land (not being Crown land or land under the care and management of the municipality or a public place within the meaning of section 3 of the *Police Offences Act 1928*) within those portions of the Parishes of Wollert, Kal Kallo, Merriang, Wallan, Yuroke, Mickleham, Darraweit Guim, Tullamarine, as are situated within the municipality of the Shire of Broadmeadows.
