Parking of Vehicles Acts.  
SPECIFYING AREA OF APPLICATION OF ACTS.

PROCLAMATION

By the Lieutenant-Governor as Deputy for His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

WHEREAS by sub-section (2) of section 2 of an Act of the Parliament of Victoria passed in the second year of the reign of Her Majesty Queen Elizabeth II., intitled the *Parking of Vehicles Act 1953* as amended by section 2 of the *Parking of Vehicles (Amendment) Act 1954*, it is enacted that the said Acts shall apply only in respect of parking infringements occurring in any area or circumstance specified for the purpose by proclamation of the Governor in Council published in the *Government Gazette* and occurring after the date of such proclamation, provided that no such proclamation shall be made in respect of any area beyond the municipal districts of the Cities of Melbourne and South Melbourne; and whereas an area in the municipal district of the City of Melbourne was specified by proclamation of the Governor in Council published in the *Government Gazette* of the 1st July, 1953, and whereas it is expedient to specify further areas for the purpose of the said Acts.

Now, therefore, I, the Lieutenant-Governor as Deputy for the Governor of the State of Victoria, by and with the advice of the Executive Council thereof, do by this my Proclamation specify for the purpose of the Parking of Vehicles Acts those further areas within the boundaries hereinafter described.

CITY OF MELBOURNE.

*Firstly.*—Commencing at the intersection of the western alignment of Spencer-street and the northern alignment of La Trobe-street; bounded thence by the western alignment of Spencer-street bearing northerly to the northern alignment of Rosslyn-street; by the northern alignment of Rosslyn-street and a line in continuation thereof bearing easterly to a point in line with the western alignment of Chetwynd-street; by a line and the western alignment of Chetwynd-street bearing northerly to the northern alignment of Victoria-street; by the northern alignment of Victoria-street bearing easterly to its intersection with the western alignment of O'Connell-street; by a line bearing easterly from the last-mentioned intersection to the intersection of the eastern alignment of Leicester-street and the northern alignment of Victoria-street; by

the northern alignment of Victoria-street bearing further easterly to a point in line with the northern alignment of La Trobe-street, and thence by a line and the northern alignment of La Trobe-street bearing westerly to the point of commencement.

*Secondly.*—Commencing on the northern alignment of Victoria-parade at a point in line with the eastern alignment of Spring-street; bounded thence by the said northern alignment of Victoria-parade and a line in continuation thereof bearing easterly to the centre-line of Nicholson-street; by the centre-line of Nicholson-street bearing southerly to the centre-line of Victoria-parade; by the centre-line of Victoria-parade bearing easterly to a point in line with the eastern alignment of Lansdowne-street; by a line, the eastern alignment of Lansdowne-street and a line in continuation thereof bearing southerly to the southern alignment of Wellington-parade; by the southern alignment of Wellington-parade to a point in line with the eastern alignment of Spring-street, and thence by a line, the eastern alignment of Spring-street and a line in continuation thereof bearing northerly to the point of commencement. Excluding Treasury-place and the vehicular access to the Government Printing Office.

*Thirdly.*—Commencing at the intersection of the southern alignment of Flinders-street and the eastern alignment of Swanston-street; bounded thence by the eastern alignment of Swanston-street and the eastern alignment of Princes Bridge respectively bearing southerly to the northern alignment of Jeffries-parade; by the northern alignment of Jeffries-parade as diverted through Alexandra Gardens and bearing generally easterly to the line of the northern kerb of Alexandra-avenue; by the line of the said kerb of Alexandra-avenue bearing westerly to the southern alignment of Jeffries-parade; by the southern alignment of Jeffries-parade aforesaid bearing generally westerly to the eastern alignment of Princes Bridge; by the eastern alignment of Princes Bridge bearing further southerly; by a line and the eastern alignment of St. Kilda-road again bearing southerly to the northern alignment of Government House Drive; by the northern alignment of Government House Drive (on the northern side of the Marquis of Linnithgow Memorial Site) bearing easterly to the western boundary of Government House Grounds Reserve; by the last-mentioned boundary bearing southerly to the southern alignment of Government House Drive; by the southern alignment of Government House Drive bearing westerly to Birdwood-avenue; by a line bearing south-westerly across Birdwood-avenue; by the southern alignment of Anzac-avenue (on

the south side of the said Memorial Site) bearing south-westerly to its intersection with the eastern alignment of St. Kilda-road; by a line bearing westerly from the last-mentioned intersection to the centre-line of St. Kilda-road and at a right angle thereto; by the centre-line of St. Kilda-road bearing northerly to a point in a line with the centre-line of Nolan-street; by a line and the centre-line of Nolan-street bearing westerly to a point in line with the centre-line of Sloss-street; by a line and the centre-line of Sloss-street bearing northerly to a point in line with the centre-line of Aikman-street; by a line, the centre-line of Aikman-street and its continuation bearing north-westerly to the centre-line of the River Yarra; by the centre-line of the River Yarra bearing generally westerly beyond the Spencer-street Bridge to the eastern boundary of the land vested in the Melbourne Harbor Trust Commissioners; by the last-mentioned boundary bearing northerly parallel to Spencer-street to a point in line with the southern alignment of Flinders-street, and thence by a line and the southern alignment of Flinders-street bearing easterly to the point of commencement.

## CITY OF SOUTH MELBOURNE.

Commencing at the intersection of the southern alignment of Park-street and the western alignment of Clarendon-street; bounded thence by the western alignment of Clarendon-street and a line in continuation thereof bearing northerly to the left bank of the River Yarra; by the left bank of the River Yarra bearing easterly to a point in line with the centre-line of Aikman-street; by a line, the centre-line of Aikman-street and a line in continuation thereof bearing south-easterly to the centre-line of Sloss-street; by the centre-line of Sloss-street and a line in continuation thereof bearing southerly to the centre-line of Nolan-street; by the centre-line of Nolan-street and a line in continuation thereof bearing easterly to the centre-line of St. Kilda-road; by the centre-line of St. Kilda-road bearing southerly to a point in line with the southern alignment of Park-street, and thence by a line and the southern alignment of Park-street bearing westerly to the point of commencement.

*Marketing of Primary Products Act 1935 (No. 4337).*  
DECLARING THAT MAIZE SHALL BECOME THE  
PROPERTY OF THE MAIZE MARKETING BOARD.

## PROCLAMATION

By the Lieutenant-Governor as Deputy for His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

WHEREAS by sub-section (1) of section 16 of the *Marketing of Primary Products Act 1935*, it is enacted that when a product has been declared a commodity and a board has been appointed in relation thereto, the Governor in Council may by proclamation—

(a) provide and declare that the commodity shall forthwith upon the date of publication of the proclamation, or on from and after a later date specified in the proclamation, be divested from the producers of the commodity and become vested in and be the absolute property of the board as the owner thereof, and that upon any of the commodity coming into existence within a time specified in the same or a subsequent proclamation it shall by virtue of this Act become vested in and be the absolute property of the board as the owner thereof; and

(b) make such further provisions as will enable the board effectively to obtain possession of the commodity as such owner and to deal with the same.

And whereas by a proclamation made on the 5th day of May 1936, under the provisions of section 6 of the said Act, the Governor in Council declared maize to be a commodity under and for the purposes of the said Act And whereas by an Order made on the 2nd November

1936, the Governor in Council appointed a marketing board in relation to maize and assigned to such board the name of "The Maize Marketing Board" Now therefore, I, the Lieutenant-Governor as Deputy for the Governor of the State of Victoria, in the Commonwealth of Australia, by and with the advice of the Executive Council of the said State, do by this my Proclamation hereby provide and declare that on and from the second day of May, One thousand nine hundred and fifty-five all maize shall subject to and in accordance with the *Marketing of Primary Products Act 1935* be divested from the producers of maize and become vested in and be the absolute property of The Maize Marketing Board as the owner thereof and that upon any maize coming into existence within two (2) years from the second day of May, One thousand nine hundred and fifty-five, it shall by virtue of and subject to and in accordance with the said Act become vested in and be the absolute property of the Maize Marketing Board as the owner thereof and to enable The Maize Marketing Board as owners of the above-mentioned commodity effectively to obtain possession thereof and to deal with the same I do further provide that all such maize shall subject to and in accordance with provisions of the said Act be delivered by the producers thereof to The Maize Marketing Board or its authorized agent within such times at such places and in such manner as The Maize Marketing Board by public notice, or in a particular case in writing, directs or as are prescribed by regulations made under the said Act.

## Local Government Act.

PROCLAMATION EXTENDING THE OPERATION OF  
THE UNIFORM BUILDING REGULATIONS

By the Lieutenant-Governor as Deputy for His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

WHEREAS section 900 (2) of the *Local Government Act 1946* provides, *inter alia*, that the Governor in Council may, by proclamation published in the *Government Gazette*, at the request of the council of any municipality, not being a city or town, extend the operation of the Regulations made under Part XLIX. of the Act to the municipal district of such municipality or any part thereof:

And whereas the Council of the Shire of Corio has requested that the operation of the said Regulations be extended to the municipal district of such municipality:

Now, therefore, I, the Lieutenant-Governor as Deputy for the Governor of the State of Victoria, by and with the advice of the Executive Council thereof, by this, my Proclamation, do hereby extend the operation of the Regulations made under Part XLIX. of the *Local Government Act 1946* to the municipal district of the Shire of Corio and order that the said Regulations shall come into operation in the municipal district of the Shire of Corio on publication of this Proclamation in the *Government Gazette*, provided that Parts I. and II. of Chapter 8 thereof shall not be deemed to come into operation till the 15th July, 1955, except in so far as may be necessary to enable the Council of the said municipality to make by-laws pursuant to the powers conferred by Part III. of the said Chapter, and provided, further, that no such by-law shall come into operation before the 15th July, 1955.

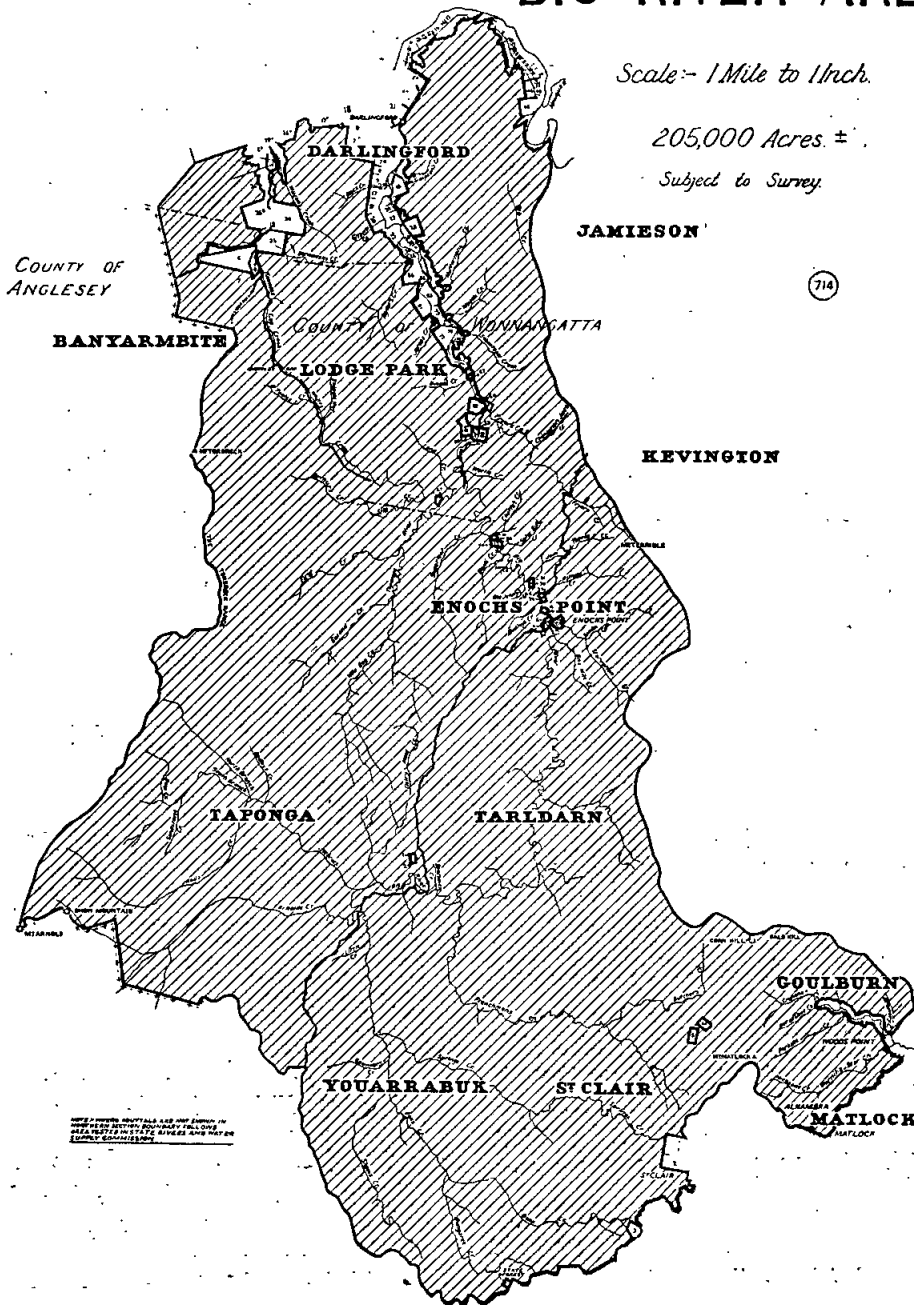

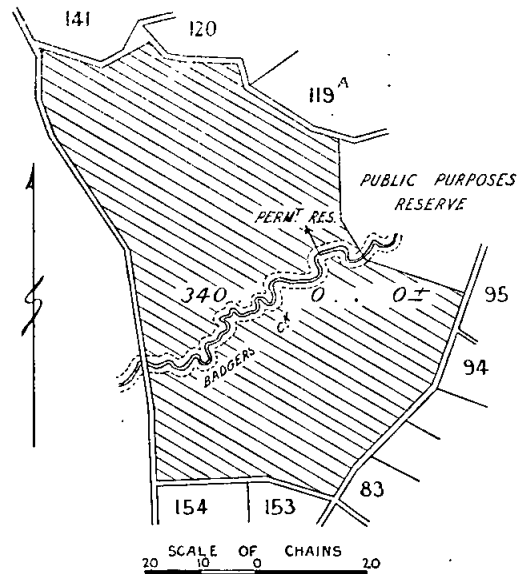

## VARIATION OF SPECIFICATIONS FOR A PRIVATE STREET CONSTRUCTION SCHEME.—CITY OF BOX HILL.

The constituents of the concrete will be four parts of screenings, two parts of sand, and one part of cement, proportioned by volume. The paving shall be laid in slabs 4 ft. 6 in. square, alternate bays being constructed at each pouring. The concrete, after placing, is to be screeded off and rammed solid.

## FINISH.

The material used for finishing shall be a basalt grit composition. The whole of the exposed surfaces shall be finished off with a steel float to produce an even non-slip surface, and all joints are to be made with an approved grooving tool.

## MAINTENANCE.

All concrete is to be covered for at least three days after placing and maintained for a period of two months after completion.

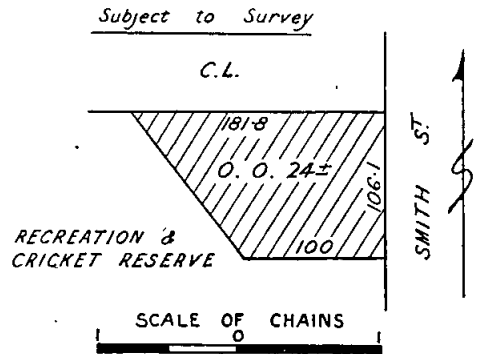

## BY-LAW No. 21.

*Uniform Building Regulations.*

A By-law of the Town of Colac made under the Local Government Acts and the Uniform Building Regulations, as amended, and numbered 21 for determining, applying, dispensing with or regulating such matters or things as are left to be determined, applied, dispensed with or regulated by the Council of the said town under the Uniform Building Regulations, Victoria, as amended.

IN pursuance of the powers conferred by the Local Government Acts and the Uniform Building Regulations, Victoria, as amended (hereinafter called "the Regulations") and of any and every other power thereunto enabling, the Mayor, Councillors and Burgesses of the Town of Colac order as follows:—

1. The whole of clause 4 of By-law No. 101 of the Shire of Colac and of the First Schedule of the said By-law as altered by By-law No. 107 of the said Shire, insofar as the same apply to the Town of Colac, are hereby repealed.

2. The areas set out and described in the First Schedule are hereby described as brick areas and no person shall in any such area construct or cause to be constructed any building, the external walls of which are of material other than masonry or concrete, provided that for the purposes of this clause buildings of reinforced concrete or masonry veneer construction conforming to the requirements of chapter 26 of the Regulations, shall be deemed to have external walls of masonry or concrete; and provided that, for the purpose of this clause, buildings shall include the following types of outbuildings as defined in the Regulations, viz.: stables, workshops and sheds, laundries constructed within 10 feet of the main building, motor garages and water or pan closets and urinals constructed within 10 feet of the main building. Provided further that this clause shall apply to any addition to or extension of existing buildings not having external walls of masonry or concrete.

3. The provisions of clause 2 hereof shall not apply to any addition to or extension of any existing building where—

- (i) such existing building—
  - (a) is a Class I. building or an out-building appurtenant to a Class I. building;
  - (b) is of timber framed construction sheeted externally with materials other than masonry or concrete;
  - (c) was erected prior to the land on which it is erected, having been prescribed as or included in a "brick area"; and

(d) was erected and constructed in accordance with all relevant By-laws in operation at the time it was so erected or constructed;

- (ii) no part of the allotment of land on which such existing building is erected or of any building on such land is used for the purpose of any trade, business, industry, manufacture, or public amusement;
- (iii) not more than one Class I. building is erected on the land upon which the existing building has been erected;
- (iv) the area of land covered by such addition or extension will not exceed 25 per cent. of the area of the land already covered by such existing building which is to be added to or extended; and
- (v) the building when so added to or extended will conform to all By-laws and Regulations relevant thereto, and will remain a Class I. building or an out-building appurtenant to a Class I. building (as the case may be).

Nothing herein contained shall be deemed to authorize the addition to a Class I. building of a garage having external walls of material other than masonry or concrete or to authorize the erection, addition, or extension previously made thereto in a manner contrary to this or any other By-law or Regulation in operation in the municipal district of the Town of Colac.

4. The minimum area, depth and width of frontage specified in column 3 of Table 803 of the Regulations are hereby adopted as the minimum area depth and width of frontage of land on which buildings of Class I. and Class II. occupancy shall be constructed throughout the whole of the municipal district of the Town of Colac.

5. (a) The minimum distance from the frontage of any land of any Class I. or Class II. building and of any out-building appurtenant thereto is hereby specified as 20 feet.

(b) No person shall construct any Class I. or Class II. building nor any out-building appurtenant thereto closer to the frontage of any land than 20 feet.

6. Notwithstanding anything contained in the Regulations, the Council may, subject to the Regulations made pursuant to section 17 of the Slum Reclamation and Housing Act, in any case where on the date of commencement of these Regulations land existed as a separate allotment and had not since been reduced in area or was shown on any plan of subdivision approved by the Council and lodged in the Office of Titles, permit—

- (a) The construction of a building of Class I. occupancy on such land having a lesser area, depth, or width of frontage than those specified in column 3 of Table 803, whether or not such building be constructed at lesser distance from the boundaries than those prescribed in clauses 805 and 806 of the Regulations.
- (b) The construction of a building of Class III., V., VI., VII., or VIII. occupancy or a building to which a building of Class IV. occupancy is attached on such land having an area, depth, or width of frontage less than that prescribed in clause 808 of the Regulations.

7. In the case of a building on any land forming part of a subdivision approved by the Council and lodged with the Office of Titles prior to the date of commencement of the Regulations, the requirements of clause 811 of the Regulations may be dispensed with by Resolution of the Council if it is satisfied that section 187 (3) of the *Health Act 1928* can be otherwise complied with.

8. *Definitions.*—In this By-law the expressions "Class I., Class II., Class III., Class IV., Class V., Class VI., Class VII. and Class VIII." shall have the same meanings as in the Uniform Building Regulations, Victoria, as amended, and "out-building" shall include a shed, workshop, stable, garage, sleep-out and laundry.

1. All former By-laws so far as they relate to the matter and things provided for in this By-law shall be and are hereby repealed.

2. This By-law shall come into full force and operation immediately after its publication in the *Government Gazette*.

3. No person shall cause, permit, or suffer the depositing or leaving of refuse or rubbish on any street, road, lane, or passage.

4. No person shall cause, permit, or suffer the depositing or leaving of any refuse or rubbish on any land other than land especially reserved for such purpose by an order of the Council.

5. All refuse or rubbish deposited or left at any reserve as provided for in the preceding clause shall at all times be deposited in a regular and orderly manner in such holes, quarry, or indenture provided for the depositing or disposal of refuse or rubbish as and where directed by an officer of the Council.

6. If any refuse or rubbish so deposited or left at any such reserve is deemed by an officer of the Council to be offensive or likely to become offensive the person depositing or leaving such refuse or rubbish shall, if directed by an officer of the Council, immediately cover such refuse or rubbish with a layer of clean soil or other innocuous material.

7. The owner or occupier of any land shall remove or destroy all refuse or rubbish thereon (other than refuse or rubbish the removal of which the Council has undertaken or contracted for under section 39 of the *Health Act 1928*).

8. In the event of default being made by such owner or occupier in complying with clause 7 hereof, and notwithstanding the imposition or recovery of any penalty, the Council may (after the service on such owner or occupier of a notice in writing from the Council over the signature of the Shire Secretary, requiring such owner or occupier to remove or destroy such rubbish or refuse within 48 hours after the service of such notice and that time has expired) by its Inspector, with a sufficient number of workmen, enter upon any such land, and for that purpose remove any fence or any part thereof upon the said land or any part thereof, and remove or destroy such refuse or rubbish, and any expenses incurred by the Council in so doing, shall be paid by the owner or occupier of the said land to the Council on demand, and in default of payment such expenses may be recovered by the Council from such owner or occupier in a Court of Petty Sessions.

9. (1) Any notice required by this By-law to be given or served upon any owner or occupier of any land may be given or served where—

(A) such owner or occupier is a person—

- (a) by delivering it to such person, or
- (b) by leaving it for such person at his usual or last known place of abode or business with some person thereat who is apparently over the age of sixteen years, or
- (c) by sending it by post in a prepaid envelope addressed to such person at his last known place of abode or business;

(B) such owner or occupier is a company or body corporate by sending such a notice in a prepaid envelope addressed to such company or body corporate at its registered office.

(2) Where the address of any owner or occupier of such land is a person, company, or body corporate, and his, her, or its address is not known, by affixing such notice upon a conspicuous part of such land.

10. Every person guilty of any offence against this By-law shall be liable to a penalty of not more than £20, and to a further penalty of not more than £5 for each day on which an offence against this By-law is continued after notice has been given to the offender by the Council of the commission of the offence or after a conviction or order by any court (as the case may be).

11. This By-law shall apply to and have operation throughout the whole of the municipal district of the Shire of Wimmera.
