



County Court Act 1928.

RULES OF COURT.

WE, the undersigned Judges of County Courts, in exercise of the powers conferred by section 87 of the County Court Act 1928, do hereby amend the County Court Rules 1930 with respect to all business on and after the 1st day of February, 1955, as follows:—

For rule 16 of Order IV. there shall be substituted the following rule:---

- "16 (a) Where an infant desires to commence an action or proceeding, his next friend shall undertake in writing to be responsible for the costs thereof. No plaint shall be entered or particulars or documents received unless such undertaking has been entered into and filed with the Registrar.
- (b) Upon entering into such undertaking, the next friend shall be liable for costs in the same manner and to the same extent as if he were himself the plaintiff, claimant, or applicant; and the action or proceeding shall continue in the name of the infant by such next friend. No order of the Court or a Judge shall be necessary for the appointment of such next friend. If the infant fail in or discontinue his action or proceeding, or do not pay the amount of costs ordered to be paid by him, proceedings may be taken for the recovery of such amount from the next friend as for the recovery of a judgment debt."

In Order XIII., there shall be added the following rule:—

"4. The Registrar may, before a summons is served, extend the return day and amend the summons accordingly."

In Order XVII., there shall be added the following rule:--

"14. Notwithstanding anything contained in the foregoing rules of this Order, except where an infant or a person of unsound mind, or a person suing or being sued on behalf of such a person, is a party to the action, money paid into Court under rules 1 or 5 may be paid out by the Registrar upon and in accordance with a written authority signed by all parties to the action or their solicitors, each signature by a party to be verified by affidavit."

In Order XXIII., after rule 7 there shall be added the following

"7A. If on the hearing of any application under rule 4, it shall appear that any claim which could not have been included in a special summons has been included in such summons, the Judge may, if he shall think fit, forthwith amend the particulars of demand by striking out such claim, or may deal with the claim for a debt or liquidated demand, with or without interest, as if no other claim had been included in the summons, and allow the action to proceed as respects the residue of the claim."

In Order XXXIII., rule 4, for the sum of "2s." there shall be substituted the sum of "3s.", and in Item 66 of the Schedule of Scale of Costs for the figure "7" there shall be substituted the figure "4".

In Forms 7 and 8 in the Schedule of Forms to Rules of Court, there shall be inserted in the headings immediately after the word "Plaintiff" and the word "Defendant" the following:—

"(Address and description.)"

REGULATIONS FOR THE CARE, PROTECTION, AND MANAGEMENT OF THE "WHITTLESEA SHOW GROUNDS AND PUBLIC RECREATION RESERVE."

WHEREAS by section 181 of the Land Act 1928, as reenacted by section 9 of the Land Act 1941, power is given to the Board of Land and Works to make Regulations in respect of the care, protection, and management of any Crown land which has been reserved under the Land Acts for any public purpose whatsoever, and which has not been conveyed to or vested in trustees, and for the further purposes as enacted: Now therefore the Board of Land and Works, in pursuance of the powers conferred. doth hereby make the following Regulations in respect of the land temporarily reserved by Order in Council of 10th October, 1905, as a site for Agricultural Show Yards in the Town of Whittlesea, and by Order in Council of 19th May, 1954, for the additional purpose of Public Recreation. and known as the "Whittlesea Show Grounds and Public Recreation Reserve" (hereinafter referred to as the "Reserve"):—

REGULATIONS.

1. The Reserve shall be open to the public from sunrise to sunset, free of charge, except on such days (not exceeding 52 in any one year) as the Reserve may be set apart

for cricket or football matches, agricultural shows, fêtes. sports, or holiday or other amusements, on any of which occasions a charge not exceeding Five shillings may be made for the admission of each adult to the Reserve.

- 2. No person shall enter or remain in the Reserve who may offend against decency as regards dress, language, or conduct
- 3. No person shall damage in any way the trees, shrubs, or flowers in the Reserve, nor shall fires be lighted therein, except in the fire-places provided for the purpose.
- 4. No person shall climb or jump over the fences or gates in or around the Reserve, stick bills thereon, or cut names on or in any way damage or injure any of the buildings, gates, fences, seats, or trees in the Reserve, nor leave or deposit any glass, paper, or rubbish, nor roll or throw stones or any missiles of any kind therein.
- 5. No person shall put in the Reserve any cattle, horses, sheep, goats, pigs, or other animals without the permission, in writing, of the Committee of Management first obtained.
- 6. No person shall bring into the Reserve any dog unless controlled by a chain or cord without the permission of the Committee of Management first obtained, in writing.
- 7. No person shall camp in the Reserve except in the part or parts thereof which are set apart for such purposes by the Committee of Management and then only on the payment of such fee and subject to such conditions as are determined by such Committee.
- 8. No person shall erect therein any building, nor any booth or other structure for the purpose of offering for sale any article without the permission, in writing, of the Committee of Management first obtained.
- 9. No person shall take part in any public entertainment of any sort in the Reserve without the permission, in writing, of the Committee of Management first obtained.
- 10. No person shall spit or expectorate on the paths or on any structure or erection in the Reserve.
- 11. Persons renting or hiring any stand, building, erection, or enclosure on the occasions of any cricket or football matches, agricultural shows, fêtes, sports, or holiday or other amusements may be required to deposit any sum which the Committee of Management may at any time determine, not exceeding Twenty-five pounds (£25). by way of guarantee that due care shall be taken of such stand, building, erection, or enclosure, and such Committee, in its absolute discretion may make good any damage or injury sustained by such stand, building, erection, or enclosure, or anything contained therein during such occupancy or hiring, and deduct the cost of making good such loss or damage from the sum of money deposited by way of guarantee and all persons so renting or hiring shall abide by these Regulations and by any order given by the Committee of Management.
- 12. No person, except labourers and workmen employed in the Reserve, shall enter any plots therein which may be enclosed for plantations of young trees or shrubs.
- 13. No person shall bring into the Reserve or use or carry therein any firearm or offensive weapon.
- 14. No person shall leave or deposit any glass, paper, litter, or rubbish in the Reserve except in a place provided for the purpose and indicated by notice board.

- 15. Any person committing on any part of the Reserve, or in any of the rooms, buildings, structures, erections, or enclosures for the time being thereon any of the following offences, shall be guilty of breach of these Regulations:—
 - (a) Assaulting or threatening any person or persons.
 - (b) Being under the influence of liquor.
 - (c) Entering, crossing, being on, or trespassing on any playing ground area, enclosure, or course, or building, room or structure, or any part thereof whilst any sport, game, competition, race, entertainment or amusement is being played, conducted or carried on, or at any time between the commencement and conclusion of such event without the consent of the Committee of Management.
 - (d) Using profane, indecent, obscene, or unseemly language.
 - (c) Using threatening, abusive, offensive, or insulting words,
 - (f) Behaving improperly, offensively, or riotously.
 - (g) Interfering with, or interrupting any game, sports, competition, entertainment or amusement or practice thereat.
 - (h) Obtaining or attempting to obtain admission to any part of the Reserve when not entitled to admission under these Regulations.
 - 16. No person shall-
 - (a) remain in the Reserve who behaves in a disorderly, unseemly, or offensive manner, or creates or takes part in any disturbance;
 - (b) enter or remain in the Reserve whilst in a state of intoxication;
 - (c) bring any intoxicating liquor on to the Reserve without the consent of the Committee of Management first obtained.
- 17. No person shall on any portion of the Reserve cause or permit any outery, sound, or noise to be emitted from an amplifier, loud-speaker, public address system, or like instrument without first obtaining the written permission of the Committee of Management, and such permission may be granted subject to such terms, conditions, and restrictions as may be imposed by the Committee of Management.
- 18. No person shall carry on the business or calling of a bookmaker except in and upon such portions of the Reserve as may be set aside for that purpose, and then only when he shall—
 - (a) have obtained the permission in writing of the Committee of Management on payment of a fee not to exceed Five pounds (£5) for any meeting or sporting event held in the Reserve; and
 - (b) that during the time he shall be in or upon the Reserve carrying on the business or calling of a bookmaker he shall wear a ticket or have a bag either of which shall be visible to the public and shall have thereon his name.

Every person who contravenes or fails to comply with these Regulations shall, in accordance with the provisions of section 181 of the Land Act 1928, as re-enacted by section 9 of the Land Act 1941, for each offence be liable to a penalty of not more than Five pounds, and every person who contravenes or fails to comply with any such Regulation and who, after he has been warned by any bailiff of Crown lands, or by any member of the Police Force, does not desist therefrom, may be forthwith apprehended by such bailiff or member of the Police Force and taken before some justice to be dealt with according to law, and shall be liable to a penalty of not more than Ten pounds.

. The Reserve has been placed under the control of a Committee of Management with power and authority to enforce the foregoing Regulations.—(Rs.2491.)

CHARLTON PARK RESERVE. RESCISSION OF REGULATIONS.

SHIRE OF BULLA. BY-LAW No. 13.

- A By-law of the Shire of Bulla, made under the Local Governments Acts and the Uniform Building Regulations Victoria, and numbered 13, for determining, applying, dispensing with, or regulating such matters or things as are left to be determined, applied, dispensed with, or regulated by the Council of the Shire of Bulla under the Local Government Acts and the Uniform Building Regulations Victoria.
- IN pursuance of the powers conferred by the Local Government Acts and the Uniform Building Regulations Victoria, and of any and every power it thereunto enabling, the President, Councillors, and Ratepayers of the Shire of Bulla order as follows:—
- 1. The minimum area, depth, and width of frontage specified in column 3 of Table 803 of the Uniform Building Regulations Victoria (hereinafter called the Regulations), are hereby adopted as the minimum area, depth, and width of frontage of land on which a building shall be constructed throughout the whole or (as the case may be) that portion (or those portions) of the municipal district known as the Township of Sunbury as defined by the Lands Department of Victoria Plan of the Township of Sunbury. Sunbury.

- 2. (a) The minimum distance of the outer walls of any building from the frontage of any land is hereby specified
- (b) No person shall construct any building closer to the frontage of any land than 15 feet.
- 3. Notwithstanding anything contained in the Regulations, any person may with the consent of the Council in any case where on the date of commencement of the Regulations such land existed as a separate allotment and has not since been reduced in area or is shown on any plan of subdivision approved by the Council and lodged in the Office of Titles in the Office of Titles
 - (a) construct a building of Class I. or Class II. Occupancy on land having a lesser area, depth, or width of frontage than those specified in Column 3 of Table 803 of the Regulations or in clause 2 of this By-law (as the case may be);
 - (b) construct a building of Classes III., V., VI., VII., or VIII. Occupancy or a building to which a building of Class IV., Occupancy is attached on land having an area, depth, or width of frontage less than that prescribed in clause 808 of the Regulations. Regulations.
- 4. In the case of a building on any land forming part of a subdivision approved by the Council, and lodged with the Office of Titles prior to the date of commencement of the Regulations, the requirements of Clause 811 of the Regulations are hereby dispensed with.
