Vegetation Diseases (Fruit Fly) Act 1947 (No. 5258).

DECLARING A PROCLAIMED AREA.

PROCLAMATION

By His Excellency the Lieutenant-Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

WHEREAS by section 3 of the *Vegetation Diseases (Fruit Fly) Act 1947 (No. 5258)*, it is provided that, where the Governor in Council is of opinion that it is necessary to protect the fruit industry against the introduction or spread of the insects of the family *Trypetidae* (commonly known as fruit flies), he may by Proclamation declare any portion of Victoria specified therein to be a proclaimed area, and prohibit the planting on any land in the proclaimed area of any plant or vegetable specified, and prohibit the removal from any property within the proclaimed area to any other property within the area and from any place in the proclaimed area to any place outside the area of any fruit or vegetable, and require occupiers and owners of land in the proclaimed area to take such action (for the eradication or prevention of the spread of fruit fly as is specified in the Proclamation: Now, therefore, I, the Lieutenant-Governor of the State of Victoria, in the Commonwealth of Australia, being of opinion that it is necessary to protect the fruit industry of Victoria against the introduction or spread of the insects of the family *Trypetidae* (commonly known as fruit flies), and by and with the advice of the Executive Council of the said State, do by this my Proclamation hereby—

1. Declare that portion of Victoria within the Shire of Mildura, Parish of Mildura, County of Karkaroc and within a boundary commencing at the intersection of the Sturt Highway and Peach Avenue, thence southerly along Peach Avenue for a distance of 2,650 feet, thence by a straight line projected due east for a distance of 1,775 feet to Access Road, thence southerly along Access Road to the intersection of 19th Street, and Riverside Avenue, thence south easterly along 19th Street, to Walnut Avenue, thence north easterly along Walnut Avenue to Dow Avenue, thence north westerly along Dow Avenue to the Sturt Highway thence westerly along the Sturt Highway to its intersection with Peach Avenue at the commencing point to be a proclaimed area.

2. Prohibit the removal from any place within the proclaimed area to any other place within the area or to any place outside the area of any fruit or vegetable or any case or package which has contained any fruit or vegetable unless such removal is made on the instruction of an inspector.

3. Prohibit the planting on any land in the proclaimed area of any of the following fruits, trees, plants and/or vegetables:—

Apples, apricots, brambles and other berry fruits, cape gooseberries, cherries, citrus fruits, cucumbers, egg fruit, figs, gooseberries, grapes, guavas, loquats, medlars, nectarines, passion fruit, peaches, pears, peppers, persimmons, plums, prunes, quinces, rock melons, sweet melons, tomatoes, ornamental solanum, box thorn provided, that where box thorn is grown as a hedge along a boundary or dividing fence the occupier or owner may continue to so grow it on the following conditions:—

(i) Cut back the hedge forthwith and periodically as necessary to retain it within a height not exceeding six (6) feet from the ground level and a width not exceeding two (2) feet.

(ii) That when such hedge has been cut back to within the foregoing dimensions, he shall thoroughly spray it forthwith to cover all parts of the plants forming the hedge with a solution containing two thousand (2,000) parts of two-four Dichloro-phenoxy-acetic acid (2-4D), or one of its derivatives, to one million (1,000,000) parts of water (0.2 per cent.) and he shall spray it thereafter as often as is necessary to prevent the plants from forming fruit.

and refrain from planting such plants while this Proclamation remains in force.

4. Require occupiers and owners of land in the proclaimed area to give access to such land at all times to an inspector with or without assistants for the purpose of inspection and/or applying on such properties any spray material and/or for the purpose of removing any fruit or vegetables or prohibited plant, and/or performing such other acts which in the opinion of an inspector are necessary for the eradication or prevention of the spread of fruit flies.

PARWAN CATCHMENT.

PROCLAMATION

By His Excellency the Lieutenant-Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

I, THE Lieutenant-Governor of the State of Victoria in the Commonwealth of Australia by and with the advice of the Executive Council of the said State and in pursuance of the provisions contained in section 22 of the *Soil Conservation and Land Utilization Act 1947* do by this my Proclamation define the water supply catchment area to be known as the Parwan Catchment as follows:

Commencing at the south-eastern corner of Crown allotment 1, section XXII, Parish of Gorrockburkghap, thence by a road to a point on the south-western boundary of Crown allotment 5, section XXII, thence across that road to the northern corner of the most easterly boundary of Crown allotment 11, section XXII, thence south and west by a road to a point opposite the northern boundary of Crown allotment 13, section XXII, thence across that road and in a south-westerly direction by a road traversing the northern portions of Crown allotments 13 and 12, section XXII, thence across a road to a point on the eastern boundary of Crown allotment 1e, section XV, thence south to the south-eastern corner of that allotment, thence westerly by a road to the south-western corner of Crown allotment 1, section XVI, thence across a road to a point on the eastern boundary of Crown allotment 5e, section XVI, thence south and west by a road forming part of the boundary of that allotment, thence across that road to the north-eastern corner of Crown allotment 6, section XVI, Parish of Gorrockburkghap, thence south and generally south-westerly by a road through the State Forest in the Parishes of Gorrockburkghap, Bungeeltap and Beremboke to the south-eastern corner of Crown allotment 55, Parish of Beremboke, thence west by a road to the south-west corner of Crown allotment 26A, thence north by a road to a point on the western boundary of that allotment opposite the north-eastern corner of Crown allotment 56, thence across a road to that corner of Crown allotment 56, thence west along the northern boundary of that allotment to a point on the eastern boundary of Crown allotment 4, Parish of Beremboke, thence south by the eastern boundary and west by the southern boundary to the south-western corner of that allotment, thence across a road to a point on the eastern boundary of Crown allotment 62c, Parish of Ballark, thence south by the eastern boundary and west by the southern boundary to the south-western corner of that allotment, thence north by the western boundaries of Crown allotments 62c, 62A and 62B to the north-western corner of Crown allotment 62B, thence east by a road forming the northern boundary of that allotment to a point opposite the south-western corner of Crown allotment 63, thence northerly by a road forming the western boundary of Crown allotment 63 to the northern corner of that allotment, thence north-westerly and north by a road forming part of the boundary of Crown allotment 63A, parish of Ballark to the north-western corner of Crown allotment 1, section II, parish of Bungeeltap, thence westerly by a road to the south-western corner of Crown allotment 5A, section I, Parish of Bungeeltap, thence north by a road to the northern corner of Crown allotment 5A, section XII, Parish of Yaloak, thence across a road to a point on the western boundary of Crown allotment 6, section XI, Parish of Yaloak, thence north-westerly by that road to the western corner of Crown allotment 8, section XXIV, Parish of Gorong, thence east by the northern boundary of that allotment to the south-western corner of Crown allotment 2, section XXIV, thence north to the north-western corner of Crown allotment 15A, section XXVI, thence west to the south-western corner of Crown allotment 8, section XXVI, thence north by a road to the north-west corner of Crown allotment 6, section XXVI, thence east by the northern boundaries of Crown allotments 6 and 5, section XXVI, and Crown allotments 4 and 3, section XXV to the north-western corner of Crown allotment 3, thence south by the eastern boundary of that allotment to a point opposite the north-western corner of Crown allotment 2, section XXII, thence across a road to that corner, thence east to the western boundary of Crown allotment 3, section XXII, thence north to the most northerly corner of that allotment, thence by a road in a south-easterly direction to a point on the north-eastern boundary of Crown allotment 5, section XXI opposite the north-western corner of Crown allotment 1, section XIV, thence east by a road to the north-eastern corner of Crown allotment 3, section XIV, thence south-easterly by a road to the northern end of the eastern

boundary of Crown allotment 1b, section XVI, Parish of Gorong, thence by that road through the north-western corner of Crown allotment 1 of A, section VII, Parish of Gorrockburkghap to the southern boundary of the railway reserve, thence easterly by the railway reserve to a road adjacent to the north-eastern boundary of Crown allotment 3 of A, section VII, thence south-easterly by that road to the southern boundary of the railway reserve at the north-eastern corner of Crown allotment 7, section IX, thence south-easterly by the southern boundary of the railway reserve to a point on the northern boundary of Crown allotment 5 of C, section X, thence south-easterly by a road to the eastern corner of Crown allotment 12, section XI, thence across a road to the north-eastern corner of Crown allotment 9 of D1, section XI, thence south to the north-western corner of Crown allotment 1, section XIII, Parish of Gorrockburkghap, thence east to the north-eastern corner of that allotment, thence south by the eastern boundary of the Parish of Gorrockburkghap to the point of commencement.

The area described is more particularly defined on a plan lodged at the Head Office of the Soil Conservation Authority, 378 Cotham-road, Kew.

PROCLAMATION EXTENDING THE OPERATIONS OF THE UNIFORM BUILDING REGULATIONS.

By His Excellency the Lieutenant-Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

WHEREAS section 900 (2) of the *Local Government Act 1946* provides, *inter alia*, that the Governor in Council may, by Proclamation published in the *Government Gazette*, at the request of the Council of any municipality, not being a city or town, extend the operation of the Regulations made under Part XLIX. of the Act to the municipal district of such municipality or any part thereof:

And whereas the Council of the Shire of Woorayl has requested that the operation of the said Regulations be extended to part of the municipal district of such municipality:

Now, therefore, I, the Lieutenant-Governor of the State of Victoria, by and with the advice of the Executive Council thereof, by this, my Proclamation, hereby extend the operation of the Regulations made under Part XLIX. of the *Local Government Act 1946* to that part of the municipal district of the Shire of Woorayl described hereunder, and order that the said Regulations shall come into operation in such part of the municipal district of the Shire of Woorayl on publication of this Proclamation in the *Government Gazette*, provided that Parts I. and II. of Chapter 8 thereof shall not be deemed to come into operation until the 25th April 1956, except in so far as may be necessary to enable the Council of the said municipality to make by-laws pursuant to the powers conferred by Part III. of the said Chapter, and provided, further, that no such by-law shall come into operation before the 25th April 1956:—

- (a) The whole of the Township of Leongatha and Crown allotments 12b, 12c, 12f, 59A, 59f, and 59g, Parish of Leongatha, County of Buln Buln.
- (b) The whole of the Township of Meeniyan, excluding sections 7, 8 and Crown allotment 13 to 26 inclusive, section 9, Parish of Nerrena, County of Buln Buln.
- (c) The whole of the Township of Inverloch and Crown allotments 52, 52b, and 56, and 1, 3 and 4, section 1, Parish of Kirrak, County of Buln Buln.
- (d) The whole of the Township of Tarwin, and Crown allotments 5, 5a, 5b, 24 and A, Parish of Tarwin, County of Buln Buln, the area being commonly known as Tarwin Lower.
- (e) The whole of the Township of Koonwarra, Parish of Leongatha, County of Buln Buln.

- (f) That portion of the Township of Dumbalk, Parish of Meeniyan, County of Buln Buln, excluding sections F and G, the area being commonly known as Stony Creek.
- (g) Those portions of Crown allotments 81, 82A, 82, 82B, 91B, 91B, 92A, 92c, 92D, 97A, 98A, and closed Government roads in the Parish of Dumbalk, County of Buln Buln, enclosed by a circle having its centre at the south-western corner of Crown allotment 92c, in the said Parish and a radius of 40 chains, the area being commonly known as Dumbalk.
- (h) Such parts, of the Township and Parish of Waratah which lie within the area bounded on the north by a line bearing east, from the angle at the south-western end of that portion of the boundary of Crown allotment 26, Parish of Waratah, County of Buln Buln, bearing south 38 deg. 21 min. west until the said line intersects the coast on Waratah Bay at high-water mark, on the east by the coast of Waratah Bay at highwater mark, on the south by the northern boundaries of Crown allotments 3A and 3B, Parish of Waratah, County of Buln Buln, and its production south-easterly across the foreshore reserve until it intersects high-water mark on the said coast and on the west by a straight line from a point at the western end of that portion of the northern boundary of the said Crown allotment 3B, bearing north 87 deg. 40 min. west to the south-western end of the above-mentioned portion of the boundary of the said Crown allotment 26 bearing south 38 deg. 21 min. west, the area being commonly known as Wakeriville.

THE MELBOURNE HARBOR TRUST COMMISSIONERS.

SUPERANNUATION REGULATIONS.

IN pursuance of section 37 of the *Melbourne Harbor Trust Act 1928* (No. 3733), the Melbourne Harbor Trust Commissioners make the following Regulations, namely:—

1. These Regulations shall come into operation on the 23rd day of December, 1955, and shall be read and construed as one with the Principal Regulations.

2. In these Regulations the Superannuation Regulations made by the Commissioners on the 16th day of December, 1927, and approved by the Governor in Council on the 24th day of January, 1928, and any Regulations amending the same are referred to as "the Principal Regulations".

3. The Principal Regulations as altered and/or added to by these Regulations shall be known as the Melbourne Harbor Trust Superannuation Regulations 1927-1955.

4. Regulation 2 of the Principal Regulations is amended by deleting the definition of "employee" and substituting therefor the following definition:—

"Employee means—

(a) Any person who, prior to the 23rd day of December, 1955, being duly qualified had become a contributor under these Regulations.

(b) Any person who, after the 23rd day of September, 1955, shall have completed three years (or in any special cases approved by the Commissioners six calendar months) continuous regular employment in the Service and was at the time of the commencement of such employment under the age of fifty-seven years and who, within three calendar months next after the completion of such three years regular employment or of such approval by the Commissioners as the case may be, shall lodge with the Commissioners a notice in the form in the Third Schedule to these Regulations."

5. In Regulation 5 sub-regulation (1) after the word "June" the word "next" shall be deleted and there shall be substituted therefor the figures "1958".

6. As on and from the 23rd day of December, 1955, the scale appended to Regulation 10 sub-regulation (1) shall have no force or effect and there shall be substituted therefor the following scale:—

7. After sub-regulation (1) of Regulation 10 add the following new sub-regulation (2):—

“(2) Notwithstanding anything in these Regulations a contributor who at the date of commencement of this Regulation, viz. the 23rd day of December, 1955, is contributing for a number of units greater than the number appropriate to his wage as set out in the scale in sub-section (1) of section 10 as amended by this section of these Regulations may within three months after the commencement of these Regulations elect to reduce that number to a number not less than the number so appropriate, and any contributor who so elects shall have returned to him from the Superannuation Account the actuarial reserve as determined by an actuary appointed by the Commissioners of the contributions paid by him for the units surrendered consequent upon such election.”

8. In Regulation 11 the figure £234 is excluded and the figure £260 substituted therefor.

9. Regulation 12 is repealed and the following Regulation substituted therefor:—

“12. (1) (a) If the wages of a contributor are increased and by reason of that increase fall within a higher wages group in column 1 of the scale contained in clause 10 of these Regulations

than the wages group in which it fell prior to the increase he may within three months from the pay day on which payment of wages at the increased rate is first actually made elect to increase the number of units for which he is contributing by a number not exceeding the difference between—

the number of units specified in column two opposite the wages group in which his wages fall after the increase of his wages, and the number of units specified in column two opposite the wages group in which his wages fell before the increase.

Any increased contribution under this sub-clause shall be payable as from and inclusive of the pay day on which payment of wages at the increased rate is first actually made.

(b) Without affecting the generality of sub-paragraph (a) of paragraph 1 of this sub-section, a contributor may at any time elect under this paragraph (b) to contribute for additional units to make up a total number of units not exceeding the number of units specified in column two opposite the wages group in which his wages fall.

Provided that such an election shall have no effect unless the contributor submits within one month after the date of election or such further time as the Commissioners allow, a certificate in a form approved by the Commissioners from a medical practitioner approved by the Commissioners that the contributor is not suffering from any physical or mental defect that is likely to render him incapable before attaining the maximum age of retirement of performing his duties.

(2) Sub-clauses (1) (a) and (1) (b) of this section shall not apply in the case of a contributor whose wages are increased under the cost of living adjustment clause or similar clause in any industrial agreement or award or determination to a sum amounting to not more than £10 per annum more than the minimum of the wages group next higher than the wages group from which such contributor was increased when such increase as aforesaid was made."

10. Sub-regulation (2) of Regulation 14 is repealed and the following sub-regulation substituted therefor:—

"(2) The contributions payable in respect of the first two, three or four units by an employee referred to in sub-clause (1) of this clause shall be those prescribed for the age of thirty."

11. Regulation 17 is amended by excluding from paragraph (a) the words "or half units" and from paragraph (c) the words "or half unit".

12. Regulation 18 is amended as follows:—

"18. As from the 23rd day of December, 1955, the table of contributions for males according to age shall be that set out in the First Schedule hereto and the table of contributions for females according to age shall be that as set out in the Second Schedule and such table shall apply to male and female employees respectively until other tables of contributions are prescribed as aforesaid."

13. Regulation 20 is repealed and the following new Regulation 20 substituted therefor:—

"20. (1) When a pension paid by the Commissioners is based upon the making by the employee throughout the period of his contribution of contributions corresponding at all times to the rates prescribed for the age of the employee there shall be debited to the Melbourne Harbor Trust Fund Account established under *Melbourne Harbor Trust Act 1928* (No. 3733) and credited to the Superannuation Account by the Commissioners in respect of each unit of pension paid a sum equal to the amount of such unit less £13.

(2) When a pension paid by the Commissioners is based upon the making by the employee at any time during the period of his contribution of a contribution or contributions at a rate other than that prescribed for the age of the employee a sum ascertained in the manner provided in the next sub-clause of this clause shall be debited to the said Harbor Trust Fund and credited to the Superannuation Account by the Commissioners.

(3) To determine the sum to be debited and credited as by the last preceding sub-clause provided the total of the amount of the contributions made by the employee from time to time shall be subtracted from the amount of $3\frac{1}{2}$ times the total of the amount of the contributions which would have been payable by the employee had he at all times during the period of his contribution made contribution at the rates prescribed for his age and the ratio of this difference to the amount of $3\frac{1}{2}$ times the total of the amount of the contributions which would have been payable by the employee had he at all times during the period of his contribution made contribution at the rates prescribed for his age shall represent the fraction of the pension payment to be so debited and credited. Provided always that where the employee has made contributions pursuant to Regulation 14 for four units of pension and no more then in the above calculation there shall for the figure $3\frac{1}{2}$ whenever appearing be substituted the figure 4.

(4) As from the 23rd day of December, 1955, every reference to a rate in Regulation 20 shall in the case of—

- (a) any person who on that day is in receipt of or entitled to receive a pension for which he has contributed; or
- (b) any employee whose contributions have on or before that day ceased in accordance with the provisions of sub-clause (2) of Regulation 7

be deemed to be a reference to the rate which would in the circumstances have been applicable if the table of contributions set out in these Regulations had been at all material times the appropriate prescribed table of contributions."

14. Regulation 24 is hereby repealed.

15. Regulation 28 is amended by:—

- (a) Excluding in paragraph (a) the words "one-half" and substituting therefor the words "five-eighths", and
- (b) Excluding in paragraph (b) the words "nineteen pounds ten shillings" and substituting therefor the figure "£26".

16. After Regulation 28 add the following new Regulation 28A:—

"28A. On the death of a male contributor before retirement if—

- (i) the Commissioners are satisfied that such contributor was during any continuous period of absence from duty immediately preceding his death incapable of performing his duties on account of ill-health or physical or mental incapacity not due to his own fault; and
- (ii) such contributor is survived by a widow—

the Commissioners may in their discretion authorize payment to the widow (in addition to any pension payable under Regulation 28) of a sum equal to the amount of pension which would have been payable to the contributor if during such period of absence (or, if such period exceeded three months, then during the last three months of such period) he had been in receipt of a pension under the provisions of Regulation 28 and contributions shall not be required to be made to the Fund for the period in respect of which such amount is calculated."

17. Regulation 29 is amended in manner following:—

- (i) In paragraph (a) exclude the words "one half" and substitute therefor the words "five-eighths".
- (ii) In paragraph (b) exclude the words "nineteen pounds ten shillings" and substitute therefor the figure "£26".

18. After Regulation 29 add new Regulation 29A:—

"29A. Notwithstanding anything in these Regulations where at the time of the death of a pensioner or other beneficiary to or in respect of whom any money (not exceeding the sum of £200) was payable by way of pension or refund of contributions, the Commissioners may pay such money to such person as in the circumstances the Commissioners think fit."

19. Regulation 30 is amended by excluding therefrom the words "nineteen pounds ten shillings" and substituting therefor the word "£52".

20. Regulation 39A is repealed and the following new Regulation 39A substituted therefor:—

" 39A. (1) Notwithstanding anything in these Regulations, the pension payable to or in respect of any pensioner, widow or child to whom pension was payable immediately before the commencement of these Regulations shall as on and from the 23rd day of December, 1955, be at the respective rates by this Regulation hereinafter provided.

(2) In this Regulation 'present rate of pension' means the rate of pension including any additional amount payable under these Regulations that was payable (apart from the operation of this Regulation) to or in respect of the pensioner, widow or child concerned immediately before the 23rd day of December, 1955.

(3) The rate of pension payable to such a pensioner shall be—

- (a) if his present rate of pension is not more than £182 per annum—such present rate increased by one-seventh thereof;
- (b) if his present rate of pension is more than £182 per annum but not more than £364 per annum—such present rate increased by £26;
- (c) if his present rate of pension is more than £364 per annum—such present rate (excluding any additional amount payable under these Regulations) increased by one-sixth thereof but to not less than £390.

(4) The rate of pension payable to such a widow shall be her present rate of pension increased by one-quarter thereof.

(5) The rate of pension payable in respect of such a child shall be £26 per annum.

If both parents are deceased then the rate in accordance with Regulation 30 shall be £52 per annum.

(6) The amount of the increases referred to in this section shall be borne wholly by the Commissioners.

(7) The provisions of this Regulation shall apply in respect of the first fortnightly payment of pension made after the 23rd day of December, 1955, and in respect of all subsequent payments."

21. Regulation 39B is hereby repealed.

22. In the First Schedule:—

(i) The heading "First £78 Pension to Contributor; £39 to Widow, £19 10s. to each child to age 16" on the second column appearing shall be deleted and the following heading substituted therefor:—

"Contributions for first two units."

(ii) The heading "Subsequent Increments—£78 Pension to Contributor; £39 to Widow" on the third column appearing shall be deleted and the following heading substituted therefor:—

"Contributions for each subsequent two units."

23. In the Second Schedule the heading "Contribution for £78 Pension" on the second column appearing shall be deleted and the words "Contributions for two units" substituted therefor.

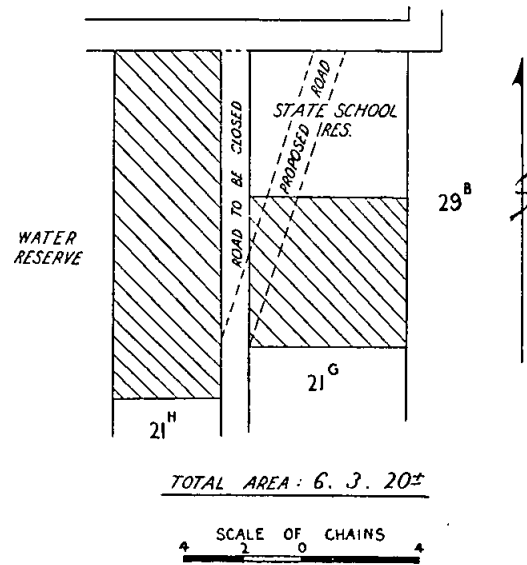

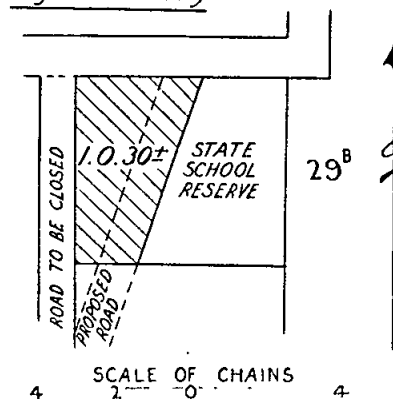

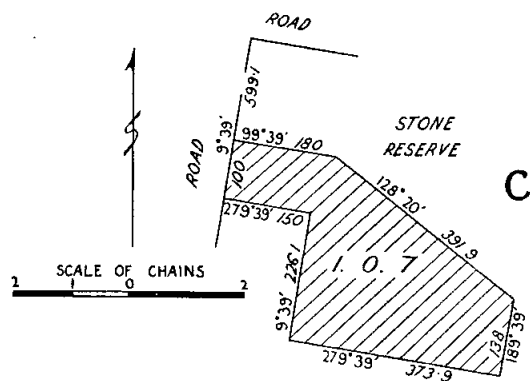

1. In this By-law "Council" shall mean the "Council of the City of Malvern."

2. The owner of any property or premises or where some person other than the owner is in occupation of any property or premises the occupier thereof shall destroy any rats, ants, or other vermin or pests which are at any time in or upon such property or premises.

3. In the event of the failure of any owner or occupier (as the case may be) of any property or premises to comply with the requirements of clause 2 hereof, the Council may cause measures to be taken to destroy the vermin or pests on the property or premises of any owner or occupier at the expense of the owner or occupier and may recover the cost thereof from such owner or occupier as a civil debt recoverable summarily.

4. Any person who is guilty of any wilful act or default contrary to any of the provisions of this By-law shall be liable on conviction to a penalty not exceeding Twenty pounds for each and every offence and in the case of a continuing offence to a further penalty of not more than Five pounds for each day on which an offence against this By-law has continued after conviction or order by any court.

5. This By-law shall apply to and have operation throughout the whole of the municipal district of the City of Malvern.
