Labour and Industry Acts.

DETERMINATION OF A WAGES BOARD ADJUSTED PURSUANT TO SECTION 33 OF THE LABOUR AND INDUSTRY ACT 1953.

I, Henry Norman Jones, Secretary for Labour and Industry, in pursuance of the powers conferred by the Labour and Industry Acts, hereby make and issue the following adjusted Determination of the Wages Board referred to hereunder showing adjusted rates and prices to operate from the beginning of the first pay period to commence in February, 1956.

One male apprentice to every three or fraction of three male workers receiving not less than 294s. 6d. per week

One male improver to every four or fraction of four male workers receiving not less than 294s. 6d. per week.

Other Males.

One male junior to every two male adult workers receiving not less than the adult minimum rate.

PROPORTION. One female junior to every two female adults receiving not less than the adult minimum rate.
