SUMMER PERIOD IN RESPECT OF SPECIFIED PARTS OF THE COUNTRY AREA OF VICTORIA.

#### PROCLAMATION

By His Excellency the Lieutenant-Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

WHEREAS by sub-section (2) of section 4 of the Country Fire Authority Act 1944 it is enacted that the Governor in Council, after consultation by the Chief Secretary of Victoria with the Minister of Forests, may from time to time by proclamation published in the Government Gazette proclaim any period as the summer period in respect of the country area of Victoria or any specified part or parts thereof and, without affecting the generality of the foregoing, may proclaim different summer periods in respect of different parts of the said country area:

And whereas the Chief Secretary and the Minister of Forests have consulted accordingly:

Now therefore I, the Lieutenant-Governor of the State of Victoria in the Commonwealth of Australia, by and with the advice of the Executive Council of the said State with the advice of the Executive Council of the said State and in pursuance of the powers conferred by the Country Fire Authority Acts, do by this my Proclamation proclaim the period commencing at midnight on the fourteenth day of January, 1959, and ending at midnight on the fifteenth day of April next following to be the summer period in respect of the parts hereinafter specified of the country area of Victoria, that is to say:—

These portions of the SIXTH Fire Country Region

Those portions of the SIXTH Fire Control Region comprised by the municipal districts of the Shire of Otway and those portions of the Shire of Heytesbury which lie outside the Parishes of Pomborneit and Purrumbete South and excluding those portions of the aforesaid Sixth Fire Control Region comprised by all that land set apart for Soldier settlement under sections 22 and 24 of the Soldier Settlement Act 1945 (No. 5107) situated in the Parishes of Cooriejong, Wiridjil and Waarre, County of Heytesbury and in such portions of the Parish of Coradjil, County of Heytesbury as lie within two miles from the boundary between the aforementioned Parish and the Parish of Cooriejong.
