BOOKMAKERS, BOOKMAKERS' CLERKS, AND BOOKMAKERS' COURSE AGENTS REGISTRATION REGULATIONS 1962.

At Government House, Melbourne, the sixth day of March, 1962.

PRESENT :

His Excellency the Governor of Victoria.

Mr. Porter

Mr. Thompson

UNDER and by virtue of the powers and authorities conferred by the *Racing Act 1958* and all other powers thereunto enabling, His Excellency the Governor of the State of Victoria, by and with the advice of the Executive Council thereof, doth hereby make the following Regulations (that is to say) :—

1. These regulations may be cited as the "Bookmakers, Bookmakers' Clerks, and Bookmakers' Course Agents Registration Regulations 1962".

2. The Bookmakers and Bookmakers' Clerks Registration Regulations made the ninth day of March, 1954 under Part 1. of the *Bookmakers Act 1953* and amended from time to time are hereby revoked.

3. The Bookmakers and Bookmakers' Clerks Registration Committee (hereinafter in these regulations called "the Committee") shall meet at such times and places as the Chairman may fix, and for each such meeting fees and expenses as follows shall be paid :—

- (a) To the Chairman—a fee of £200 per annum ; and
- (b) To each member of the Committee, other than the Chairman—a fee of £150 per annum ; and
- (c) To the Chairman and each other member of the Committee reimbursement of his reasonable and necessary travelling expenses.

APPLICATIONS FOR ORIGINAL REGISTRATION AND FOR REPLACEMENT CERTIFICATES.

4. Applications for registration of bookmakers, temporary bookmakers, bookmakers' clerks, bookmakers' course agents and for replacement certificates in respect of any lost or destroyed certificate previously issued in respect of any such registration shall be in accordance with Forms "A" to "E" in the Schedule hereto.

APPLICATIONS FOR RENEWAL OF REGISTRATION.

5. Applications by bookmakers, bookmakers' clerks, and bookmakers' course agents for renewal of their certificates of registration shall be in accordance with Forms "F", "G", and "H" in the Schedule hereto.

CERTIFICATES OF REGISTRATION.

6. Bookmakers' certificates of registration, bookmakers' temporary certificates of registration, replacement bookmakers' certificates of registration, bookmakers' clerks certificates of registration and replacement bookmakers' clerks certificates of registration, and bookmakers' course agents certificates of registration and replacement bookmakers' course agents certificates of registration shall be in accordance with Forms "I" to "O" in the Schedule hereto.

FINANCIAL STATEMENTS.

7. (1) Every person applying for a certificate of registration as a bookmaker on Form "A" in the Schedule hereto shall submit with his application a financial statement.

(2) Every bookmaker shall submit a financial statement at such time or times as the Committee may require.

(3) Every such financial statement shall be in accordance with Form "P" in the Schedule hereto.

ISSUE OF CERTIFICATES.

8. Every certificate (including any replacement or temporary certificate) granted by the Committee upon which duty is payable under the *Stamps Act* 1958 shall be forwarded by the Committee to the Comptroller of Stamps who shall deliver or forward the same to the applicant when the appropriate stamp duty has been paid.

AUTHORIZED WITNESSES.

9. The persons authorized to witness the signature of a bookmaker or bookmaker's clerk on any certificate of registration shall be any Justice of the Peace, Commissioner for taking declarations and affidavits under the *Evidence Act* 1958, bank manager, postmaster or member of the Police Force to whom such bookmaker or clerk is personally known.

ADDRESSES OF BOOKMAKERS AND BOOKMAKERS' CLERKS.

10. (1) Every registered bookmaker or bookmaker's clerk shall within three (3) days after changing his place of business (if any) or abode, as recorded on his Certificate of Registration, notify the Committee of full particulars of such change and submit such Certificate for alteration accordingly.

(2) If any default is made in complying with the provisions of this Regulation, the Committee may call upon the defaulter to show cause why his Certificate of Registration should not be withdrawn.

NOTIFICATION OF CHANGE OF STAFF.

11. Every registered bookmaker shall within seven days of making any change in the personnel of his staff notify the Committee in writing of full particulars of such change.

ENDORSEMENTS.

12. The Committee may endorse a bookmaker's clerk's certificate with the name or names of the bookmaker or bookmakers by whom he shall be employed.
