# PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

WHEREAS by an Act of Parliament of the State of Victoria passed in the tenth year of the reign of Her Majesty Queen Elizabeth II., intituled the Motor Car (Amendment) Act 1961 (No. 6762), it is amongst other things enacted that the several provisions of the said Act shall come into operation on a day or the respective days to be fixed by Proclamation or successive Proclamations of the Governor in Council published in the Government Gazette:

And whereas by a Proclamation issued on the thirtieth day of May, One thousand nine hundred and sixty-one, and published in the Government Gazette of the thirty-first day of May, One thousand nine hundred and sixty-one, Monday, the fifth day of June, One thousand nine hundred and sixty-one, was fixed as the day on which sections 1 to 3 inclusive; 5 to 8 inclusive and 10 to 13 inclusive of the said Act shall come into operation:

And whereas by a further Proclamation issued on the fifth day of September, One thousand nine hundred and sixty-one, and published in the Government Gazette of the sixth day of September, One thousand nine hundred and sixty-one, Wednesday, the first day of November, One thousand nine hundred and sixty-one, was fixed as the day upon which section 9 of the said Act shall come into operation:

Now therefore, I, the Governor of the State of Victoria, in the Commonwealth of Australia, by and with the advice of the Executive Council of the said State, do by this my Proclamation fix Monday, the seventh day of May, One thousand nine hundred and sixty-two, as the day on which section 4 of the Motor Car (Amendment) Act 1961, shall come into operation.

Given under my Hand and the Seal of the State of Victoria aforesaid, at Melbourne, this second day of May, in the year of our Lord One thousand nine hundred and sixty-two, and in the eleventh year of the reign of Her Majesty Queen Elizabeth II.
