PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c. WHEREAS by the Land Act 1958 it is amongst other things enacted that the Governor in Council may, by Proclamation to be published in the Government Gazette, at any time diminish or increase the area of land comprised in any of the classes mentioned in Part I., Division I, section 5, of the said Land Act 1958, but that the area of lands which may be sold by auction (Class 6), shall not be increased except as in certain cases in the said Act provided: Now therefore I, the Governor of the State of Victoria, in the Commonwealth of Australia, by and with the advice of the Executive Council of the said State, and in accordance with the provisions of sections 94 and 117 of the Land Act 1958 aforesaid, do hereby diminish or increase (as the case may be) the areas of Crown lands comprised in Classes 2 and 6 of the classes mentioned in section 5 of the Land Act 1958 aforesaid, to the extent set forth in the subjoined Schedule (that is to say):—

PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

WHEREAS by sub-section (2a) of section sixteen of the Cancer Act 1958 it is enacted that the Governor in Council on the recommendation of the Anti-Cancer Council of Victoria, may by Proclamation published in the Government Gazette alter the provisions of paragraphs (b), (c) and (f) of sub-section (2) of the said section or any of them by altering the number of members to be appointed to the medical and scientific committee or by removing from such paragraphs or inserting therein the name of any University of Faculty thereof or any institution or association (as the case may be) and that the said paragraphs (b), (c) and (f) respectively of the said sub-section:

And whereas the Anti-Cancer Council of Victoria has recommended that the provisions of the said paragraphs (b), (c) and (f) be altered as hereinafter appears:

Now therefore, I, the Governor of the State of Victoria, by and with the advice of the Executive Council of the said State and acting upon the recommendation of the Anti-Cancer Council of Victoria, do by this my Proclamation alter paragraphs (b), (c) and (f) of sub-section (2) of section sixteen of the Cancer Act 1958 as follows:—

- "(a) At the end of paragraph (b) there shall be inserted the words and four members appointed by the Council of Monash University two being nominated by the Faculty of Medicine and two by the Faculty of Science of that University';
- (b) In paragraph (c)-

- (i) for the words 'five members' there shall
 be substituted the words 'seven members';
- (ii) after the name 'St. Vincent's Hospital',
 there shall be inserted the name
 'Prince Henry's Hospital'; and
- (iii) for the words 'and the Royal Women's 'Hospital respectively' there shall be substituted the words 'the Royal Women's Hospital and the Queen Victoria Memorial Hospital respectively';

- (c) In paragraph (f)-
 - (i) for the words 'five members' there shall be substituted the words 'six members';
 - (ii) for the name 'Australasian Association of Physicians' there shall be substituted the name 'Royal Australasian College of Physicians';
 - (iii) for the name 'British Medical Associa-tion' there shall be substituted the name 'Australian Medical Associa-
 - or the name 'Australian and New Zealand Association of Radiology' there shall be substituted the name 'College of Radiologists of Australasia'; and (iv) for the
 - (v) for the words 'and one by the Melbourne Cancer Causation Research Committee' there shall be substituted the words 'one by the College of Pathologists of Australia and one by the Australian Regional Council of the Royal College of Obstetricians and Gynaecologists'."

By-law Relating to the Management and Use of Public Baths.

- A By-law of the City of Prahran made under the pro-visions of the Local Government Act 1958, and numbered 241 for regulating the conduct of persons using and the management of public baths within the municipal district of the City of Prahran and prescribing charges for such use.
- IN pursuance of the powers conferred by the Local Government Act and of any and every other power it thereunto enabling the Mayor, Councillors and Citizens of the City of Prahran (hereinafter called "the Council") order as follows:--

Definitions.

- 1. In this By-law unless inconsistent with the subjectmatter:-

 - "Adult" means any person who is fifteen years of age or older than fifteen years of age.

 "Bath premises" means any premises maintained by the Council as public baths or a public swimming pool including all buildings and structures on such premises and all appurtenances and equip-ment therein.

 - such premises and all appurtenances and equipment therein.

 Bath attendant" means an employee of the Council performing any duties on or in connexion with any bath premises.

 Bottle" means any article made wholly or partly of glass, china, porcelain and bakelite of like composition.

 Town Clerk" means the person for the time being holding the office or performing the duties of the Town Clerk of the Council.

 Junior" means any person who is under the age of fifteen years.

of fifteen years.

Words importing the masculine gender also include the feminine and vice versa.

Prohibition of Intoxicating Liquor.

- 2. No person shall-
 - (1) Bring into any bath premises any intoxicating
 - liquor.
 (2) Consume intoxicating liquor on any bath premises
 - Bad Language or Offensive Behaviour.
- Bad Language or Offensive Behaviour.

 (3) Go into or appear in any bath premises in a drunken or disorderly state or be guilty of swearing or using profane, foul or abusive language, or of obscenity or indecency or conduct himself riotously or create any disturbance or obstruct, hinder or resist in the execution of his duty any bath attendant or any officer or person appointed by the Council to conduct or aid in the good management of any bath premises or neglect or refuse to comply with any lawful request of any bath attendant or any such other officer or person made in accordance with the provisions of this By-law.

 Dogs.

(4) Cause or permit any dog or other animal belonging to that person or under his control to enter or remain in or upon any bath premises.

Bathing Costumes.

(5) Use any swimming pool unless he is properly attired in a bathing costume so as to preserve public

Entry or Use Without Payment.

(6) Enter any bath premises or use any facility therein without having first paid to a bath attendant the proper fee or charge as set out in the Schedule

Bottles.

- (7) Bring into any bath premises any bottle.(8) Break any bottle or bottles within any bath
- premises. (9) Fail to report the breakage of any bottle therein.

Spitting.

(10) Spit in any swimming pool nor on the floor or walls or any part of any bath premises.

Smoking.

(11) Smoke in any portion of the bath premises where a notice is displayed that smoking is not permitted.

Prohibition of Persons Suffering from Certain Diseases.

3. No person suffering from any cutaneous infectious or contagious disease shall use any dressing room or bath or enter any swimming pool.

Cleansing Before Entry.

- 4. No person shall-
- (1) Enter any swimming pool until he has thoroughly clearsed himself to the satisfaction of a bath attendant under a shower bath on the bath premises in which the use of soap is permitted.
- (2) Enter or remain in any swimming pool whilst he is in an unclean condition.

Soap in Swimming Bath.

(3) Use soap in any part of any bath premises other than in the shower baths in which the use of soap is permitted.

Use of Discolouring Substances.

- (4) Use any substance or preparation whilst he is in a swimming pool whereby the water in that swimming pool may be discoloured or rendered turbid or rendered unfit in any way for the use of
 - Pollution of Water.
- (5) Wilfully foul or pollute the water in any shower bath, separate bath or swimming pool.

Soiling of Towels.

(6) Wilfully soil or defile any towel or any bathing dress, trunks or drawers the property of the Council.

Pollution of Premises.

(7) Wilfully foul, pollute or defile any bath premises or any part thereof.

Injury, &c. to Premises or Council Property.

(8) Wilfully or negligently break, injure, damage, destroy or tamper with any bath premises, or any key or any towel or bathing costume, trunks or drawers the property of the Council.

Defacing Premises.

(9) Wilfully or negligently mark or deface any bath premises or any article of furniture or equipment therein or attached thereto.

Bringing Chemicals, &c. on to Bath Premises.

(10) Bring on to any bath premises or place in any bath premises or in any part thereof any chemical substance, liquid or powder.

Deposit of Articles for Safe-Keeping.

- 5. (1) A person may deposit with a bath attendant any article for safe-keeping, subject to the terms and conditions contained in this clause.
- (2) Any person making any deposit shall be deemed to agree that the following conditions shall be applicable thereto:-
 - (a) If any article deposited be damaged, destroyed, lost, mislaid or stolen, neither the Council nor any officer, employee or agent of the Council shall be in any way responsible for any such damage, destruction, loss or theft, howsoever occurring.

 (b) Unon production to a bath attendant of a receipt
 - occurring.

 (b) Upon production to a bath attendant of a receipt or token given in respect of any article deposited the bath attendant may hand the article to the person producing the receipt or token without proof that such person was the person to whom such receipt or token was originally issued

- (c) If any article deposited is not reclaimed within 60 days from the date of the deposit, the Council or some person duly authorized in that behalf by the Council, may sell or otherwise dispose of the same and shall be under no liability either to the owner or depositor thereof by reason of such sale or disposal.
- (3) The bath attendant with whom any article is deposited for safe-keeping shall deliver to the person depositing such article a receipt or token in respect thereof.

Articles Lost or Found.

- 6. (1) At every bath premises there shall be kept by the baths manager or by some bath attendant duly authorized by the Town Clerk a book (hereinafter referred to as "the lost property register").
- (2) Any person who finds any article which has been left in any bath premises shall forthwith deliver it to a bath attendant.
- (3) Upon receipt by a bath attendant of any article which has been left in any bath premises such bath attendant shall forthwith take charge of the article and enter or cause to be entered in the lost property register a description of the article, the time and date of its receipt and the name of the finder.
- (4) The bath attendant having the custody of the lost property register may deliver to a person apparently the owner thereof any article, particulars of which have been entered in the lost property register upon receiving proof to his satisfaction of ownership and on payment of the prescribed fee (if any) and upon such delivery such person shall by way of acknowledging receipt of the said article, enter in the lost property register his name and address

Disposal of Lost Property.

7. It shall be a condition of any person being admitted to enter any bath premises (whether on payment to the Council of a fee or otherwise howsoever) that if such council of a fee of otherwise nowsoever) that if such person leaves upon such bath premises any article which is taken charge of by a bath attendant, the Council or some person duly authorized in that behalf by the Council may, if such article be not claimed within 60 days of the date on which its receipt is recorded in the lost property register, sell or otherwise dispose of the same and shall be under no liability either to the owner or and shall be under no liability either to the owner or leaver thereof by reason of such sale or disposal.

Non Responsibility.

8. Neither the Council nor any officer or employee of the Council shall be in any way liable or responsible for any article lost by or stolen from any person whilst in bath premises or for any article damaged or destroyed whilst in or on any bath premises.

Prohibition of Payment Except for Tickets, &c.

9. A person shall not pay, nor shall any bath attendant or other officer or servant of the Council accept any fee for admission to or for the use of any facility in any bath premises, except in being permitted to pass through a turnstile which automatically registers such admission or except in exchange for a printed ticket bearing the name of the Council in exchange for a ticket issued from a cash register of the Council.

Use of Prescribed Entrances and Exits.

10. (1) No person shall enter any bath premises except through a prescribed entrance or leave any bath premises except by a prescribed exit.

Prohibited Areas.

- (2) No person shall enter or remain in any portion of any bath premises not set aside for public use.
- (3) No male person shall enter or use any part of any bath premises for the time being set apart or appropriated for the use of females, nor shall any female person enter or use any part of bath premises for the time being set apart or appropriated for the use of males.

Deposit on Towels, &c.

11. (1) Every person who hires any towel, bathing costume or other article the property of the Council, shall pay a deposit in respect of each such article according to the scale which may from time to time be determined by the Council, and shall return any article so hired by him to a bath attendant before leaving the bath promises

(2) If any article so hired is returned in good order and condition the deposit paid in respect thereof shall be refunded to the person returning that article, but if any article is not returned or is returned in a damaged condition, then without prejudice to any other remedies of the Council, a bath attendant may forfeit the whole or (in his own discretion) any part of the deposit to the Council. Council,

. Temporary Closing.

12. The baths manager or a bath attendant authorized by the Town Clerk may temporarily suspend admittance to and clear any bath premises or any part thereof of any person or persons if in his opinion such action is considered necessary.

Transfer of Tickets, &c.

13. No ticket, token, licence or receipt issued as provided by this By-law shall be transferable and no person other than the person to whom same was originally issued shall be entitled to or enjoy any benefit therefrom or any privileges thereunder.

Professional Coaches.

- 14. The Council may in its discretion permit from time to time for such times for such fees and under such conditions as it may formally resolve, the use of bath premises to professional coaches. Every person desiring to be registered as a professional coach in respect of any bath premises shall first sign and lodge an application, in writing, addressed to the Town Clerk stating his full name and his private and business addresses and the bath premises in respect of which he desires to be registered, and further such other particulars as the Town Clerk may require.
- The Council may by formal Resolution refuse to register any or all professional coaches in respect to any bath premises.

Nothing in this clause shall prevent the teacher from any school (whether State school or otherwise) from giving instruction to pupils admitted to bath premises under school classes rates of admission.

Season Tickets.

15. A season ticket which has been issued to any person shall only entitle such person to be admitted to the bath premises from which such season ticket was

Supension of Charges During Galas.

- 16. During any period for which any bath premises or any part of a bath premises may be made available by the Council for contests or galas or other entertainments-
 - (1) The charges for admission thereto shall be suspended.
 - (2) No season or other tickets, licences, or tokens issued by or on behalf of the Council shall have any force or effect or be available for entrance to or use at any such contests galas or other entertainment.
 - (3) Neither the Council nor any of its officers or employees shall be in any way liable or responsible
 - (a) the due conduct of such contests galas or other entertainments.
 - (b) any article deposited with any person in charge of or in any way connected with any such contest gala or other entertainment or present thereat nor
 - (c) any injury to or any loss or damage sustained by any person during the time any such contest gala or entertainment is being held.

Power to Eject Offenders.

17. If any person offends against any of the provisions of this By-law that person may (without prejudice to his liability to a penalty in respect of that offence) be required by a bath attendant to leave the bath premises and if he fails forthwith to do so any bath attendant may, using no more force than is reasonably necessary, eject that person from the bath premises.

Penalties.

18. Any person committing a breach of or an offence against any of the provisions of this By-law shall upon conviction for every such breach or offence, be liable to a penalty not exceeding Ten pounds.

Hours of Admission.

19. Bath premises will be open to the public on such days and between such hours as may be determined from time to time by Resolution of the Council.

Operation and Extent of Operation.

20. This By-law shall-

- (1) Apply to and have operation throughout the whole of the Municipal District of Prahran.
- (2) Come into operation and have effect immediately upon its publication in the Government Gazette.
