Water Act 1958. STATE RIVERS AND WATER SUPPLY COMMISSION.

At the Executive Council Chamber, Melbourne, the thirtieth day of June, 1964.

PRESENT:

His Excellency the Governor of Victoria. Mr. Mack. Mr. Thompson

GOULBURN-MURRAY IRRIGATION DISTRICT—DISTRICT EXTENDED.—COHUNA RRIGATION AREA—BOUNDARIES VARIED.

UNDER the powers conferred by the Water Act 1958 and all other powers enabling him in that behalf, His Excellency the Governor of the State of Victoria, with the advice of the Executive Council of the said State, on the recommendation of the State Rivers and Water Supply Commission, doth hereby declare, order, and direct as follows: follows:-

That the Goulburn-Murray Irrigation District be extended and the boundaries of the Cohuna Irrigation Area be varied by adding to the said District and Area the lands set out and described in the Schedule hereto, and as on and from the first day of July, 1964, such District shall be deemed to be so extended and the boundaries of such Area shall be so varied.

SCHEDULE.

All those lands comprising-

1. The whole of allotments 73, 74, 75, 75A and 75B, section D, Parish of Cohuna, County of Gunbower, together with that portion of a Government road between the southern boundary of said allotment 75 and the northern boundary of said allotment 75A. Excepting thereout the whole of the land described in certificate of title, volume 5822, folio 287, being part of said allotment 75A, section D, Parish of Cohuna.

- 2. The whole of allotments 70, 70A, 71A and 71B, section D, Parish of Cohuna, County of Gunbower.
- 3. The whole of allotments 63B, 65, 66 and 66A, section D, Parish of Cohuna, County of Gunbower.
- 4. The whole of allotments 58 and 59, section 8, Parish of Gunbower West, County of Gunbower.
- 5. The whole of allotment 56A, section 8, Parish of Gunbower West, County of Gunbower.
- 6. The whole of allotments 29, 29A, 30, 33, 34, 34A, 35, 36, 36A, 37, 40, 41, 42, 43, 47, 48, 49, 52 and 54, section 8, Parish of Gunbower West, County of Gunbower, together with those portions of Government roads—
 - (a) between the western boundaries of said allotments 42 and 43 and the eastern boundary of said allotment 49;
 - (b) between the eastern boundaries of said allotments 40 and 41 and the western boundaries of said allotments 34, 34a, 35 and 37; and
 - (c) between the north-eastern boundary of said allot-ment 52 and the south-western boundary of said allotment 48. Excepting thereout—
 - (1) the whole of the land described in certificate of title, volume 6376, folio 153, being part of said allotment 41, section 8, Parish of Gunbower West; and
 - (2) the whole of the land described in certificate of title, volume 8388, folio 224, being part of said allotment 54, section 8, Parish of Gunbower West.
- 7. The whole of allotments 7a, 7B, 8, 8a, 9, 10, 11, 12, 13, 20B, 20c, 32 and 33, section 8, Parish of Gunbower, County of Gunbower, together with those portions of Government roads between—
 - (a) the south-western boundaries of said allotments 20B and 20C and the north-eastern boundaries of said allotments 8 and 9, Parish of Gunbower;
 - (b) the western boundary of said allotment 8A and the eastern boundaries of said allotments 20c and 33, Parish of Gunbower; and

- (c) the southern boundary of said allotment 8A and the northern boundary of said allotment 7B, Parish of Gunbower.
- 8. The whole of allotments 5 and 6B, section 8, Parish of Gunbower, County of Gunbower.
- 9. The whole of lot 4 on lodged plan of subdivision No. 40158, Parish of Gunbower, County of Gunbower.
- 10. The whole of the land described in certificate of title, volume 8260, folio 268, being part of allotment 23, section 7, Parish of Gunbower, County of Gunbower.
- 11. The whole of allotments 50B and 50c, section 7, Parish of Gunbower, County of Gunbower.
- 12. The whole of allotments 12a and 12B, Parish of Gunbower, County of Gunbower.
- 13. The whole of allotments 73, 73a, 74 and 77, section E, Parish of Patho, County of Gunbower.
- 14. The whole of allotments 57, 58, 59, 60, 62, 64 and 64A, section E, Parish of Patho, County of Gunbower, together with those portions of Government roads between—
 - (a) the northern boundary of said allotment 62 and the southern boundary of said allotment 64;
 - (b) the eastern boundary of said allotment 58 and the western boundary of said allotment 59; and
 - (c) the western boundaries of said allotments 62 and 64 and the eastern boundaries of allotments 65 and 67, Parish of Patho.
- 15. The whole of allotments 41 and 42, section E, Parish of Patho, County of Gunbower, together with that portion of a Government road between the south-eastern boundary of said allotment 42 and the north-western boundary of said allotment 41, Parish of Patho.
- 16. The whole of allotments 37 and 38, section E, Parish of Patho, County of Gunbower, excepting thereout the whole of the land described in certificate of title, volume 8226, folio 652, being part of said allotment 38.
- 17. The whole of allotments 36 and 36A, section E, Parish of Patho, County of Gunbower.

- 18. The whole of allotment 12, section B, Parish of Patho, County of Gunbower.
- 19. The whole of allotment 12A, section B, Parish of Patho, County of Gunbower.
- 20. The whole of allotments 29 and 31, section E, Parish of Patho, County of Gunbower, together with that portion of a Government road adjoining the eastern boundaries of allotment 30 and said allotment 31.
- 21. The whole of allotment 18, section D, Parish of Patho, County of Gunbower.
- 22. The whole of allotment 30, section D, Parish of Patho, County of Gunbower.
- 23. The whole of allotments 2 and 3, section 6, Parish of Turrumberry North, County of Gunbower, together with that portion of a Government road adjoining the eastern boundary of said allotment 3.
- 24. The whole of allotments A1, A3, A4, A5, A6 and 18, section A, Parish of Patho, County of Gunbower, together with those portions of Government roads between—
 - (a) the eastern boundary of said allotment A1 and the western boundary of said allotment 18; and
 (b) the north-western boundary of said allotment A1
 - (b) the north-western boundary of said allotment Al and the south-eastern boundary of said allotment A6.
- 25. The whole of allotments lir and llg, section 6, Parish of Gunbower West, County of Gunbower.
- The lands set out and described in the foregoing Schedule are shown on a plan approved by the Governor in Council, and deposited in the office of the State Rivers and Water Supply Commission, Melbourne.—(Corres. Nos. 64/2375, 63/5485, 53/4781.)
