AREA OF LAND COMPRISED IN CERTAIN CLASSES DIMINISHED OR INCREASED.

### PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

WHEREAS by the *Land Act 1958* it is amongst other things enacted that the Governor in Council may, by Proclamation to be published in the *Government Gazette*, at any time diminish or increase the area of land comprised in any of the classes mentioned in Part I., Division 1, Section 5, of the said *Land Act 1958* but that the area of lands which may be sold by auction (Class 6), shall not be increased except as in certain cases in the said Act provided: Now therefore I, the Governor of the State of Victoria, in the Commonwealth of Australia, by and with the advice of the Executive Council of the said State, and in accordance with the provisions of sections 94 and 117 of the *Land Act 1958* aforesaid, do hereby diminish or increase (as the case may be) the areas of Crown lands comprised in Classes 2 and 6 of the classes mentioned in section 5 of the *Land Act 1958* aforesaid, to the extent set forth in the subjoined Schedule (that is to say):—

## PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

I, THE Governor of the State of Victoria, in the Commonwealth of Australia, do hereby declare that I have this day assented, in Her Majesty's name, to the Bills passed by the Parliament of the said State, the titles whereof are hereunder set forth, together with the short titles, that is to say:—

- No. 7447. "An Act to amend Sections 8 and 261 of the *Marine Act 1958*." (*Marine (Amendment) Act 1966*.)
- No. 7448. "An Act to amend the *Mildura Irrigation and Water Trusts Act 1958* with respect to the Collection and Enforcement of Rates and for other purposes." (*Mildura Irrigation and Water Trusts (Amendment) Act 1966*.)
- No. 7449. "An Act to provide for the Sale of certain Land acquired by the Crown for the Purposes of the State Accident Insurance Office and no longer required for the Purposes thereof." (*State Accident Insurance Office Land Act 1966*.)
- No. 7450. "An Act to amend the *Public Account Act 1958*." (*Public Account (Bona Vacantia) Act 1966*.)
- No. 7451. "An Act to amend Part V. of the *Motor Car Act 1958* and for other purposes." (*Motor Car (Hospitals and Charities Contributions) Act 1966*.)

"An Act to authorize and approve an Agreement between the Commonwealth of Australia and the States of New South Wales, Victoria, Queensland, South Australia, Western Australia and Tasmania, to amend the Agreement made between the Commonwealth and the aforesaid States on the 12th day of December, 1927 and for other purposes." (*Commonwealth and States Financial Agreement Act 1966*.)
- No. 7453. "An Act to sanction the Issue and Application of Loan Money for Works and other Purposes relating to State Forests." (*State Forests Loan Application Act 1966*.)
- No. 7454. "An Act to amend the *Water Act 1958*." (*Water (Amendment) Act 1966*.)
- No. 7455. "An Act to amend Part V. of the *Hospitals and Charities Act 1958* with respect to the Contributions to be made by or in respect of Patients in Registered Institutions, to amend the *Cancer Act 1958*, the *Motor Car Act 1958*, the *Workers Compensation Act 1958*, to repeal the *Hospital Benefits Act 1958* and for other purposes." (*Hospitals and Charities (Liability of Patients) Act 1966*.)

## GOVERNMENT NOTICES

## THE COMPANIES ACT 1961.

- (c) That the Company make available for inspection at the place where the Register is kept in the State of Victoria a copy of the Register of all holders of interests in the Fund wherever resident within fourteen (14) days after a request in that behalf by any person entitled to inspect the Register by virtue of the provisions of sub-section (2) of section 153 of the said Act.

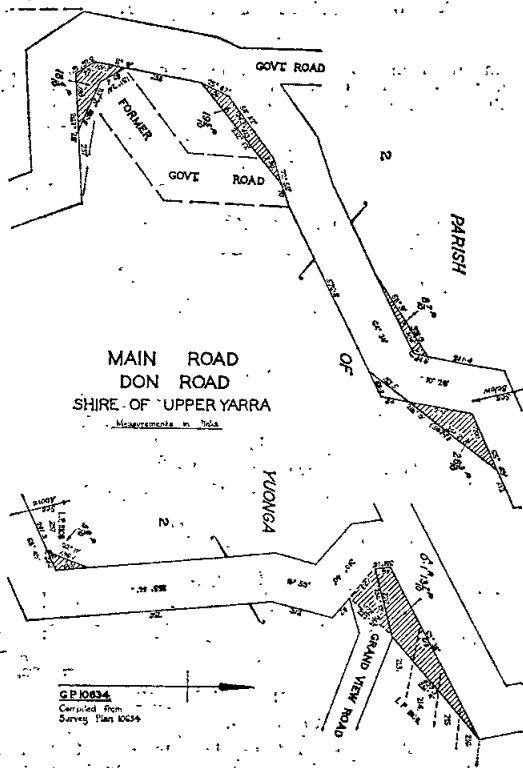

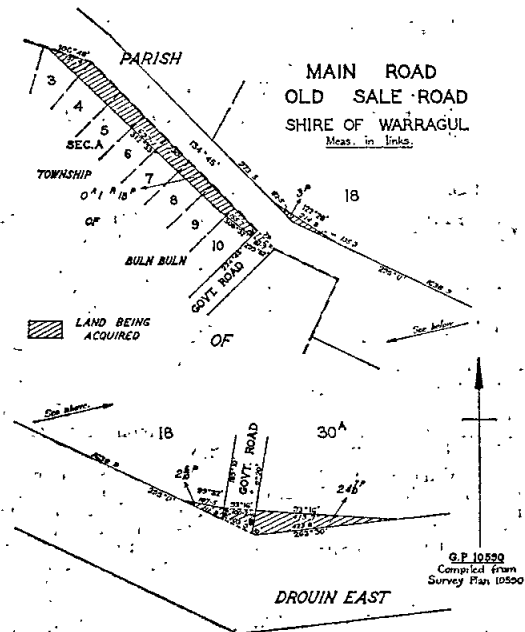

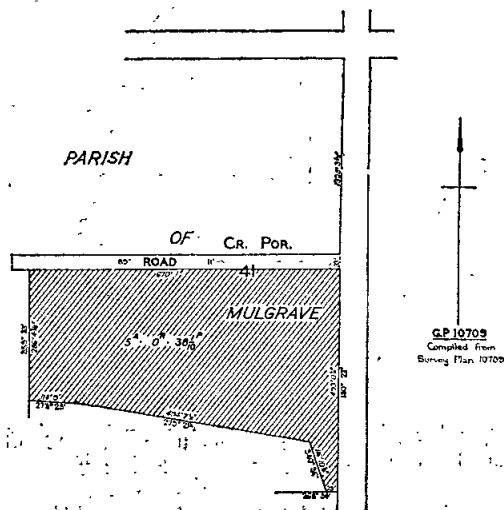

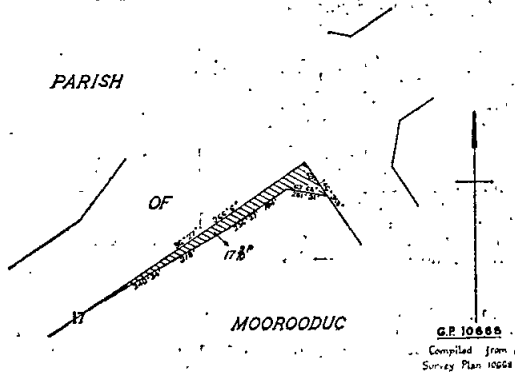

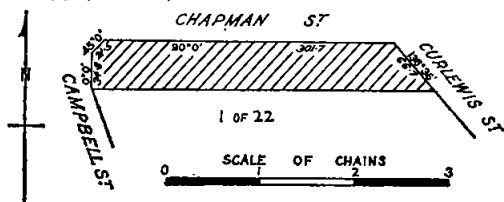

A By-Law of the City of Geelong West made under Section 197 of the Local Government Act 1958, and numbered 81—

(a) regulating the use of streets, roads and public places within the municipal district by street hawkers and itinerant traders;

(b) prohibiting and regulating the sale of goods from stalls, motor cars, carts, trucks, barrows and other receptacles standing or placed on any street, road, public place or vacant land within specified areas;

(c) prohibiting or regulating the erection or use on any land within the areas specified of tents or other temporary structures or buildings for the sale of goods therein or therefrom and the sale of goods in or from such tents, structures or buildings.

IN pursuance of the powers conferred by the Local Government Act 1958 and of every power enabling it in that behalf the Mayor, Councillors and Citizens of the City of Geelong West order as follows—

1. No hawker or itinerant trader dealing in goods shall without the written consent of the Council previously had and obtained, use any street, road or public place within the municipal district of the City of Geelong West between the hours of 6 o'clock in the afternoon and 7 o'clock in the forenoon following or on weekends between the hours of 6 o'clock in the afternoon of Saturday and 7 o'clock in the forenoon of the following Monday.

2. Save as is herein otherwise provided no person shall within the municipal district of the City of Geelong West sell any goods from any stall, motor car, cart, truck, barrow, box, basket, crate, bag or other vehicle or receptacle standing or placed on any street, road or public place or within or upon any vacant land (not being Crown land or land under the care and management of the Municipality).

3. No child (as defined by the Labour and Industry Act 1958) shall be employed as a street hawker or be permitted to occupy or manage a stand in any street, road or public place.

4. Any person may lodge with the Town Clerk an application in the form set out in the First Schedule hereto for a permit to sell goods from any stall, motor car, cart, truck, barrow, box, basket, crate, bag or other vehicle or receptacle standing or placed on any street, road, public place or vacant land as aforesaid. Such application shall be signed by the applicant and by at least five ratepayers of the City of Geelong West. Notwithstanding anything herein contained the Council shall not grant any application hereunder to sell within the areas set out in the Second Schedule unless the Council considers special circumstances exist. The fact that permission to sell is sought to raise funds for charitable, public or community purposes may if the Council so considers constitute special circumstances.

5. The Council may in its discretion grant or refuse to grant the said application or may grant the same for such period and subject to such terms and conditions as the Council shall cause to be endorsed on the permit. Any permit issued pursuant to the provisions of this clause shall be in the form in the Third Schedule hereto together with such additions or alterations as the Council may require and shall be given under the hand of the Town Clerk.

6. Any person who is the holder of a current permit hereunder shall when engaged in the business of selling goods as a hawker or itinerant trader within the City of Geelong West shall carry the said permit and produce the same on demand to any Authorized Officer of the Council.

7. If at any time in the opinion of the Council the holder of any permit issued hereunder shall fail to comply with all the terms and conditions thereof or if at any time in the opinion of the Council any obstruction shall be caused or traffic shall be interfered with by the exercise of any rights granted by such permit or any assemblage of persons caused thereby the Council may revoke or vary such permit and the same shall thereupon become void and of no effect or varied accordingly.

8. The holder of any current permit issued hereunder shall be entitled to sell goods for the term at the place and subject to the conditions set out in the said permit and to the provisions of this By-Law.

9. No person shall without the approval of the Council first had and obtained erect or use on any land within the municipal district any tent or other temporary structure or building for the sale of goods therefrom or sell any goods in or from such tent, structure or building.

10. Any person guilty of any wilful act or default contrary to this By-Law shall be liable to a penalty of not more than forty dollars and any person guilty of a continuing offence against this By-Law shall be liable to a penalty of not more than ten dollars for each day on which an offence against this By-Law is continued after a conviction or order by any Court.

11. Save as is herein otherwise provided this By-Law shall apply to and have operation throughout the whole of the municipal district.

(b) The fee to be paid to the Council on any transfer of registration shall be \$0.25.

(c) Where application for renewal of registration is not lodged with the Council until after the 15th day of November in each year being the last day fixed for the lodging thereof an additional fee of one half of the renewal fee applicable shall be payable.

2. This By-law shall apply to and have operation throughout the whole of the Municipal district of the City of Moorabbin.

"Instrument" means any instrument device or thing whatsoever capable of making or being used for making sound or noise and without affecting the generality of the foregoing includes any loud-speaker, amplifier, broadcasting set, wireless receiving set, television set, gramophone, piano or player piano.

"Municipal District" means the municipal district of the City of Northcote.

"Premises" includes vacant land.

2. No person shall in any public highway cause or permit or suffer to be caused any noise:

(a) By shouting calling out haranguing or singing, or

(b) By using operating controlling sounding or playing any instrument.

3. No person shall in or upon any land house building or place make or cause or permit or suffer to be made or caused such a volume or amount of sound or noise as to be an annoyance or nuisance to any other person being in or upon any other land house building or place or in or upon any public highway—

(a) By shouting calling out haranguing or singing, or

(b) By using operating controlling sounding or playing any instrument.

4. No person shall in or upon any premises use or operate any instrument or any machinery or plant in such manner as to cause any objectionable noise at any unreasonable time.

5. This Bylaw shall apply to and have operation throughout the whole of the municipal district of the City of Northcote.

6. Any person guilty of a wilful act or default contrary to the provisions of this Bylaw shall be liable to a penalty of not less than \$10.00 nor more than \$40.00 and to a further penalty of not more than \$10.00 each for each day on which such offence is continued after a conviction or order of any Court.
