REFUSAL OF APPLICATION FOR SEVERANCE OF PORTION OF THE CITY OF SALE AND ANNEXATION THEREOF TO THE SHIRE OF AVON.

HIS Excellency the Governor of the State of Victoria by and with the advice of the Executive Council thereof and in pursuance of the powers conferred by Section 23 of the Local Government Act 1958, as amended, hereby refuses to grant an Application by the Council of the Shire of Avon for severance of portion of the municipal district of the City of Sale and the annexation thereof to the Shire of Avon.

And the Honorable Rupert James Hamer, Her Majesty's Minister for Local Government for the State of Victoria, shall give the necessary directions herein accordingly.

SEVERANCE OF PORTIONS OF THE SHIRE OF AVON AND ANNEXATION OF SUCH PORTION TO THE CITY OF SALE.

PURSUANT to the provisions of Sections 23 and 38 of the Local Government Act 1958, as amended, His Excellency the Governor of the State of Victoria, by and with the advice of the Executive Council thereof, and in compliance with an application of the Council of the City of Sale, hereby orders:—

1. That on and from the 31st May, 1967 the portions of the municipal district of the Shire of Avon described hereunder shall be severed from the South Riding of the said shire and annexed to the North and East Wards of the City of Sale;

- that the residue of the South Riding of the Shire of Avon shall thenceforth be deemed to be that sub-division;
- 3. that the boundaries of the municipal districts of the said municipalities and of the affected sub-divisions thereof shall be re-defined accordingly as described hereunder; and
- that this Order shall not affect the retirement in accordance with the provisions of Division 2 of Part III of the said Act of Councillors of the said municipalities.

PORTIONS TO BE SEVERED FROM THE SHIRE OF AVON AND ANNEXED TO THE CITY OF SALE.

- ANNEXED TO THE CITY OF SALE.

  (a) Commencing at the south-eastern angle of allotment 89, section 1, Parish of Sale; thence westerly by Dawson Street to a point distant 1,005 links easterly from the eastern alignment of the Princes Highway; thence northerly by a road for a distance of 902 links; thence westerly by a line bearing 269 deg. 57 min. to the Princes Highway; thence southerly by that highway to Dawson Street; thence westerly by that street to the Flooding Creek; thence generally north-westerly by that creek to the south-western corner of allotment 199; thence northerly by a road to the north-western angle of that allotment; thence easterly by a road to the western boundary of allotment 97; thence northerly by that boundary to the Maffra-Sale Road and south-easterly by that road to the north-western angle of allotment 117 and further easterly by a road to the road forming the eastern boundary of allotment 124; and thence southerly by that road to the point of commencement.
