*Country Fire Authority Act 1958.*

FIRE DANGER PERIOD IN RESPECT OF SPECIFIED  
PARTS OF THE COUNTRY AREA OF VICTORIA.

WHEREAS by section 4 of the *Country Fire Authority Act 1958*, it is enacted that the Chief Secretary of Victoria, after consultation with the Minister of Forests, may from time to time by declaration published in the *Government Gazette* declare any period to be the fire danger period in respect of the country area of Victoria, or any specified part or parts thereof and, without affecting the generality of the foregoing, may declare different periods to be the fire danger period in respect of different parts of the said country area:

And whereas the Chief Secretary and the Minister of Forests have consulted accordingly:

Now therefore I, the Chief Secretary of Victoria, do hereby declare the period commencing at midnight on the 12th December, 1969, and ending at midnight on the 30th April, 1970, to be the fire danger period in respect of the municipal district of the Shire of Stawell in the Sixteenth Fire Control Region.

FIRE DANGER PERIOD IN RESPECT OF SPECIFIED  
PARTS OF THE COUNTRY AREA OF VICTORIA.

Now therefore I, the Chief Secretary of Victoria, do hereby declare the period commencing at midnight on the 15th December, 1969, and ending at midnight on the 30th April, 1970, to be the fire danger period in respect of the parts of the country area of Victoria situated within the municipal districts or parts of municipal districts, and being portion of the Seventeenth Fire Control Region specified in the Schedule hereunder—

Shire of Arapiles (that part which lies south of the Rifle Butts road and the Clear Lake-Tooan-Duffholme road).

Shire of Kowree.

Shire of Wimmera (that part which lies south of the Rocklands-Lubeck water channel).
