DATE OF COMING INTO OPERATION.

PROCLAMATION

By His Excellency the Governor of the State of Victoria
and its Dependencies in the Commonwealth of Australia,
&c., &c., &c.

WHEREAS by an Act of Parliament of the State of
Victoria passed in the fifteenth year of the reign of
Her Majesty Queen Elizabeth II entitled the *Marketing of
Primary Products (Tobacco Leaf Marketing Board) Act*
1966, it is amongst other things enacted that the said
Act shall come into operation on a day to be fixed by
proclamation of the Governor in Council published in the
Government Gazette:

NOW THEREFORE I, the Governor of the State of Vic-
toria, in the Commonwealth of Australia, by and with the
advice of the Executive Council of the said State, do by
this my Proclamation FIX Saturday, the nineteenth day
of April, One thousand nine hundred and sixty-nine as the
day on which the said *Marketing of Primary Products
(Tobacco Leaf Marketing Board) Act* 1966 shall come into
operation.

Given under my Hand and the Seal of the State of
Victoria aforesaid, at Melbourne, this eighteenth
day of April, in the year of our Lord One
thousand nine hundred and sixty-nine, and in the
eighteenth year of the reign of Her Majesty
Queen Elizabeth II.

APPOINTMENT OF MEMBERS OF THE TOBACCO LEAF MARKETING BOARD.

IN pursuance of the powers conferred by the *Marketing
of Primary Products Act* 1958 and all other powers
him thereunto enabling His Excellency the Governor of
the State of Victoria by and with the advice of the Execu-
tive Council thereof DOETH by this Order hereby:

1. Appoint DAVID SUTCLIFFE WISHART as a member of
The Tobacco Leaf Marketing Board from the 18th April,
1969, to the 21st April, 1969, both dates inclusive; and

2. Appoint—

FRANCIS GEORGE JOHNSON,
WILLIAM JAMES MCGUFFIE,

ANGELO RIGONI,

as members of The Tobacco Leaf Marketing Board from
the 18th April, 1969, to the 21st April, 1969, both dates
inclusive, such persons having been elected by the pro-
ducers of tobacco leaf as elective members of such Board
pursuant to and in accordance with the said Act.

And the Honorable Gilbert Lawrence Chandler, Her
Majesty's Minister of Agriculture for the State of Victoria,
shall give the necessary directions herein accordingly.
